
# **§179D EPACT TAX DEDUCTION**



Originally enacted in the Energy Policy Act of 2005 and recently made permanent as part of the Consolidated Appropriations Act of 2021, **179D provides a tax deduction of up to \$1.80 per square foot** (indexed for inflation beginning in 2021) for new construction, retrofits or expansions of commercial buildings that install lighting, building envelope or HVAC systems that reduce the buildings total energy and power costs by 50% or more in comparison to certain standards.


## Allowed for individually qualifying components





## Actual energy savings are determined using the following standards:

- Placed in service 1/1/2016-12/31/2020 Compared to ASHRAE 90.1-2007
- Placed in service on or after 1/1/2021 Compared to ASHRAE 90.1- (2 years prior to date construction began)

## **Who Benefits?**



#### **Commercial Building Owners:**

- Owners of commercial buildings, warehouses, parking garages, high-rise (greater than 3 stories above grade) apartment buildings
- Property located in the US

#### **Government Owned Building Designers:**

- Special rule allows public entities to allocate benefit to primary designer
- Buildings owned by federal, state or local government
- Property located in the US

### The IRS requires all claims:



- $\checkmark$  Be certified by a qualified, unrelated third party
- ✔ Meet or exceed the energy efficiency requirements of IRC 179D
- ✓ Include the necessary computer modeling, using IRS approved software
- ✓ Include a qualified allocation letter for primary designers of government owned buildings
