> State and local governments face an **unprecedented mental health crisis**. The Bipartisan Safer Communities Act, in addition to addressing gun safety, also **includes major new funding opportunities in excess of \$2 billion** that state and local governments can leverage to **expand access to and the quality of mental health services**. These provisions have the potential to dramatically accelerate state and local efforts to improve behavioral health care.

School-Based Mental Health Care - \$1.2 Billion

The BSCA provides \$1.2 billion in funding to implement new programs and to enhance or expand access to existing mental health services in school-based settings, including:

- \$500 million to increase the number of qualified mental health service providers via the School-Based Mental Health Services Grants
- \$500 million for Mental Health Services Professional Demonstration Grants
- \$50 million in grants to states to implement, enhance or expand the provision of CHIP and Medicaid services in schools

General Mental Health Care - \$940 Million

The BSCA also appropriates \$940 million to support ongoing investment in general mental health services. This includes the provision of an additional \$250 million for the Community Mental Health Services Block Grant program, \$80 million in grants to support pediatric primary care providers, \$60 million for mental health training for primary care clinicians and an additional \$550 million for other critical SAMHSA programs such as the National Child Traumatic Stress Network, Project AWARE, mental health awareness training and the National Suicide Prevention Lifeline.

Certified Community Behavioral Health Clinics - \$40 Million

The BSCA includes \$40 million in technical assistance funds to expand the existing Medicaid Certified Community Behavioral Health Clinic (CCBHC) demonstration program to include all 50 states. **This is a major step forward.**
