Court application to make interim distribution to unitholders of Shield Master Fund

We refer to our circulars dated 1 December 2025, 12 December 2025, 24 December 2025, 5 February 2026 and 24 February 2026 regarding our application to the Court for directions to make an interim distribution to qualifying unitholders in the Shield Master Fund (**SMF**). We provide important further updates below.

Update on fearing on 15 June 2026

The application to make the interim distribution was heard before Justice Moshinsky of the Federal Court of Australia on 15 June 2026. The Court suggested that we file further evidence in support of the application and adjourned the application to a date to be fixed. We are preparing this further evidence and will seek a final hearing of the interim distribution application as soon as possible. Whilst the date for a final hearing has not been set, we confirm that creditors and unitholders will be provided with details of the date and time for the final hearing once determined.

New documents on the Receivers' website

On 15 June 2026, the Court has made orders that allow us to rely on documents received in other proceedings in the interim distribution application. These orders were required to be provided before certain documents related to the interim distribution application were able to be published on our website. As we have those orders, we have now uploaded further documents in relation to the interim distribution application to our website.
