Sales Tax Nexus Analysis

Identifying the state and local jurisdictions where a Company is required to comply with tax has grown increasingly complicated. The importance of sales tax nexus recently became more urgent, when the U.S. Supreme Court handed down its 2018 landmark ruling in *South Dakota v. Wayfair.* Due to Wayfair, sellers may now face more sales and use tax compliance obligations than ever before.

Sales and Purchases Taxability Analyses

The rules for taxing modern digital products and services are often as complex as the technology which enables the product. Purchasers often need assistance to understand which of their purchases are subject to tax and which jurisdiction has the right to tax the purchase; sellers frequently require this assistance too.

Sales and Use Tax Exposure Analysis

Underpayments happen. Knowing about and quantifying underpayments keeps your balance sheet up-to-date and is an important preparatory step for audit preparedness.

Companies are routinely audited by state and local taxing authorities for sales and use taxes more than any other type of tax. Reverse Sales Tax Audit Services

Most government tax auditors are focused on identifying tax underpayments. A&M Taxand helps you to recover and manage "above-the-line" taxes – the indirect taxes. Our professionals identify overpaid sales and use tax and assist in recovering overpaid tax from tax authorities and/or vendors. Examples of such overpayments include exempt purchases, vendor errors, and tax remitted to taxing authorities but not collected from customers; e.g. bad debt write-offs. When performed in conjunction with a state or local Department of Revenue sales tax audit, this detailed reverse sales tax audit review could also reduce interest and penalties incurred in the Department of Revenue audit.

Process and Controls Review

Preventative and detective controls are the key to optimizing the transaction tax function.
