TAKE NOTICE than an application will be made by the applicants to the presiding judge at the courthouse at 800 Smithe Street, Vancouver, BC, V6Z 2E1 on Wednesday, September 22, 2010 at 9:15 a.m. for the orders set out in Part 1 below.

Part 1: ORDER(S) SOUGHT

1. See draft form of Order attached as Schedule "A".

Part 2: FACTUAL BASIS

- 1. On May 29, 2009 the Receiver was appointed the Receiver of certain assets and undertakings (the "Receivership Property") of the Debtor by Order of the Honourable Chief Justice Brenner in these proceedings (the "Receivership Order");
- 2. The Receiver has collected proceeds from the sale of Receivership Property and wishes to distribute the proceeds to the senior secured creditor in partial satisfaction of their debt;
- 3. The Receiver has received interest payments from certain asset backed commercial paper ("ABCP")held by Redcorp that is not covered by Note Holders' (as defined in the Fourth Report) security, and the Receiver has sold oil and gas assets of Redfern in the Province of Alberta that are not part of the Note Holders' security. The Receiver wishes to pay these interest payments to the Trustee of Redcorp and Redfern;
- 4. The D & O Claims process proceeded pursuant to Order dated August 20, 2009:
 - nine claims were received;
 - all were disallowed:
 - there were two appeals;
 - the disallowance of appeals was confirmed by Order of The Honourable Mr. Justice Burnyeat on February 19, 2010;
 - there were no further appeals received and all applicable appeal periods have run out.

Accordingly, the Directors Charge is no longer required;

- 5. The Note Holders' security is the first charge against Receivership Property and the funds to be paid to the Note Holders are the proceeds of the sale thereof;
- 6. The Trustee has priority over Note Holders to the interest received on the ABCP and the proceeds from the sale of the oil & gas assets.

- 4. THIS COURT ORDERS THAT the Receiver pay the net proceeds from the sale of the Oil and Gas Assets of Redfern Resources Ltd. (as described in the Fourth Report) in the sum of \$150,341.27 to Abakhan & Associates Inc., Trustee in Bankruptcy for the estate of Redfern Resources Ltd.;
- 5. THIS COURT ORDERS AND DECLARES THAT the Director's Charge, as defined in paragraph 27 of the Order of the Honourable Chief Justice Brenner dated March 4th, 2009 granted herein, is hereby released and discharged; and
- 6. THIS COURT ORDERS THAT the approval of this Order by counsel appearing, other than counsel for the Receiver, is hereby dispensed with.
