
**INSTRUCTION LETTER FOR THE PRE-FILING CLAIMS PROCEDURE OF
INTERTAN CANADA LTD. AND TOURMALET CORPORATION**

(hereinafter referred to as the “Applicants”)

PRE-FILING CLAIMS PROCEDURE

By order (the “Pre-Filing Claims Procedure Order”) of the Ontario Superior Court of Justice (Commercial List) (the “Court”) dated February 10, 2009 under the *Companies’ Creditors Arrangement Act*, R.S.C. 1985, c. C-36 (the “CCAA”), the Applicants have been authorized to conduct a pre-filing claims procedure (the “Pre-Filing Claims Procedure”).

This letter provides general instructions for responding to or completing the Proof of Claim. For your information, there is currently no proposed plan under the CCAA. Defined terms, which are not defined herein, shall have the meaning ascribed thereto in the Pre-Filing Claims Procedure Order.

The Pre-Filing Claim Procedure is intended for any Person with any claims of any kind or nature whatsoever, against any or all of the Applicants existing and arising as at November 10, 2008. Please review the Pre-Filing Claims Procedure Order for the complete definition of a Pre-Filing Claim.

FOR CREDITORS SUBMITTING A PROOF OF CLAIM

If you believe that you have a Pre-Filing Claim against any or all of the Applicants you must file a Proof of Claim form with the Monitor. Pre-Filing Claims relating to amounts owing to the Applicants as of November 10, 2008 **must be received by 5:00 p.m. (Toronto time) on Monday March 16, 2009** unless the Monitor and the Applicants agree in writing or the Court orders that the Proof of Claim be accepted after that date.

Additional Proof of Claim forms and other information, including the Pre-Filing Claims Procedure Order, can be obtained from the Monitor's website at www.alvarezandmarsal.com/intertan, or by contacting the Monitor at the telephone and fax numbers indicated above and providing the particulars as to your name, address, facsimile number, email address and contact person. Once the Monitor has this information, you will receive, as soon as practicable, additional proof of claim forms.

EXCLUDED CLAIMS

The following are Excluded Claims at this time and no person needs to file any claim in respect thereof at this time:

- (i) the DIP Lenders (as defined in the Amended and Restated Initial Order, dated December 15, 2008);
- (ii) customers with gift cards, store credits, or with ongoing warranty programs;
- (iii) employees who continued to be employed by the Applicants after November 10, 2008; and
- (iv) JV Managers of JV Stores (each as defined in the Wong Affidavit, sworn November 10, 2008) that remained open after November 10, 2008, in respect of deposits provided to the Applicants pursuant to JV Agreements (also as defined in the Wong Affidavit, sworn November 10, 2008).
