 - proof of claims and proxies received; and
 - affidavit of mailing with respect to the Notice of Creditors Meeting.
- 3. The Chairman advised that presentation of the Plan and the Monitor's comments and recommendations were dispensed with as all those in attendance were familiar with the Plan and Monitor's comments regarding same.
- 4. The Chairman described the voting process and requisite majorities as prescribed in the Meeting Order and *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C36, as amended ("CCAA");
- 5. It was resolved to approve the Plan.
