- 1. Komatsu Financial (Canada) Ltd. ("**Komatsu**") is seeking an Order, substantially in the form attached hereto as Schedule "A":
 - (a) deeming service of this Application good and sufficient, and abridging time for notice of this Application to the time actually given, if necessary;
 - (b) granting Komatsu immediate possession of the following equipment:

- (c) declaring that SR does not have an interest in the Komatsu Equipment;
- (d) requiring the Receiver to make the Komatsu Equipment available to Komatsu so that it may take possession and dispose of same as it sees fit; and
- (e) such further and other relief as counsel may request and this Honourable Court may deem appropriate.

Grounds for making this application:

2. The grounds upon which Komatsu relies in making the within application are as follows:

- (a) pursuant to a series of conditional sales contracts dated December 14, 2012, March 25, 2013, and April 30, 2014 (the "CSCs") Komatsu sold the Komatsu Equipment to Edmonton Heavy Equipment Rentals Ltd. ("Edmonton Heavy");
- (b) Komatsu registered its interests in the Komatsu Equipment in the Alberta Personal Property Registry as instrument numbers 12121728511, 13032835799, 13032835862, 13032835196, 13032834911, 13032834307, 14051428036, 14051424999, 14051427807, and 14051425518, as amended;
- (c) as at October 14, 2014, there was \$3,505,757.98 owing to Komatsu under the CSCs;
- (d) the Receiver was appointed over the property of SR on July 31, 2014 in the receivership proceedings (the "Receivership Proceedings") commenced by the Royal Bank of Canada;
- (e) Edmonton Heavy entered into an agreement (the terms of which are not known to Komatsu) with SR for the use the Komatsu Equipment in breach of the CSCs;
- (f) the principals of SR are also the principals of Edmonton Heavy;
- (g) it was a condition of the CSCs that Edmonton Heavy would not lease, provide an interest in or give possession of the Komatsu Equipment to any other party;
- (h) Edmonton Heavy registered its interest in the certain pieces of Komatsu Equipment against SR in the Personal Property Registry;
- (i) SR and the Receiver do not hold a legal right to possession of the Komatsu Equipment;
- (j) Edmonton Heavy has negotiated a prospective sale of the Komatsu Equipment to a third party; and

(k) such further relief as counsel may request and this Honourable Court may deem just.

- 3. Komatsu intends to rely upon the following materials:
 - (a) the affidavit of Remo Iacovozzi, sworn October 16, 2014, filed; and
 - (b) the materials and orders filed in the Receivership Proceedings; and
 - (c) such further and other materials as counsel may advise and this Honourable Court may permit.
