TAKE NOTICE than an application will be made by the Petitioners to the Honourable Madam Justice Brown at the courthouse at 800 Smithe Street, Vancouver, BC, V6Z 2E1 on October 3, 2012 at 9:15 a.m. for the orders set out in Part 1 below.

### Part 1: ORDER(S) SOUGHT

- 1. An order in the form attached hereto as Schedule "B"; and
- 2. such further and other relief as this Honourable Court may order.

# Part 2: FACTUAL BASIS

- 1. On June 21, 2012, the Honourable Mr. Justice Grauer pronounced an Initial Order in these proceedings pursuant to the provisions of the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended, which granted relief, including, *inter alia*, a stay of proceedings until 11:59 p.m. on July 20, 2012.
- 2. On July 20, 2012, the Petitioners applied for, and were granted, an extension of the relief in the Initial Order, including the stay of proceedings, to September 28, 2012.

- 3. On September 7, 2012, the Petitioners applied for, and were granted, a further extension of the relief in the Initial Order (the "Second Extension Order"), including the stay of proceedings, to October 5, 2012.
- 4. The Petitioners' application to strike out certain portions of Affidavits #1 and #2 of Jason Kruger, the pending motion of Her Majesty the Queen in right of the Province of British Columbia to set aside the Initial Order and the application of the Petitioners for a further extension of the relief in the Initial Order, and the Claims Process Order (collectively, the "Motions") were scheduled to be heard on October 2, 4 and 5, 2012, respectively. The stay of proceedings was extended to October 5, 2012 to coincide with the hearing dates.
- 5. The parties in this matter have subsequently been advised that Mr. Justice Grauer, who is seized of this matter, is unavailable on the dates originally chosen for the hearing. The Motions will instead be heard on October 16, 18 and 19, 2012, respectively.
- 6. Given that (pursuant to the Second Extension Order), the relief granted in the Initial Order expires on October 5, 2012, the Petitioners seek an extension of the Initial Order to October 19, 2012 to coincide with the new hearing dates. All of the parties in this matter have consented to this extension.
- 7. The Petitioners have acted and continue to act in good faith and with due diligence in these proceedings.

#### Part 3: LEGAL BASIS

- 1. *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36, as amended, and in particular ss. 11, 11.02, 19 thereof; and
- 2. the inherent jurisdiction of this Honourable Court.
