1. An Order in the form attached as Schedule “A” hereto, *inter alia*, (the “**Draft Order**”):

- (a) if necessary, abridging the time for service of this Notice of Motion and the Motion Record herein, and dispensing with further service thereof;
- (b) approving the Seventh Report to Court of the Receiver dated October 7, 2009 (the “**Seventh Report**”) and the activities of the Receiver as described therein;
- (c) directing a reference (the “**Reference**”) to a Construction Lien Master in Toronto for the determination of, among other things, the relationship between RRDI and the Lien Claimants having valid Lien Actions (the “**Perfectured Lien Claimants**”), as these terms are defined in the Order of

the Honourable Mr. Justice Campbell dated July 24, 2009 (the **“Construction Lien Claims Process Order”**);

- (d) amending the date in the Construction Lien Claims Process Order by which a Notice of Determination shall be delivered by the Receiver and posted on the Receiver’s website to a date to be set by this Court following a final determination of the Reference; and
- (e) validating service of a Claim pursuant to the CLA and, in particular, on the Muskoka Standard Condominium Corporation No. 62.

2. Such further and other relief as counsel may advise and to this Honourable Court may seem just.

THE GROUNDS FOR THE MOTION ARE:

1. In the course of exercising its duties as trustee and receiver and manager under the CLA, it has become apparent to the Receiver that clarification with respect to role of Rock Ridge Contractors Inc. (**“RRCI”**) is important to the quantification of possible priority amounts for Perfected Lien Claimants.
2. The Receiver believes that it is appropriate for the determination of RRCI’s role with respect to the Claims to be made by reference to a Construction Lien Master in Toronto.

3. The Receiver has not been able to complete its review and determination of the Claims it has received to date, due to the volume of the materials submitted.

4. Additionally, there remains certain information outstanding which the Receiver requires in order to fully evaluate the Claims.

5. Accordingly, in order to provide sufficient time for a final determination of the reference and for the Receiver to complete its Claims review, the Receiver requests that the respective deadlines for the determination of Claims and for the filing of a notice of dispute pursuant to paragraphs 10 to 12 of the Construction Lien Claims Process Order, be extended to a date to be subsequently fixed by the Court.

ON READING the Motion Record of the Receiver including the Seventh Report, all filed, and on hearing the submissions of independent counsel to the Receiver, counsel for WestLB AG, Toronto Branch and the Receiver, counsel for Fortress Credit Corp. and counsel for [NTD: construction lien claimants] no one appearing for any other person on the service list, though properly served,

SERVICE & TERMS

1. THIS COURT ORDERS that the time and manner of service of the Notice of Motion and the Motion Record is hereby abridged and validated so that this motion is properly returnable today and hereby dispenses with further service thereof.
2. THIS COURT ORDERS that all capitalized terms not otherwise defined herein have the same meaning as in the Construction Lien Claims Process Order.

APPROVAL OF RECEIVER’S ACTIVITIES

3. THIS COURT ORDERS that the Seventh Report and the activities of the Receiver as described therein be and are hereby approved.

REFERENCE

4. THIS COURT ORDERS that the following issues relating to the Lien Actions shall be referred to a Construction Lien Master at Toronto for trial (the “**Reference**”):

- (a) are each of the Perfected Lien Claimants a “contractor” as defined in the CLA for the purposes of their respective Claims?
- (b) if the answer to the question in paragraph 4(a) is negative, is Rock Ridge Contractors Inc. a “contractor” as defined in the CLA with respect to the Claims?

The Construction Lien Master shall take all accounts, make all inquiries, give all directions and do all things necessary to finally determine the above issue, and any associated issues, and the findings of the Construction Lien Master shall be effective on the confirmation of the report by this Court. The Construction Lien Master may also determine the question of costs in the Reference, except that the Construction Lien Master shall not make any award of costs against the Receiver.

5. THIS COURT ORDERS that the determination of the issues in the Reference shall not affect the determination of the validity of the Claims by the Receiver as provided for in the Construction Lien Claims Process Order.

6. THIS COURT ORDERS that the Receiver is hereby authorized, if necessary, to bring a motion to fix a date for the trial of the Reference and give any directions related thereto in accordance with the provisions of the CLA and that service of the Notice of Trial by facsimile, mail, courier or email on each of the Perfected Lien Claimants or their counsel, and anyone else on the service list in these proceedings, shall constitute valid and effective service for the purpose of section 60(4) of the CLA.

CONSTRUCTION LIEN CLAIMS PROCESS AMENDMENT

7. THIS COURT ORDERS that the date of October 15, 2009 as provided for in paragraph 10 of the Construction Lien Claims Process Order be and is hereby amended to a date to be determined by this Court following a final determination of the Reference, including all appeals therefrom, or, if before such determination, by further order of this Court.

SERVICE OF CONSTRUCTION LIEN CLAIMS

8. THIS COURT ORDERS that service of a Claim (i) upon any party to a Lien Action in accordance with section 87 of the CLA, and (ii) in the case of a Claim against Muskoka Standard Condominium Corporation No. 62, by sending a copy by facsimile, registered mail or courier to the Receiver, is hereby deemed to be valid and effective service for the purpose of paragraph 6 of the Construction Lien Claims Process Order.

1.0 Introduction

1.1. On May 22, 2009, the Ontario Superior Court of Justice (the “Court”) issued an order appointing Alvarez & Marsal Canada ULC (“A&M”) and Alvarez & Marsal Canada Inc.¹ as trustee and interim receiver, respectively (collectively the “Interim Receiver”) pursuant to Section 68 of the *Construction Lien Act* (Ontario) (“CLA”) and Section 47(1) of the *Bankruptcy and Insolvency Act* (“BIA”) of all the property, assets and undertakings (the “Assets”) of The Rosseau Resort Developments Inc. (“RRDI” or the “Company”). On June 2, 2009, the Court issued an Amended and Restated Appointment Order (the “Appointment Order”) continuing the appointment of the Interim Receiver and appointing A&M as receiver and manager (the “Receiver and Manager”) pursuant to Section 101 of the *Courts of Justice Act* (“CJA”) and pursuant to the CLA of the Assets of RRDI (the Interim Receiver and the Receiver and Manager are hereinafter collectively defined as the “Receiver”).

1.2. On July 24, 2009, an order was made by the Honourable Mr. Justice Campbell which established a claims process for construction lien claims (the “Claims Process Order”). Capitalized terms in this report (the “Seventh Report”) shall have meanings ascribed to them in the Claims Process Order, a copy of which is attached as Appendix A, unless otherwise defined herein.

1.3. The purpose of the Seventh Report is to provide information with respect to the Receiver’s request for an Order:

- (a) directing a reference to a Construction Lien Master in Toronto for a determination of, among other things, the relationship between RRDI and those Lien Claimants who have valid Lien Actions in this matter;
- (b) amending the date in the Claims Process Order by which a Notice of Determination shall be delivered by the Receiver and posted on the Receiver's website to a date to be determined by this Honourable Court; and
- (c) validating service of a Claim (i) upon any party to a Lien Action in accordance with section 87 of the CLA; and (ii) if a copy is served on the Receiver in the case of a Claim against the Muskoka Standard Condominium Corporation No. 62, pursuant to paragraph 6 of the Claims Process Order.

1.4. The Receiver intends to provide this Honourable Court with a more complete update in respect of these proceedings on an upcoming motion.

2.0 Terms of Reference

2.1. In preparing this Seventh Report, the Receiver has relied on unaudited financial information prepared by the Company's management and the Company's consultants and advisors, the Company's books and records and discussions with its management. The Receiver has not performed an audit or other verification of such information. An examination of the Company's financial forecasts as outlined in the Canadian Institute of Chartered Accountants Handbook has not been performed. Future oriented financial information relied on in this Seventh Report is based on management's assumptions regarding future events; actual results achieved may vary from this information and these variations may be material. The Receiver expresses no opinion or other form of assurance with respect to the accuracy of any financial information presented in this Seventh Report, or relied upon by the Receiver in preparing the Seventh Report. All references to dollar figures contained in the Seventh Report are in Canadian currency unless otherwise specified.

3.0 Relationship Between RRDI and the Lien Claimants

3.1. Certain Lien Claimants have requested information with respect to the relationship between RRDI, Rock Ridge Contractors Inc. ("RRCI") and the Lien Claimants. The Receiver understands that the primary purpose for which certain Lien Claimants have requested this information is so that they may attempt to determine whether the Lien Claimants had a direct contractor relationship with RRDI or whether RRCI had a contractor relationship with RRDI (and therefore the Lien Claimants were subcontractors of RRDI) (the "RRCI/RRDI Reference"). The determination of RRCI's role in this context has an impact on, among other things, the calculation of amounts owing in respect of construction holdback priorities to the Lien Claimants and it is therefore important to have this issue determined prior to certain steps occurring in the construction lien claims process. In particular, this determination may influence a Lien Claimant's decision to dispute other Lien Claimants' claims, pursuant to the Claims Process Order.

3.2. On or about June 3, 2009, the Receiver provided various Lien Claimants with a copy of the contract between RRDI and RRCI (the "RRDI/RRCI Contract") which it obtained from the books and records of RRDI. A copy of the RRDI/RRCI Contract is attached as Appendix B. In addition, by letter dated July 23, 2009 (the "July 23rd Letter"), the Receiver provided the Lien Claimants with certain information that the Receiver concluded that the Lien Claimants were entitled to receive and which was requested by Lien Claimants, pursuant to Section 39 of the CLA. A copy of the July 23rd Letter is attached as Appendix C.

3.3. Subsequent to the Receiver providing the Lien Claimants with the RRDI/RRCI Contract and the July 23rd Letter, certain Lien Claimants requested further information regarding the role of RRCI in connection with construction of The Rosseau, a J.W. Marriott Resort & Spa (the

“Hotel”). The following is a summary of the Receiver’s understanding of the role of RRCI in the development and construction of the Hotel. The development and construction of the Hotel and surrounding property, all of which is on the property owned by RRDI, is hereinafter referred to as the “Project”.

3.4. The Receiver has been advised by its legal counsel that the criteria which the Court may consider in order to determine whether (i) a trade contractor contracted directly with an owner (RRDI) and the role of the intermediary (RRCI) was one of agent or construction manager; or (ii) a trade contractor contracted with a general contractor (RRCI) as a subcontractor to the owner (RRDI), includes the following:

- a) the language and provisions of any contract between RRDI and RRCI;
- b) the language and provisions of any contract between RRCI and the trades that performed work and services in connection with the Project;
- c) RRCI’s involvement in the Project;
- d) the role of RRCI as perceived by the trade contractors;
- e) the interest, if any, which RRCI might have in the Project;
- f) the nature of the finances in respect of the improvement; and
- g) what expectation there was, if any, that RRCI would finance, in whole or in part, the construction of the Project.

The language and provisions of any contract between RRDI and RRCI

3.5. The RRDI/RRCI Contract is in the form of an executed Canadian Construction Association Form 5 (“CCA”) Canadian Standard Construction Management Contract and dated as of April 1, 2005. The RRDI/RRCI Contract was executed on behalf of both RRDI and RRCI by Ken Fowler, as President of each company.

3.6. The RRDI/RRCI Contract was for nominal consideration (\$1.00) for services performed during the construction phase of the Hotel. The RRDI/RRCI Contract called for RRDI to reimburse RRCI for: *"All costs directly and indirectly attributable to the Work to maximum amounts as follows: For Longview, including Off Site Servicing, Onsite Servicing, Landscaping and Building Construction Costs of the Work shall not exceed \$64,389,736 in Canadian Funds. For Paignton House, Including Off Site Servicing, Onsite Servicing, Landscaping and Building Construction Costs of the Work shall not exceed \$13,326,272 in Canadian Funds."*²

3.7. Section GC 2 of the RRDI/RRCI Contract outlines RRCI's responsibilities in respect of the Project. Relevant excerpts include:

Section 2.2.5.4: Assemble all bid documents for the solicitation of competitive bids for Work to be performed by Trade Contractors.

Section 2.2.5.5: Analyze the bids received and recommend awards to the Owner (RRDI). Once awards are approved by the Owner, prepare the trade contracts for execution.

Section 2.3.1: Coordinate the Work with the activities and responsibilities of the Owner, consultants, trade contractors and itself.

3.8. The above provisions indicate that ultimate responsibility for selecting the trade contractors rested with RRDI as the Owner.

3.9. In addition, Section 4.9 provides that the Owner shall provide for the payment of all trade contractors in accordance with the terms and conditions of *his* (emphasis added)

agreements with the trade contractors and Section 4.10 further identifies the Construction Manager (RRCI) as the sole entity responsible for communication between the Owner and the trade contractors.

The language and provisions of any contract between RRCI and the trades that work and services in connection with the Project

3.10. The Receiver believes that, based on its review of the relevant documentation, relationships between RRDI, RRCI and the respective trade contractors can be classified into four general categories:

- a) trade contractors with formal CCA contracts with RRDI;
- b) trade contractors with formal CCA contracts with RRCI;
- c) trade contractors having a letter of intent with RRCI; and
- d) trade contractors performing work or supplying goods pursuant to purchase orders from RRCI and/or RRDI.

3.11. Based on the Receiver's review of RRDI's records, initial CCA trade contracts were executed between and among RRCI and certain of the trade contractors. However, the Receiver has only been able to locate eight (8) such contracts. Only three (3) of the eight (8) contracts located relate to current lien claimants (Schindler Elevator Corporation, Vipond Fire Protection and Bonavista Pools) (collectively the "Initial Contracts").

3.12. Based on the Receiver's discussions with RRDI staff which were held subsequent to the commencement of the receivership, the Receiver understands that in or about January and February 2009, RRDI began to revise its various trade contracts to change the executing party,

where applicable, from RRCI to RRDI, with RRCI still referred to as the Construction Manager (the "Revised Contracts").

3.13. The Receiver was able to locate thirteen (13) of these Revised Contracts. However, from the Receiver's review, only nine (9) were fully executed. Included in these nine were the following seven (7) Lien Claimants; Wallwin Electric Services, Interart Décor Ltd, Can-Barr Mechanical, Rock Solid Granite Tops, Quanbury Contract Interiors, Barzelle Designs Ltd, and GM Exteriors. All of the Revised Contracts reflect the fact that the Owner (RRDI) is to make payments on account of such Revised Contracts.

RRCI's involvement in the Project

3.14. Based on the Receiver's review, it appears that the functions of RRDI and RRCI are not clearly distinguishable. While RRDI and RRCI employed separate staff and each had their own payrolls, certain employees of both entities performed project management duties, which blurred the roles of "owner" and "construction manager." Further, the accounting records of RRDI and RRCI were consolidated together and for review and evaluation purposes, management considered the two entities as one.

3.15. For most of the Project, the senior construction supervisor was Howard Scott ("Mr. Scott"). Mr. Scott's official title was Director of Construction; however, Mr. Scott was employed by, and on the payroll of, RRDI. Immediately subordinate to Mr. Scott, was John MacDonald ("Mr. MacDonald"). Mr. MacDonald was an employee of RRCI. While there were numerous staff members working on the Project, it appears that from a payroll perspective that the individual employment arrangements were arbitrarily divided between RRDI and RRCI. However, it appears as though most of the site supervision staff were employees of RRCI.

3.16. Although Mr. Scott was an RRDI employee, he represented himself as the Director of Construction for RRCI. This is evidenced by historical e-mails in which his e-mail signature identifies him as "Howard Scott, Director of Construction, Rock Ridge Contractors Inc.".

The position of RRCI as perceived by the trades

3.17. The Receiver is not in a position to comment on how RRCI was perceived by the trade contractors.

The interest, if any, which RRCI might have in the Project

3.18. The Receiver understands that RRCI does not have any interest, financial or otherwise, in the Hotel or the Project.

The nature of the finances in respect of the improvement and expectation there was, if any, that RRCI would finance, in whole or in part, the construction of the Project

3.19. For the purposes of accounting and ongoing review of the Project, costs incurred by RRDI and RRCI were consolidated in one set of books and records. Based on the Receiver's review, it appears that little or no regard was made for the need to maintain and settle intercompany accounts as between RRDI and RRCI. Further, it appears that RRCI had no finance function whatsoever. This was solely the responsibility of RRDI.

3.20. In general terms, all offsite construction, onsite construction, landscaping and general construction costs were allocated to and accounted for in RRCI (the "RRCI Divisions"), whereas commissions, royalties, land, consultants, development charges, FF&E, interest, and marketing costs (the "RRDI Divisions") were recorded in the books and records of RRDI as costs of RRDI. At the time of the receivership, aggregate costs incurred towards the development of the Hotel

totaled \$165.9 million. Of that, \$103.4 million was incurred by RRCI and the balance was incurred through RRDI³ based on the RRDI and RRCI Divisions noted above.

3.21. During any typical month throughout the construction phase, RRCI would incur costs directly related to the RRCI Divisions and receive invoices for such costs which would be recorded in RRCI's accounts payable system. At the end of each month, RRCI would issue invoices for this work in progress ("WIP") to RRDI; however, no money changed hands specifically for this invoiced WIP.

3.22. Payments to the trade contractors for work performed in the RRCI Divisions were issued by RRCI. However, signing authorities on RRCI's bank accounts and management of both RRDI and RRCI were the same individuals.⁴ When RRCI needed funds to pay these trade contractors, as well as employees and other expenses, a "cash call" would be prepared by Rupert McNay, Director of Finance for RRDI, which would result in cash being transferred from RRDI or reportedly from the Red Leaves Resort Partnership, the 100% owner of both RRDI and RRCI (the "Partnership"). RRDI transferred \$74.1 million directly to RRCI.

3.23. RRDI received advances from its senior lending syndicate and Fortress Investment Group in the approximate amounts of \$84 million and \$22 million respectively. The Receiver is not aware of any advances made to RRCI by the senior lending syndicate or Fortress Investment Group.

³ This information was obtained by the Receiver from the project accountant who was in charge of the construction finances for both RRDI and RRCI. The Receiver has not performed any type of review of these figures.

3.24. It is important to note that pursuant to the Appointment Order, the Receiver only has access to the books and records of RRDI and not those of RRCI. Based on the Receiver's review of the books and records of RRDI the documentation reviewed suggests that RRCI was acting as an agent/construction manager pursuant to the RRDI/RRCI Contract. However, due to the potential implications with respect to this determination, the Receiver respectfully requests that this Honourable Court order that the determination of this issue be referred to a Construction Lien Master.

4.0 Construction Lien Claims Process Order

4.1. As noted above, on July 24, 2009, the Court approved the Claims Process Order which provided, among other things, that:

- a) a Claim must have been preserved and perfected in accordance with the provisions of the CLA and shall have been served upon the Receiver and all named defendants to such Lien Action;
- b) in filing a Claim with the Receiver, all Lien Claimants shall include contract copies, change orders, purchase orders, and other related documents to which the Claim is asserted;
- c) the Receiver shall deliver a Notice of Determination to such Lien Claimants on or before October 15, 2009, and the Receiver shall post each Notice of Determination on its website immediately after delivery to such Lien Claimant in any event on or before October 15, 2009.

4.2. The Receiver's legal counsel has identified 32 separate liens filed against the property. A summary of the Claims is attached as Appendix D. As at the date of this Report, 11 Lien Claimants have not yet provided the Receiver with the information required pursuant to paragraphs 7 (a-e) of the Claims Process Order. The Receiver's legal counsel is in the process of following up with each Lien Claimant who has not yet provided such information.

4.3. Further, while certain Lien Claimants have provided such information, the Receiver has not yet completed a detailed review of all of the claims due to the substantial amount of documentation received.

4.4. Accordingly the Receiver respectfully requests that this Honourable Court grant an Order extending the October 15, 2009 deadline referenced in paragraph 10 of the Claims Process Order to a date to be determined by the Court following the determination of the RRCI/RRDI Reference.

4.5. As no proceeds have been realized, the Receiver is not in a position at this time to make a distribution. As such, the Receiver is of the view that no parties would suffer any prejudice as a result of the proposed extension of the October 15, 2009 date in the Claims Process Order.

5.0 Requirement for Service

5.1. A number of Lien Claimants have requested that the Receiver seek an order from this Honourable Court validating service of (i) any Claim which is served pursuant to section 87 of the CLA, and (ii) in the case of a claim against Muskoka Standard Condominium Corporation No. 62 (the "Condo Corp."), by sending documents by facsimile, courier, or registered mail to the Receiver.

5.2. As RRDI still owns a majority of units which comprise the Condo Corp., the Lien Claimants have specifically requested an order that service of the Claim on the Condo Corp. is effective for the purposes of the Claims Process Order where a copy is sent by facsimile, courier, or registered mail to the Receiver.

6.0 Additional Information Requested by the Lien Claimants

6.1. Several of the Lien Claimants have requested that the Receiver provide additional information with respect to financial relationships between RRDI, RRCI and certain Lien Claimants, including;

- a) Details of payments to all trade contractors, including details with respect to holdback monies released; and
- b) Details with respect to contractual relationships between trade contractors, RRDI and RRCI;

6.2. The Receiver is not prepared to provide information about the contractual relationships, scope of work and terms such work of certain trade contractors to other trade contractors without Court authorization to do so. Accordingly, the Receiver has not provided such information to the Lien Claimants.

6.3. If the RRCI/RRDI Reference determines that RRDI had direct contractor relationships with the various Lien Claimants, the provision of information to all Lien Claimants with respect to specific trade contractor contract terms and payments as contemplated in the previous paragraphs would likely be unnecessary. As such, the Receiver proposes to address the responses to the above inquiries following the determination of the RRCI/RRDI Reference.

7.0 Conclusions and Recommendations


7.1. The Receiver therefore respectfully requests that this Honourable Court:

- a) Approve the Receiver's activities as described in this Seventh Report;
- b) Refer, among other things, the determination of the relationship between RRDI and Lien Claimants having valid Lien Actions to a Construction Lien Master in Toronto;
- c) Amend the date in the Claims Process Order by which a Notice of Determination shall be delivered by the Receiver and posted on the Receiver's website, to a date to be later determined by this Honourable Court once there has been a determination of the RRDI/RRCI Reference; and
- d) Validate service of a Claim (i) upon any party to a Lien Action in accordance with section 87 of the CLA; and (ii) if a copy is served on the Receiver in the case of a Claim against the Muskoka Standard Condominium Corporation No. 62, pursuant to paragraph 6 of the Claims Process Order.

CONSTRUCTION LIEN CLAIMS PROCESS ORDER

THIS MOTION, made by Alvarez & Marsal Canada ULC ("A&M"), in its capacity as Court-appointed receiver and manager pursuant to section 101 of the *Courts of Justice Act* (the "CJA") and trustee and receiver and manager under the *Construction Lien Act* (Ontario) (the "CLA"), and McIntosh & Morawetz Inc., in its capacity as interim receiver (the "Interim Receiver") pursuant to section 47(1) of the *Bankruptcy and Insolvency Act*, (jointly and collectively, the "Receiver") of the undertaking, property and assets, including the Property (as

defined below) of The Rosseau Resort Developments Inc. ("RRDI"), for, *inter alia*, approval of a construction lien claims process, was heard this day at 330 University Avenue, Toronto, Ontario.

WHEREAS pursuant to the Order of the Honourable Madam Justice Pepall dated May 22, 2009, A&M was appointed as trustee pursuant to section 68(1) of the CLA and McIntosh & Morawetz Inc. was appointed Interim Receiver;

AND WHEREAS pursuant to the Amended and Restated Appointment Order of the Honourable Madam Justice Pepall dated June 2, 2009, A&M was appointed receiver and manager pursuant to section 101 of the CJA and the CLA;

AND WHEREAS the Receiver has not adopted or affirmed any contracts or agreements of RRDI, including any contracts with any party (each, a "Lien Claimant") who is entitled to assert a claim for lien under the CLA in respect of the lands and premises legally described in **Schedule "A"** hereto and the condominium project under construction thereon (the "Property") for services and materials provided prior to May 22, 2009 (each, a "Claim");

AND WHEREAS the Receiver has entered into new contracts for the provision of services and materials with respect to the Property after May 22, 2009;

AND WHEREAS the Receiver seeks the approval of the process described in the Second Report of the Receiver dated July 3, 2009 (the "Second Report") and described herein for the administration of any such Claims (the "Construction Lien Claims Process");

ON READING the Second Report; filed; and on hearing the submissions of counsel for WestLB AG, Toronto Branch ("WestLB") and the Receiver, Fortress Investment Group ("Fortress"); counsel for the Debtor; independent counsel for the Receiver; counsel for Marriott Hotels of Canada Ltd. no one else appearing.

SERVICE

1. THIS COURT ORDERS that the time for service of the Notice of Motion and the Motion Record is hereby abridged so that this Motion is properly returnable today and hereby dispenses with further service thereof.

CLAIMS PROCESS

2. THIS COURT ORDERS AND DECLARES that the Construction Lien Claims Process is hereby approved and is the exclusive process by which all Claims shall be determined, and all Claims shall attorn to the Construction Lien Claims Process.
3. THIS COURT ORDERS that the Receiver is hereby authorized and directed to implement and administer the Construction Lien Claims Process, including the acceptance, revision, disallowance and/or settlement of any Claims by any Lien Claimant, and the Receiver may take any steps which it believes are incidental or necessary for the implementation of the Construction Lien Claims Process.
4. THIS COURT ORDERS AND DIRECTS that all Claims shall be determined and administered by the Receiver under the supervision of this Court pursuant to the Construction Lien Claims Process and any such determination or disposition of any Claim shall have the same force and effect as if made by a court of competent jurisdiction pursuant to the CLA. The Receiver may retain any consultant or assistant as it may require to assist in the review and determination of any Claim.
5. THIS COURT ORDERS AND DECLARES that, for the purposes of the CLA, all contracts and subcontracts for the provision of services and materials with respect to the Property prior to May 22, 2009 are deemed to have been substantially performed, completed or abandoned (as the case may be) on the earlier of date(s) so determined pursuant to the provisions of the CLA and May 22, 2009.
6. THIS COURT ORDERS AND DIRECTS that in order to be properly filed with the Receiver for purposes of the Construction Lien Claims Process, a Claim, including any sheltered claim for lien, must have been preserved and perfected in accordance with the provisions of the CLA (a "Lien Action") and shall have been served upon the Receiver and all named defendants to such Lien Action.
7. THIS COURT ORDERS AND DIRECTS that in filing a Claim with the Receiver, all Lien Claimants shall include:

- (a) a copy of the contract or subcontract including any change orders, amendments, purchase orders, or other related documents on which such Claim is asserted;
- (b) the names of the parties to the contract or subcontract;
- (c) the contract price and a statement of account, including the dates and amounts of payments received;
- (d) a copy of any labour and material payment bond posted by a subcontractor with a contractor or by a subcontractor with a subcontractor; and
- (e) any other documents or information as the Receiver may reasonably request for the purpose of assessing and determining any Claims in accordance with paragraph 3 of this Order.

NO DEFAULT PROCEEDINGS OR DEFENCES

8. THIS COURT ORDERS that no default or enforcement proceedings shall be commenced against any defendant in any Lien Action unless authorized by further Order of this Court.

9. THIS COURT ORDERS that the requirement for the Receiver, RRDI, WestLB, Fortress, or any defendant in any Lien Action to file a statement of defence is hereby dispensed with subject to any further Order of this Court.

DETERMINATION OF CLAIMS

10. THIS COURT ORDERS that the Receiver shall accept, revise and/or disallow a Claim as set out in a Lien Claimant's Statement of Claim by delivering a notice of determination including the reasons for such determination (a "Notice of Determination"), and all documentation, if any, referred to in the notice of determination to such Lien Claimant on or before October 15, 2009, and the Receiver shall post each Notice of Determination only, without any supporting documentation, on its website immediately after delivery to such Lien Claimant and in any event on or before October 15, 2009. Any Lien Claimant who files a Notice of Dispute with respect to

a Notice of Determination of the Claim of another Lien Claimant may request, and the Receiver shall provide, any documentation referred to in such Notice of Determination.

DISPUTE NOTICE AND APPEALS

11. THIS COURT ORDERS that a Lien Claimant may appeal the acceptance, revision and/or disallowance (as the case may be) of any Claim as set out in a Notice of Determination by delivering a Dispute Notice to the Receiver substantially in the form attached to this Order as Schedule "B" ("Dispute Notice"), within 30 days of the posting of such Notice of Determination by the Receiver on its website. Any Lien Claimant who does not deliver a Dispute Notice within 30 days of such posting shall be deemed to have accepted the Receiver's determination as set out in the Notice of Determination, which shall be final and binding, and that portion, or the whole, of the Claim so disallowed (as the case may be), shall be forever barred and extinguished pursuant to this Order.

12. THIS COURT ORDERS AND DIRECTS that any appeal of a Notice of Determination as set out in a Dispute Notice shall be referred to a claims officer (with construction lien expertise), as appointed by further order of this Court or by reference by order of this Court to a Construction Lien Master or Case Management Master. Any appeal of a Notice of Determination shall be conducted as a hearing *de novo* and any appeal (or motion to oppose confirmation of a report), of a claims officer, Construction Lien Master or Case Management Master, shall be heard by this Court on a timetable agreed to by the parties to that proceeding and approved by this Court and shall be final and binding on all parties with no further appeal thereof.

CLAIMS BAR PROVISIONS

13. THIS COURT ORDERS that any Claim:

- (i) which is not preserved and perfected pursuant to the provisions of the CLA and served in accordance with paragraph 6 of this Order with all accompanying documentation as required by paragraph 7 hereof; or

- (ii) for which a Dispute Notice is not delivered by a Lien Claimant disputing a Notice of Determination with respect to its Claim to the Receiver within 30 days of the posting of a Notice of Determination by the Receiver;

shall be forever barred and extinguished and such Lien Claimant shall be forever estopped and enjoined from asserting or enforcing any further Claims against the Property, RRDI, WestLB, Fortress or the Receiver, and such Lien Claimant shall not be entitled to receive further notice of these proceedings, and in any event, all claims of any nature against the Receiver, WestLB and Fortress are hereby forever barred and extinguished.

14. THIS COURT ORDERS that nothing in this Order shall bar or extinguish:

- (i) trust claims under the CLA, against any party other than the Receiver, WestLB and Fortress, or against the Property or proceeds of sale of the Property subsequent in priority to the Receiver, WestLB and Fortress, and RRDI, as permitted by further Order of this Court;
- (ii) any claims in contract against any party, other than the Receiver, WestLB and Fortress, and subject to further Order of this Court, RRDI; and
- (iii) any Claim in its entirety or part thereof which has been accepted by the Receiver.

NOTICES AND COMMUNICATION

15. THIS COURT ORDERS that, except as otherwise provided herein, the Receiver may deliver any notice or other communication to be given under this Order to Lien Claimants or other interested parties by forwarding true copies thereof by ordinary mail, courier, personal delivery, facsimile or e-mail to such Lien Claimants or parties at the address last shown on the books and records of the Debtor, and that any such service or notice by ordinary mail, courier, personal delivery, facsimile or e-mail shall be deemed to be received on the next business day following the date of forwarding thereof, or if sent by ordinary mail on the third business day after mailing within Ontario, the fifth business day after mailing within Canada, and the tenth business day after mailing internationally.

16. THIS COURT ORDERS that any notice or other communication to be given under this Order by a Lien Claimant to the Receiver shall be in writing in substantially the form, if any, provided for in this Order and will be effective only if delivered by registered mail, courier, personal delivery, e-mail or facsimile transmission addressed to:



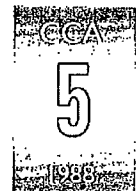

Various elements of shared infrastructure including but not limited to Domestic Water Supply, Sanitary Sewer Services, Telecommunications network & infrastructure, power distribution and provision of backup power generation for the facilities, Landscaping, irrigation and other works.

See the attached list of Contract Documents as updated from time to time as design is completed.

ARTICLE A-5 CONTRACT FEE

- (a) The Owner agrees to pay the Construction Manager as compensation for his services a Contract Fee of

ARTICLE A-6 REIMBURSIBLE EXPENSES

In addition to the Contract Fee stipulated in ARTICLE A-5 CONTRACT FEE of this Agreement, the Owner agrees to pay the Construction Manager for the Reimbursible Expenses he incurs as defined by APPENDIX 'A' to this Agreement in accordance with ARTICLE A-8 PAYMENT and GC 10-APPLICATIONS FOR PAYMENT

ARTICLE A-7 OWN FORCES WORK

The Construction Manager may, subject to the Owner's approval, perform work with his own forces. Such work shall be performed in accordance with the terms of this Agreement. The Owner shall pay to the Construction Manager the cost of such work plus a fee being zero (0%) per cent of that cost in addition to all other amounts payable pursuant to this Agreement. For the purposes of this provision, cost of the work shall include and be limited to those items set forth in APPENDIX 'A' -REIMBURSIBLE EXPENSES to this Agreement.

ARTICLE A-8 PAYMENT

- (a) The Owner agrees to make monthly payments to the Construction Manager in Canadian funds on account of Reimbursible Expenses incurred to date, the applicable portion of the Contract Fee earned as described in ARTICLE A-5 CONTRACT FEE of this Agreement, any work performed directly by the Construction Manager pursuant to ARTICLE A-7 OWN FORCES WORK and for Additional Services in accordance with GC 2.5

- (b) If the Owner fails to make payments to the Contractor as they become due under the terms of this Contract, or in an award by arbitration or court, interest at zero per cent (0.00 %) above the prime rate per annum as of the date payment became due on such unpaid amounts shall also become due and payable until payment. Such interest shall be calculated and added to any unpaid amounts monthly.

Prime rate, for the purposes of this Agreement, means the lowest rate of interest quoted by The Royal Bank of Canada from time to time in the City of _____ to the most credit-worthy borrowers for prime business loans.

ARTICLES A-9 RIGHTS AND REMEDIES

- (a) The duties and obligations imposed by the Contract Documents and the rights and remedies available thereunder shall be in addition to and not a substitution for any duties, obligations, rights and remedies otherwise available by law.
- (b) No action or failure to act by the Owner or Construction Manager shall constitute a waiver of any right or duty afforded either of them under the Contract, nor shall any such action or failure to act constitute an approval of or acquiescence in any breach thereunder, except as may be specifically agreed in writing.

ARTICLE A-10 RECEIPT OF AND ADDRESSES FOR NOTICES

Communications in writing between the parties shall be considered to have been received by the addressee on the date of delivery if delivered by hand to the individual or to a member of the firm or to an officer of the corporation for whom they are intended or if sent by post or by telegram, to have been delivered within five (5) days of the date of mailing, dispatch or delivery to the telegraph company when addressed as follows:

ARTICLE A-12 LANGUAGE OF THE CONTRACT

When the Contract Documents are prepared in both the English and French languages, it is agreed that in the event of any apparent discrepancy between the English and French versions, the * ~~English~~ language shall prevail.

ARTICLE A-13 PRIOR NEGOTIATIONS, REPRESENTATIONS OR AGREEMENTS

This Agreement supersedes all prior negotiations, representations or agreements, either written or oral.

ARTICLE A-14 SUCCESSION

This Agreement shall enure to the benefit of and be binding upon the parties hereto and their respective heirs, legal representatives, successors and assigns.

ARTICLE A-15 DISCOUNTS, REBATES AND REFUNDS

All cash discounts shall accrue to the Construction Manager unless the Owner deposits funds with the Construction Manager with which to make payments, or makes such payments directly, in which case the cash discounts shall accrue to the Owner. All trade discounts, rebates and refunds, and all returns from sale of surplus materials and equipment applicable to the Project shall accrue to the Owner, and the Construction Manager shall make provisions so that they can be secured.

APPENDIX 'A'

REIMBURSIBLE EXPENSES

The following items are the Reimbursible Expenses referred to in ARTICLE A-6 REIMBURSIBLE EXPENSES and the cost of the work for the purposes of ARTICLE A-7 OWN FORCES WORK of the Agreement and shall be at rates prevailing in the locality of the Place of the Project except with the prior consent of the Owner:

- (a) wages and benefits paid for labour in the direct employ of the Construction Manager in the performance of the Project under applicable collective bargaining agreements or under a salary or wage schedule agreed upon by the Owner and Construction Manager;
- (b) salaries, wages and benefits of the Construction Manager's personnel in whatever capacity employed; salaries, wages and benefits of personnel engaged at shops, or on the road, in expediting the production or transportation of materials or equipment, for that portion of their time spent on the Project; salaries, wages and benefits of head office or other personnel, as are indicated below, for that portion of their time spent on the Project;

Ted Forbes, Bonnie Goulet, Will Henderson, John MacDonald, Shannon Taylor and other personnel who may be added from time to time as workload requires.

- (c) contributions, assessments or taxes incurred during the performance of the Contract for such items as unemployment insurance, workers' compensation, Canada or Quebec Pension Plan and the Construction Manager's employee benefit plan, insofar as such costs are based on wages, salaries or other remuneration paid to employees of the Construction Manager and included under paragraphs (a) and (b) above;
- (d) the portion of travel and subsistence expenses of the Construction Manager or his officers or employees incurred while travelling in discharge of duties connected with the Project;
- (e) the cost of all materials, products, supplies and equipment incorporated into the Work, including costs of transportation and storage thereof;
- (f) the cost of materials, products, supplies, equipment, temporary services, utilities and facilities, and hand tools not owned by the workers including transportation and maintenance thereof, which are consumed in the performance of the Contract, and cost less salvage value on such items used, but not consumed, which remain the property of the Construction Manager;
- (g) rental costs of all tools, machinery and equipment used in the performance of the Contract, whether rented from the Construction Manager or others, including installation, minor repairs and replacements, dismantling, removal, transportation and delivery costs thereof;
- (h) deposits lost;
- (i) the amount of all subcontracts;
- (j) the costs to the Construction Manager that result from any Trade Contractor's insolvency or failure to perform;
- (k) the cost of quality assurance such as independent inspection and testing services;

- (l) charges levied by authorities having jurisdiction at the Place of the Project;
- (m) royalties, patent licence fees, and damages for infringement of patents and costs of defending suits therefore subject always to the Construction Manager's obligation to indemnify the Owner pursuant to paragraph 13.1 of GC 13-PATENT FEES;
- (n) premiums for all bonds and insurances which the Construction Manager is required, by the Contract Documents, to purchase and maintain;
- (o) taxes and duties related to the Project for which the Construction Manager is liable other than tax on income payable by the Construction Manager;
- (p) losses and expenses sustained by the Construction Manager for matters which are the subject of the insurance coverages obtained pursuant to GC 17-INSURANCE when such losses and expenses are not recoverable because the amounts are in excess of collectible amounts, within the deductible amounts or are not insurable;
- (q) charges for telegrams, telexes, site telephones, courier services, expressage, and petty cash items;
- (r) the cost of removal and disposal of waste products and debris;
- (s) costs incurred due to emergencies affecting the safety of persons or property;
- (t) legal costs, incurred by the Construction Manager, arising out of the performance of the Contract;
- (u) costs incurred by the Construction Manager, with the Owner's permission, in expediting the rejected work or the warranty work of Trade Contractors and costs incurred by the Construction Manager in correcting defects or deficiencies in the work undertaken by his own forces and repairing damages resulting therefrom either during the course of construction or the warranty period except those arising from a negligent or wilful act of the Construction Manager;
- (v) the cost of financing the Project in accordance with the method determined by the parties;
- (w) the cost of auditing when requested by the Owner;
- (x) the cost of computer time and usage in accordance with the method determined by the parties;
- (y) such other costs directly incurred by the Construction Manager in the performance of the Contract including the following:

All costs directly and indirectly attributable to The Work to maximum amounts as follows:

For Longview, including Off Site Servicing, On Site Servicing, Landscaping and Building Construction Cost of the Work shall not exceed \$64,389,736.00 in Canadian Funds.

For Paignton House, including Off Site Servicing, On Site Servicing, Landscaping and Building Construction Cost of the Work shall not exceed \$13,326,272.00 in Canadian Funds.

It is the intention of the parties that the items referred to herein shall cover and include any and all costs and contingencies incurred by the Construction Manager in connection with the Project.

DEFINITIONS

The following Definitions shall apply to all Contract Documents.

1. The Contract

The Contract Documents form the Contract. The Contract is the undertaking by the parties to perform their respective duties, responsibilities and obligations as prescribed in the Contract Documents and represents the entire agreement between the parties.

2. Contract Documents

The Contract Documents consist of the executed Agreement between the Owner and the Construction Manager, the General Conditions of the Contract, Supplementary Conditions, Definitions, specifications, drawings and such other documents as are listed in ARTICLE A-4 - SCOPE OF THE PROJECT including amendments thereto incorporated before the execution of the Contract and subsequent amendments thereto made pursuant to the provisions of the Contract and agreed upon between the parties.

3. Owner

The Owner is the person, firm or corporation identified as such in the Agreement and is referred to throughout the Contract Documents as if singular in number and masculine in gender. The term Owner means the Owner or his authorized agent or representative as designated to the Construction Manager in writing.

4. Consultant

The Consultant is the person, firm or corporation identified as such in the Agreement, and is an architect or engineer licensed to practice in the province or territory of the Place of the Project, and is referred to throughout the Contract Documents as if singular in number and masculine in gender.

5. Construction Manager

The Construction Manager is the person, firm or corporation identified as such in the Agreement and is referred to throughout the Contract Documents as if singular in number and masculine in gender. The term Construction Manager means the Construction Manager or his authorized representative as designated to the Owner in writing.

6. Trade Contractor

A Trade Contractor is a person, firm or corporation having a direct contract with the Owner to perform the Work. The term Trade Contractor is referred to throughout the Contract Documents as if singular in number and masculine in gender.

7. The Project

The Project means the total construction and related services to be managed under this Contract of which the Work is a part.

8. The Work

The Work means that portion of the Project performed by a Trade Contractor or by the Construction Manager directly using own forces.

9. Place of the Project

The Place of the Project is the designated site or location of the Project.

10. Time

The Contract Time is the time stipulated in paragraph (a) of ARTICLE A-2.

Day means calendar day.

Working day means days other than Saturdays, Sundays and holidays which are observed by the construction industry in the area of the Place of the Project.

11. Substantial Performance of the Project

Substantial Performance of the Project is the date when the total construction contemplated by the Project is sufficiently complete in accordance with the Contract Documents.

12. Total Performance of the Project

Total Performance of the Project is the date when the total construction and related services contemplated by the Project have been performed to the requirements of the Contract Documents.

13. Changes in the Project

Changes in the Project means additions, deletions, or other revisions to the Project within the general scope of the Contract.

THE GENERAL CONDITIONS OF THE CONSTRUCTION MANAGEMENT CONTRACT

(Hereinafter referred to as the General Conditions)

GC 1 DOCUMENTS

- 1.1 The Contract Documents shall be signed in duplicate by the Owner and the Construction Manager.
- 1.2 The Contract Documents are complementary, and what is required by any one shall be as binding as if required by all.

GC 2 CONSTRUCTION MANAGER'S SERVICES

- 2.1 The Construction Manager will perform the following services in each of the three phases described below but in doing so, he assumes no responsibility nor offers any expertise with respect to the design of the Project including any and all architectural or engineering aspects which shall be the responsibility of the Consultant and Owner.

2.2 PRE-CONSTRUCTION PHASE

2.2.1 *Consultation During Project Development:*

Attend regular meetings with the Construction Management Team during the development of conceptual and preliminary design and preparation of working drawings to advise on site use and improvements, selection of materials, building systems and equipment. Provide recommendations on construction feasibility, availability of materials and labour, time requirements for installation and construction, and factors related to cost including costs of alternative designs or materials, preliminary budgets, and possible economies.

2.2.1.1 Acquaint the Owner and other members of the Construction Management Team with the labour conditions applicable for the duration of the Project.

2.2.1.2 Assist in providing liaison and co-ordination among government authorities, utility companies, and other authorities having jurisdiction over the Place of the Project.

2.2.2 *Planning and Scheduling:*

Prepare, for the Owner's review, a preliminary master time schedule, following consultation with the Construction Management Team, incorporating the sequence and timing of the required basic program decisions, including design time, documentation, bid calls, bid evaluations, trade contract awards and on-site construction activities.

2.2.2.1 Monitor and, if required, revise and update the preliminary schedule as the design proceeds.

2.2.2.2 Finalize the master time schedule for the Owner's approval, and, if necessary, estimate the manpower requirements. Break down this schedule into individual networks for each phase of the Project where necessary showing the sequence and timing for the main construction operations and the milestone completion operations and the milestone completion dates for the various phases.

2.2.2.3 Recommend any equipment or materials which should be pre-ordered to meet the master time schedule

2.2.3 *Project Construction Budget:*

Prepare a Project budget as soon as major Project requirements have been identified, and update periodically for the Owner's approval.

2.2.3.1 Prepare an estimate based on a quantity survey of drawings and specifications at the end of the schematic design phase for approval by the Construction Management Team as the "Project Construction Budget".

2.2.3.2 Update and refine this estimate for the Owner's approval as the development of the drawings and specifications proceeds, and advise the Construction Management Team if it appears that the Project Construction Budget will not be met and make recommendations for corrective action.

2.2.3.3 Evaluate possible alternatives as the design proceeds, in order to permit the selection of the most economical materials and methods that will satisfy the design concept, and the schedule.

2.2.3.4 Establish a cost control program and prepare a projected cash flow for the Project.

2.2.4 *Coordination of Trade Contract Documents:*

Review the drawings and specifications as they are being prepared, recommending alternative solutions whenever design details affect construction feasibility or schedules.

2.2.4.1 Make recommendations to the Owner and the Consultant regarding the division of Work in the drawings and specifications to help facilitate the bidding and awarding of trade contracts, allowing for phased construction, taking into consideration such factors as time of performance, availability of labour, overlapping trade jurisdictions, and provisions for temporary facilities.

2.2.5 *Construction Planning:*

Plan and arrange for supply of temporary services and site facilities including but not limited to office accommodation and supplies, site hoardings, access, storage areas, temporary power and lighting, temporary enclosures, heating, drainage and water facilities, job offices, job security, materials and personnel hoisting facilities and equipment, safety measures, access stairs and ladders, protection of finishes and continuous cleanup.

2.2.5.1 Review with the Consultant the drawings and specifications to eliminate areas of conflict and overlapping in the Work to be performed by the various Trade Contractors.

2.2.5.2 Review with the Construction Management Team the construction insurance needs for the Project.

2.2.5.3 Make recommendations to the Construction Management Team with respect to the bonding of Trade Contractors.

2.2.5.4 Assemble all bid documents for the solicitation of competitive bids for Work to be performed by Trade Contractors. Arrange for the advertising of such bid calls and prepare the necessary prequalification criteria.

2.2.5.5 Analyze the bids received and recommend awards to the Owner. Once awards are approved by the Owner, prepare the trade contracts for execution.

2.2.5.6 Assemble the trade contract documents for all successful Trade Contractors. Check where required that all bonds, insurance policies, and workers' compensation certificates are provided.

- 2.2.5.7 Assist the Construction Management Team in obtaining all approvals, permits, and licenses required for the Project.
- 2.2.5.8 Assist the Owner to arrange for legal surveys of the Project. The Construction Manager shall be responsible for the maintenance of base lines and levels but Trade Contractors shall be responsible for detailed setting out of their work.

2.3 CONSTRUCTION PHASE

2.3.1 *Project Control:*

Monitor the Work of the Trade Contractors and coordinate the Work with the activities and responsibilities of the Owner, Consultant and Construction Manager.

- 2.3.1.1 Maintain a competent full-time staff at the Place of the Project to coordinate and provide general direction of the Project and progress of the Trade Contractors on the Project.
- 2.3.1.2 Establish on-site organization and lines of authority in order to carry out the overall plans of the Construction Management Team.
- 2.3.1.3 Establish procedures for coordination among the Owner, Consultant, Trade Contractors and Construction Manager with respect to all aspects of the Project and implement such procedures.
- 2.3.1.4 Schedule and conduct progress meetings at which Trade Contractors, Owner, Consultant and Construction Manager can discuss jointly such matters as procedures, progress, problems and scheduling.
- 2.3.1.5 Provide regular monitoring of the schedule as construction progresses. Identify potential variances between scheduled and probable completion dates. Review schedule for work not started or incomplete and recommend to the Owner and Trade Contractors adjustments in the schedule to meet the probable completion date. Provide summary reports of each monitoring and document all changes in schedule. Revise the schedule as required by GC 5-DELAYS and GC 9-CHANGES IN THE PROJECT.
- 2.3.1.6 Review the adequacy of the Trade Contractors' personnel and equipment and the availability of materials and supplies to meet the schedule. Recommend courses of action to the Owner when requirements of a trade contract are not being met.

2.3.2 *Physical Construction:*

Provide all of the construction facilities and services common to the requirements of all Trade Contractors, both temporary and permanent, as are planned and called for in Item 2.2.5 above. Ensure that all bidders are informed of the facilities and services being provided.

- 2.3.2.1 Advise the Owner of work which should best be done by the Construction Manager. Where the Owner approves of work to be done by the Construction Manager, such work shall be performed in accordance with the Contract Documents and, unless otherwise agreed, paid for by the Owner pursuant to ARTICLE A-7 OWN FORCES WORK.
- 2.3.2.2 Provide advice and assistance on labour problems in order to minimize work stoppages and in the settlement of jurisdictional or other labour disputes.

2.3.3 *Cost Control and Accounting:*

Develop, implement and maintain an effective system of Project cost control. Revise and refine the initially approved Project Construction Budget, incorporate approved changes as they occur, and develop cash flow reports and forecasts as needed. Identify variances between actual and budgeted or estimated costs and advise Owner and Consultant whenever projected cost exceeds budgets or estimates.

2.3.3.1 Maintain accounting records and afford the Owner access to these records.

2.3.3.2 Provide for and administer the necessary procedures to permit recovery of all tax rebates where applicable.

2.3.3.3 If requested, assist the Construction Management Team in implementing changes necessary to bring the projected costs within budgets or estimates.

2.3.4 *Changes in the Work:*

Develop and implement a system for the preparation, review and processing of Changes in the Work. Recommend necessary or desirable Changes in the Work to the Construction Management Team, review requests for Changes in the Work, submit recommendations to the Construction Management Team and assist in their negotiation.

2.3.5 *Payments to Trade Contractors:*

Develop and implement a procedure for the review, certification, processing and payment of applications by Trade Contractors for progress and final payments.

2.3.5.1 Expedite the processing of Trade Contractors' invoices.

2.3.6 *Other Consultants:*

Assist the Owner in selecting and retaining the professional services of a surveyor, testing laboratories, geotechnical and other specialists and coordinate these services, without assuming any responsibility or liability of or for these consultants or their work.

2.3.7 *Inspection:*

Periodically inspect the Work of Trade Contractors for defects and deficiencies in the Work without assuming any of the Consultant's responsibilities for inspection. Inspection by the Construction Manager shall not relieve the Trade Contractor from their responsibility for nor make the Construction Manager responsible for construction means, methods, techniques, sequences and procedures, nor for their responsibility to carry out the Work in accordance with their contracts.

2.3.7.1 Review the safety programs of each of the Trade Contractors and make appropriate recommendations. In making such recommendations and carrying out such reviews, the Construction Manager shall not be required to make exhaustive or continuous inspections to check safety precautions and programs in connection with the Project. The performance of such services by the Construction Manager shall not relieve the Trade Contractors of their responsibilities for the safety of persons and property, and for compliance with the federal, provincial and local statutes, rules, regulations and orders applicable to the conduct of the Work.

2.3.8 *Document Interpretation:*

Refer all questions for interpretation of the documents prepared by the Consultant to the Consultant.

2.3.9 *Shop Drawings and Samples:*

With the Consultant, establish and implement procedures for expediting the receipt, processing and review of shop drawings and samples.

2.3.10 Reports and Project Site Documents:

Submit written progress reports to the Owner and the Consultant including budget and scheduling information. Keep a daily log available to the Owner and the Consultants.

2.3.10.1 Maintain at the Place of the Project, on a current basis, records of all necessary contracts, drawings, samples, purchases, materials, equipment, maintenance and operating manuals and instructions, and other construction related documents, including all revisions. Obtain data from Trade Contractors and maintain a current set of Project record documents and operating manuals. At the completion of the Project, deliver all such records to the Owner.

2.3.11 Substantial Performance of the Work:

Subject to applicable legislation arrange with the Consultant for the issuance of the necessary certificates respecting substantial performance of the Work or designated portions thereof and prepare with the Consultant a list of incomplete or unsatisfactory items and a schedule for their completion.

2.3.11.1 Distribute substantial performance and total performance certificates.

2.3.12 Start-Up:

With the Owner's maintenance personnel and the Consultant, direct the check-out of utilities, operations systems and equipment for readiness and assist in their initial start-up and testing by the Trade Contractors.

2.3.13 Total Performance of the Work:

Arrange with the Consultant for the certification of total performance and provide written notice to the Owner and Consultant that the Work is ready for final inspection. Seek and transmit to the Consultant as received warranties, affidavits, releases, bonds, waivers, manuals and record drawings. Turn over to the Owner all keys and maintenance stocks.

2.4 POST-CONSTRUCTION PHASE

2.4.1 Operations:

Maintain a close relationship with the Owner's operating staff to ensure a smooth and proper takeover of the Project.

2.4.2 Warranties:

Assist the Owner in administering warranties of the Trade Contractors.

2.5 ADDITIONAL SERVICES

At the request of the Owner, the Construction Manager will provide the following additional services upon written agreement between the Owner and Construction Manager defining the extent of such additional services and the amount and manner in which the Construction Manager will be compensated for additional services.

2.5.1 Services related to investigation, appraisals or valuations of existing conditions, facilities or equipment, or verifying the accuracy of existing drawings or other Owner-furnished information.

2.5.2 Services related to Owner-furnished equipment, furniture and furnishings which are not a part of this Contract.

2.5.3 Services for tenant or rental spaces not a part of this Contract.

2.5.4 Obtaining or training maintenance personnel or negotiating maintenance service contracts.

2.5.5 Services related to the resolution of claims, adjudication of disputes or litigation.

2.5.6 Other:

Not Used.

GC 3 TRADE CONTRACTORS

3.1 The Construction Manager will, in accordance with the direction of the Owner, arrange for contracts to be entered into between the various Trade Contractors and the Owner.

3.2 The terms and conditions of all trade contracts, including any amendments thereto, shall be subject to the approval of the Construction Manager.

GC 4 OWNER'S RESPONSIBILITY

4.1 The Owner shall provide full and timely information regarding his requirements for the Project.

4.2 The Owner shall designate in writing a representative who shall be fully acquainted with the Project and shall have the authority to act on the Owner's behalf in relation to all duties and responsibilities of the Owner under this Contract including the authority to issue and approve the Project Construction Budget and Changes in the Project and who shall furnish information expeditiously and tender decisions promptly. The Construction Manager shall in all respects be entitled to rely upon such designated representative as having full and complete authority in all matters.

4.3 The Owner shall retain a Consultant who shall be responsible for the design and design-related services required for the Project. The duties, responsibilities and services to be provided by the Consultant shall be described in the agreement between the Owner and the Consultant, a copy of which shall be furnished to the Construction Manager. The agreement between the Owner and the Consultant shall not be modified without written notification to the Construction Manager.

4.4 The Owner shall furnish promptly to the Construction Manager all necessary information regarding the Place of the Project including surveys as to the physical characteristics of the site, soils reports and subsurface investigations, legal limitations, utility locations and legal description. The Construction Manager shall have no responsibility or liability with respect to these matters including their suitability or non-suitability to the Project and shall be entitled to rely entirely upon the completeness and accuracy thereof.

4.5 The Owner shall arrange to secure and pay for all necessary approvals, permits, easements, assessments and charges required for the construction, use or occupancy of permanent structures or permanent changes in existing facilities.

4.6 The Owner shall furnish such legal and auditing services as are required for the performance of the Contract.

4.7 The Owner shall provide, maintain and pay for the insurance coverages outlined in GC 17-INSURANCE.

- 4.8 The Owner shall promptly notify the Construction Manager in writing of any defective, faulty or nonconforming work of which he becomes aware.
- 4.9 The Owner shall provide for the payment of all Trade Contractors in accordance with the terms and conditions of his agreements with such Trade Contractors and in conformity with the payment certificates issued by the Consultant.
- 4.10 The Owner and the Consultant shall communicate with the Trade Contractors solely through the Construction Manager.
- 4.11 The Owner shall ensure that adequate financing is available in order to ensure the completion of the Project

GC 5 DELAYS

- 5.1 If the Construction Manager is delayed at any time in the progress of the Project by any act or omission of the Owner or the Consultant or anyone engaged by them directly or indirectly, then the Contract Time shall be extended by a reasonable period of time and the Contract Fee shall be adjusted by a reasonable amount.
- 5.2 If the Construction Manager is delayed at any time in the progress of the Project by a stop work order issued by a court or other public authority and, providing that such order was not issued as the result of an act or fault of the Construction Manager or anyone employed or engaged by him directly or indirectly, then the Contract Time shall be extended by a reasonable period of time and the Contract Fee shall be adjusted by a reasonable amount.
- 5.3 If the Construction Manager is delayed in the progress of the Project by labour disputes, strikes, lock-outs, fire, unusual delay in transportation, adverse weather conditions not reasonably foreseeable, unavoidable casualties or, without limit to the foregoing, any cause beyond the Construction Manager's control, then the Contract Time shall be extended by a reasonable period of time and the Contract Fee shall be adjusted accordingly.
- 5.4 No extension of the Contract Time nor adjustment to the Contract Fee shall be made for delay unless written notice of claim is given to the Owner within thirty (30) days after the occurrence of the event giving rise to the delay.
- 5.5 Where the Owner and Construction Manager are unable to agree upon the appropriate adjustment to be made to the Contract Time or Contract Fee, such adjustment shall be determined in accordance with GC 11-DISPUTES.

GC 6 OWNER'S RIGHT TO PERFORM CONTRACT OR TO TERMINATE CONTRACT

- 6.1 If the Construction Manager should be adjudged bankrupt, or makes a general assignment for the benefit of creditors because of his insolvency, or if a receiver is appointed because of his insolvency, the Owner may, without prejudice to any other right or remedy he may have, by giving the Construction Manager or receiver or trustee in bankruptcy written notice, terminate the Contract.
- 6.2 If the Construction Manager should neglect to provide the services required by the Contract to a substantial degree, the Owner may notify the Construction Manager in writing that he is in default of his contractual obligations and instruct him to correct the default within seven (7) working days immediately following the receipt of such notice.

- 6.3** If the correction of the default cannot be completed in the seven (7) working days specified, the Construction Manager shall be in compliance with the Owner's instructions if he:
- (a) commences the correction of the default within the specified time and,
 - (b) provides the Owner with an acceptable schedule for such correction, and
 - (c) completes the correction in accordance with such schedule.
- 6.4** If the Construction Manager fails to correct the default in the time specified or subsequently agreed upon, the Owner, without prejudice to any other right or remedy he may have, may:
- (a) correct such default and deduct the cost thereof from any payment of fee then or thereafter due the Construction Manager, or
 - (b) terminate the Construction Manager's right to perform the Contract in whole or in part or terminate the Contract.
- 6.5** If the Owner terminates the Construction Manager's right to perform the Contract, he shall:
- (a) be entitled to take possession of the premises and all materials, equipment, tools, construction equipment and machinery owned by the Construction Manager and finish the Project by whatever method he may consider expedient, and
 - (b) pay to the Construction Manager those further amounts to which he is entitled in accordance with ARTICLE A-6 REIMBURSIBLE EXPENSES and ARTICLE A-7 OWN FORCES WORK plus the proportionate amount of the Contract Fee earned to the date of termination, and
 - (c) pay to the Construction Manager fair compensation, either by purchase or rental, at the option of the Owner, for any construction tools or machinery and equipment retained for use on the Project, and
 - (d) assume and become liable for all obligations, commitments and unliquidated claims that the Construction Manager may have therefore, in good faith, undertaken or incurred in connection with the said Project.

The Construction Manager shall, as a condition of receiving the payments described, execute and deliver all such papers and take such action, including the legal assignment of his contractual rights, as the Owner may require for the purpose of fully vesting in himself the rights and benefits of the Construction Manager under the obligations or commitments to be assumed by the Owner.

- 6.6** After the completion of the Pre-Construction Phase, if the final cost estimates make the Project no longer feasible from the standpoint of the Owner, the Owner may terminate the Contract and shall pay the Construction Manager his fee in accordance with ARTICLE A-5 CONTRACT FEE plus any Reimbursible Expenses incurred pursuant to ARTICLE A-6 REIMBURSIBLE EXPENSES or ARTICLE A-7 OWN FORCES WORK.

GC 7 SUSPENSION ABANDONMENT OR TERMINATION BY OWNER WITHOUT CAUSE

- 7.1** Should the Project be suspended, abandoned or terminated at any time prior to its completion by the Owner, the Construction Manager shall be entitled to be paid in addition to the fee computed in accordance with ARTICLE A-5 CONTRACT FEE and those further amounts recoverable under ARTICLE A-6 REIMBURSIBLE EXPENSES and ARTICLE A-7 OWN FORCES WORK, a sum in compensation for the loss of income experienced by the Construction Manager as a result of the premature termination of this Agreement calculated as follows:
- (a) Zero (0%) per cent of the Contract Fee if the suspension, abandonment or termination occurs during the Pre-Construction Phase;
 - (b) Zero (0%) per cent of the Contract Fee if the suspension, abandonment or termination occurs during the Construction Phase;
 - (c) Zero (0%) per cent of the Contract Fee if the suspension, abandonment or termination occurs during the Post-Construction Phase.

- 7.2 Suspension shall be deemed to have occurred should work on the Project have been stopped at the Owner's request and should such stoppage or stoppages have continued individually or collectively for a period of sixty (60) days.

GC 8 CONSTRUCTION MANAGER'S RIGHT TO TERMINATE CONTRACT

- 8.1 If the Owner should be adjudged bankrupt or makes a general assignment for the benefit of creditors because of his insolvency or if a receiver is appointed because of his insolvency, the Construction Manager may, without prejudice to any other right or remedy he may have, by giving the Owner or receiver or trustee in bankruptcy written notice, terminate the Contract.
- 8.2 If the Project or a substantial part thereof should be stopped or otherwise delayed for a period of thirty (30) days or more under an order of a court or other public authority having jurisdiction and providing that such order was not issued as the result of an act or fault of the Construction Manager, the Construction Manager may, without prejudice to any other right or remedy he may have, by giving the Owner written notice, terminate the Contract.
- 8.3 Should the Owner suspend the Project for a period of sixty (60) days as contemplated by GC 7-SUSPENSION ABANDONMENT OR TERMINATION BY OWNER WITHOUT CAUSE, and the Owner has not instructed the Construction Manager to resume the Project within five (5) working days after the Construction Manager gives the Owner written notice of his intention to resume the Project, and providing such suspension was not due to the default of the Construction Manager, then the Construction Manager may, without prejudice to any other rights or remedies he may have, by giving the Owner written notice, terminate the Contract.
- 8.4 The Construction Manager may notify the Owner in writing that the Owner is in default of his contractual obligations if:
- (a) the Owner fails to pay the Construction Manager when due those amounts which are due and payable in accordance with the Contract or an award by arbitration or court, or
 - (b) the Owner violates the requirements of the Contract to a substantial degree.

The Construction Manager's written notice to the Owner shall advise that if the default is not corrected in the seven (7) working days immediately following the receipt of the written notice the Construction Manager may, without prejudice to any other right or remedy he may have, terminate the Contract.

- 8.5 If the Construction Manager terminates the Contract as herein set out, he shall be paid forthwith all sums to which he is entitled pursuant to paragraph 7.1 of GC 7-SUSPENSION, ABANDONMENT OR TERMINATION BY OWNER WITHOUT CAUSE.

GC 9 CHANGES IN THE PROJECT

- 9.1 Should the Owner during the Pre-Construction Phase require a significant revision in the design concept then developed, the Contract-Fee and the Contract Time shall be subject to an appropriate adjustment. Any additional fee to which the Construction Manager is entitled shall be such sum as having regard to the total fee payable by this Contract for the Pre-Construction Phase represents the amount of the services provided by the Construction Manager which must be duplicated by such change. The Contract Time and the date for Substantial Performance of the Project shall each be extended to reflect such additional time as may reasonably be required having regard to all circumstances as a result of the change required by the Owner.

- 9.2 Should the Owner or his Consultant make changes in all or any portion of the work during the course of the Construction Phase and should such changes singly or collectively have the effect of extending the Contract Time or the date of Substantial Performance or Total Performance of the Project, the Construction Manager shall be entitled to payment of an additional fee having regard to that portion of the fee allocated to the Construction Phase of the Agreement as reflects the additional time for which the Construction Manager is required to be engaged on the Project.
- 9.3 The Construction Manager shall advise the Owner promptly when he determines that changes as herein contemplated will delay the date of Substantial Performance of the Project, extend the Contract Time, and entitle the Construction Manager to payment of an additional fee.
- 9.4 If the Owner and Construction Manager cannot agree on the change in Contract Time and Contract Fee, the matter shall be determined in accordance with the provisions of GC 11-DISPUTES.

GC 10 APPLICATIONS FOR PAYMENT

- 10.1 The Construction Manager shall submit to the Owner on a monthly basis an application for payment covering all Reimbursible Expenses incurred during the previous period pursuant to ARTICLE A-6 REIMBURSIBLE EXPENSES and the amount of the Contract Fee then due as provided in ARTICLE A-5 CONTRACT FEE and for work performed directly by the Construction Manager pursuant to ARTICLE A-7 OWN FORCES WORK.
- 10.2 (a) The Pre-Construction Phase portion of the Contract Fee shall be payable monthly as set out in ARTICLE A-5 CONTRACT FEE. The balance of the Pre-Construction Phase fee, if any, shall be paid at the commencement of construction.
- (b) Prior to commencement of construction, the Construction Manager shall, in accordance with sub-paragraph 2.2.2.2 of GC-2 CONSTRUCTION MANAGER'S SERVICES, provide a schedule showing the time required to achieve Substantial Performance of the Project. That portion of the fee payable for the Construction Phase shall be payable in equal monthly installments determined by dividing the Construction Phase portion of the fee by the number of months scheduled from commencement of construction to achievement of Substantial Performance of the Project. Upon certification of Substantial Performance of the Project, the balance, if any, of the Construction Phase fee shall become due and payable.
- (c) Should the state of completion of the Project at any time during the Construction Phase be delayed through no fault of the Owner or his Consultant, then the amount payable by the Owner each month shall be such that the total of all sums paid in monthly installments on account of the Construction Phase fee to the Construction Manager to date of payment when related to the total Construction Phase fee as a percentage reflects the degree of completion of the construction of the Project at the date of that payment. Thereafter the amount of the fee payable monthly shall be adjusted either up or down so as to ensure that the total fees paid to the Construction Manager monthly when related to the total fee payable under this Contract for the Construction Phase is equal to the degree of completion of construction of the Project. In any event the Construction Manager shall be entitled to payment in full of his Construction Phase fee upon certification of Substantial Performance of the Project.
- (d) The fee for the Post-Construction Phase shall be paid in equal monthly installments in accordance with ARTICLE A-5 CONTRACT FEE commencing the end of the first month following Substantial Performance of the Project with the balance paid at Total Performance of the Project.
- 10.3 The Owner shall make payment to the Construction Manager on account in accordance with the provisions of ARTICLE A-8 PAYMENT no later than fifteen (15) days following the date of receipt of an application for payment.

GC 11 DISPUTES

- 11.1 Differences between the parties to the Contract as to the interpretation, application or administration of this Contract or any failure to agree where agreement between the parties is called for, herein collectively called disputes, shall be settled in accordance with the requirements of this General Condition.
- 11.2 If the parties so agree the dispute shall be submitted to arbitration in accordance with the provisions of the arbitration legislation of the Place of the Project.
- 11.3 If no agreement is made for arbitration then either party may submit the dispute to such judicial tribunal as the circumstances may require.

GC 12 ASSIGNMENT

- 12.1 Neither party to the Contract shall assign the Contract or a portion thereof without the written consent of the other, which consent shall not be unreasonably withheld.

GC13 PATENT FEES

- 13.1 The Construction Manager shall hold the Owner harmless from and against claims, demands, losses, costs, damages, actions, suits or proceedings arising out of the Construction Manager's performance of the Contract which are attributable to an infringement or an alleged infringement of a patent or invention by the Construction Manager or anyone for whose acts he may be liable.
- 13.2 The Owner shall hold the Construction Manager harmless against, claims, demands, losses, costs, damages, actions, suits or proceedings arising out of the Construction Manager's performance of the Contract which are attributable to an infringement or an alleged infringement of a patent or invention in executing anything for the purpose of the Contract, the model, plan or design of which was supplied to the Construction Manager for the performance of the Contract.

GC 14 WAIVER

- 14.1 As of the date of Total Performance of the Project, the Owner expressly waives and releases the Construction Manager from all claims against the Construction Manager including without limitation those that might arise from the negligence or breach of contract by the Construction Manager except one or more of the following:
- (a) those made in writing prior to Total Performance of the Project and still unsettled;
 - (b) those arising from the provisions of GC 16 -INDEMNIFICATION BY CONSTRUCTION MANAGER;
 - (c) those made in writing within a period of one (1) year from the date of Substantial Performance of the Project and arising from any liability of the Construction Manager for damages resulting from the performance of this Contract with respect to substantial defects or deficiencies in the Project for which the Construction Manager is proven responsible.

As used herein 'substantial defects or deficiencies' means those defects or deficiencies in the Project which affect the Project to such an extent or in such a manner that a significant part or the whole of the Project is unfit for the purposes intended.

- 14.2** As of the date of Total Performance of the Project, the Construction Manager expressly waives and releases the Owner from all claims against the Owner including without limitation those that might arise from the negligence or breach of contract by the Owner except:
- (a) those made in writing prior to the date of Total Performance of the Project;
 - (b) those arising from the provisions of GC 15-INDEMNIFICATION BY THE OWNER.

GC 15 INDEMNIFICATION BY THE OWNER

- 15.1** The Owner shall indemnify and hold harmless the Construction Manager, his agents and employees, from and against all claims, demands, losses, costs, damages, actions, suits or proceedings by third parties, including all legal fees, costs and expenses incurred in defending such claims, that arise out of or are attributable to the performance of the Contract except any proportion thereof which is attributable to acts or omissions of the Construction Manager, his agents or employees, which constitute a breach of this Contract and for which the Construction Manager is liable under the terms of this Contract.
- 15.2** The Owner shall indemnify and hold harmless the Construction Manager, his agents and employees, from and against all claims, demands, losses, costs, damages, actions, suits or proceedings arising out of the performance of the Contract which are:
- (a) attributable to a lack of or defect in title or an alleged lack of or defect in title to the Place of the Project; or
 - (b) attributable to the negligence of or a breach of contract by the Consultant or Owner; or
 - (c) attributable to the negligence or breach of contract by any Trade Contractor.

GC 16 INDEMNIFICATION BY CONSTRUCTION MANAGER

- 16.1** The Construction Manager shall indemnify and hold harmless the Owner, his agents and employees, from and against claims, demands, losses, costs, damages, actions, suits or proceedings by third parties that arise out of, or are attributable to, the Construction Manager's performance of the Contract (hereinafter the called 'claims'), provided such claims are:
- (a) attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property; and
 - (b) caused by negligent acts or omissions of the Construction Manager or those directly employed or engaged by the Construction Manager;
 - (c) made in writing within a period of one (1) year from the date of Substantial Performance of the Project.

The Owner expressly waives the right to indemnity for claims other than those stated above.

- 16.2** The obligation of the Construction Manager to indemnify hereunder shall be limited to the dollar amounts which are recoverable under the insurance coverages maintained pursuant to GC 17-INSURANCE.

GC 17 INSURANCE

- 17.1** The Owner undertakes and agrees at his cost to maintain insurance insuring the interest of and indemnifying the Construction Manager against any liability which he might incur as a result of damage to or injury sustained to any portion of the Project. The Owner agrees that the Construction Manager may place the liability portion of such insurance with the insurer of his choice providing the premiums are competitive or to maintain continuity in regard to completed operations coverage.

We represent Alvarez & Marsal Canada ULC and McIntosh & Morawetz Inc., jointly as receiver and manager and trustee and interim receiver of RRDI (in such capacities, jointly, the "Receiver") pursuant to Section 47(1) of the *Bankruptcy and Insolvency Act* (Canada), Section 101 of the *Courts of Justice Act* (Ontario) and Section 68 of the *Construction Lien Act* (Ontario) (the "CLA") and orders of the Honourable Madam Justice Pepall dated May 22, 2009 and June 2, 2009 (collectively, the "Appointment Order").

The Receiver has requested that we provide you with the information below in response to your request.

DISCLAIMER

In providing this information, the Receiver has relied on unaudited financial information prepared by RRDI's management, its consultants and advisors, RRDI's books and records and discussions with its management. Neither the Receiver nor any of its advisors have performed an independent audit or other verification of such information. Neither the Receiver nor any of its advisors, including its legal counsel Fraser Milner Casgrain LLP and Blake Cassels & Graydon LLP, express any opinion or other form of assurance with respect to the accuracy of any financial information presented herein, or relied upon in preparing this letter and the schedules hereto. As well, the lenders to RRDI have not confirmed the accuracy of the information contained herein and this response is without prejudice to the positions of the lenders. All references to dollar figures contained herein are in Canadian currency unless otherwise specified.

STATE OF ACCOUNTS AS BETWEEN WEST LB AND RRDI

West LB is the chargee under a building mortgage registered as Instrument No. MT29969 on March 6, 2007 in the principal amount of \$125,000,000¹. West LB advanced the aggregate sum of \$89,463,939.37 to RRDI plus costs and expenses which are estimated to be in excess of \$914,945.00. See attached Schedule "A" for the details of each advance by West LB to RRDI. Note that of the aggregate sum advanced by West LB, the net sum of \$74,167,831 was advanced for the purpose of financing construction improvements.

CONSTRUCTION MANAGEMENT AGREEMENT

Under a construction management agreement made between The Rosseau Resort Developments Inc. ("RRDI"), as Owner of the subject lands developed as The Rosseau, A JW Marriott Resort & Spa, including Longview and Paignton House (the "Project") to which the improvements were made and Rock Ridge Contractors Inc. ("RRCI") as Construction Manager, dated April 1, 2005 (the "CMA"), RRCI agreed to provide construction management services to RRDI in relation to completion by trade contractors of construction of the improvements. The contract price payable under the CMA to RRCI was \$1.00. According to the records of RRDI, all trade contracts were made directly with the Owner, through RRCI in its capacity as agent and Construction Manager for the Owner.

STATE OF ACCOUNTS AS BETWEEN RRDI AND RRCI

According to the records of RRDI:

- (a) the aggregate gross cost to date as invoiced to RRDI by RRCI as at May 22, 2009 is \$80,810,436.
- (b) the aggregate sum of \$72,085,500 was released from RRDI through RRCI for payment to trade contractors, based on requests for progress and/or final payments submitted to RRDI through RRCI.
- (c) the sum of \$7,478,404 represents the aggregate holdback values of all trade contracts based on the construction costs reporting as of May 22, 2009, of which \$4,139,663 has been released for payment to the trade contractors and the sum of \$3,338,741 remains outstanding. There are \$NIL holdback funds currently set aside and held in a separate trust account.
- (d) To the best of the Receiver's knowledge, no labour and material payment bonds were posted by RRCI or any trade contractors.

SUBSTANTIAL PERFORMANCE/COMPLETION OF CONTRACTS/OCCUPANCY

The list of published certificates of substantial performance for the Project was included with our letter of June 18, 2009, and is attached hereto as Schedule "B" for reference. Occupancy permits


were issued for the condominium units and the Hotel generally as per the list attached as Schedule "C".

SALE OF CONDOMINIUM UNITS

Of the total resort condominium units in the Project, there are 137 condominium resort units under existing agreements of purchase and sale between RRDI and a third party purchaser, of which 73 units closed prior to May 22, 2009, and 64 units are yet to close. There are 84 units in inventory which will be marketed for sale over the coming weeks. Proceeds of sale of the remaining units scheduled to close and the as yet unsold units are to be held by the Receiver and disbursed under direction of the Court..
