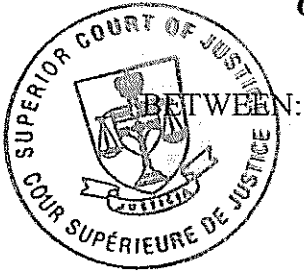

ORDER

THIS MOTION, made by Alvarez & Marsal Canada ULC, in its capacity as Court-appointed receiver and manager pursuant to section 101 of the *Courts of Justice Act* (Ontario) and trustee and receiver and manager under the *Construction Lien Act* (Ontario) (the “**CLA**”), and Alvarez & Marsal Canada Inc., in its capacity as interim receiver pursuant to section 47(1) of the *Bankruptcy and Insolvency Act* (jointly and collectively, the “**Construction Lien Trustee**”), of the undertaking, property and assets (the “**Assets**”) of The Rosseau Resort Developments Inc. (“**RRDI**”), for an Order, *inter alia*:

- (a) abridging the time for service of this Notice of Motion and Motion Record, if necessary, validating service of the Notice of Motion and Motion Record, and dispensing with further service thereof;
- (b) declaring that all capitalized terms not otherwise defined in this Order shall have the same meaning as in the Construction Lien Claims Process Order of the Honourable Mr. Justice Campbell dated July 24, 2009 (the “**Construction Lien Claims Process Order**”);
- (c) approving the amounts determined pursuant to Notices of Determination issued by the Construction Lien Trustee for certain Claims filed by Lien Claimants under the Construction Lien Claims Process Order as described in the Thirteenth Report of the Construction Lien Trustee dated November 30, 2010 (the “**Thirteenth Report**”) and as set out in **Schedule “A”** to this Order (the “**Determined Lien Claims**”);
- (d) confirming and declaring that the Determined Lien Claims have priority over, *inter alia*, any and all claims against RRDI which could give rise to any judgments, executions, assignments, attachments, garnishments, receiving orders, and any and all mortgages/charges affecting RRDI’s interest in its Premises (as defined in the CLA), which Premises include those lands legally described in **Schedule “B”** attached hereto, the improvements thereto, and all materials supplied to the improvements, and which mortgages/charges include, but are not limited to, the interests of and any and all claims of WestLB AG (“**WestLB**”) in its capacity as agent for certain lenders under charges/mortgages of land registered on title to the Premises of RRDI as Instrument Numbers MT29969 and MT63504 (collectively, the “**WestLB Charges**”), the interests of and any and all claims of Fortress Credit Corp. and/or 2258454 Ontario Inc., if any, under a charge/mortgage of land formerly registered on title to the Premises of RRDI as Instrument Number MT33625 (the “**Fortress Charge**”), the interests of and any and all claims of Travelers Guarantee Company of Canada (“**Travelers**”) under a charge/mortgage of land registered on title to the Premises of RRDI as Instrument Number MT29970 (the “**Travelers Charge**”), the Unit Owners’ Charges (as

defined in the Amended Order of Madam Justice Pepall dated August 18, 2009) (the “**August 18 Order**”) and the Primary Marriott Charge and the Secondary Marriott Charge (as defined in the August 18 Order), but not the Receiver’s Charge or the Receiver’s Borrowings Charge (as defined in the Amended and Restated Appointment Order of the Honourable Madam Justice Pepall dated June 2, 2009, as amended), and;

- (e) pursuant to paragraph 18 of the Construction Lien Claims Process Order, dispensing with the provisions of paragraphs 11 and 12 of the Construction Lien Claims Process Order and declaring that notwithstanding any provision of the Construction Lien Claims Process Order, the Notices of Determination issued by the Construction Lien Trustee are final and binding for all purposes upon the granting of this Order;
- (f) setting trial dates for all Claims under the Construction Lien Claims Process Order solely for purpose of complying with section 37 of the CLA;
- (g) approving the Thirteenth Report, and the conduct and activities of the Receiver as described therein; and
- (h) such further and other relief as counsel may request and this Honourable Court deems just,

was heard this day, at 330 University Avenue, Toronto, Ontario.

ON READING the Thirteenth Report, the affidavits of service filed, and on hearing the submissions of counsel for WestLB AG, New York Branch and the Construction Lien Trustee, and independent counsel for the Construction Lien Trustee, no one else appearing,

1. **THIS COURT ORDERS** that service of the Notice of Motion and the Motion Record in accordance with the Affidavit of Service of Christina DeLuca sworn December 2, 2010 and the Affidavits of Service of Natalina Arvaj sworn December 2, 2010 and December 6, 2010, filed, including the method and timing of notice, and the service to certain individual owners of units by letter dated December 2, 2010 by way of email, and service to the service list by way of email and courier, shall be and is hereby abridged and validated, so that this Motion is properly

returnable today and any further service thereof upon any interested party other than the persons served with the Motion Record is hereby dispensed with.

2. **THIS COURT ORDERS AND DECLARES** that capitalized terms not otherwise defined in this Order have the same meaning as in the Construction Lien Claims Process Order.

3. **THIS COURT ORDERS** that paragraphs 4, 5, 6, 7, and 8 herein in respect of each Determined Lien Claim are conditional and shall be effective upon delivery to the Construction Lien Trustee of written confirmation (the “**Confirmation**”) by WestLB AG, New York Branch and the applicable Lien Claimant of the completion of the assignment of the relevant Determined Lien Claim to WestLB, New York Branch. A copy of each Confirmation shall be provided to Travelers’ counsel.

4. **THIS COURT ORDERS** that the amounts determined for each of the Determined Lien Claims pursuant to Notices of Determination issued by the Construction Lien Trustee, as described in the Thirteenth Report and as set out at Schedule “A” attached to this Order, be and are hereby approved.

5. **THIS COURT ORDERS** that each Determined Lien Claim has priority, *inter alia*, pursuant to sections 77 and 78 of the CLA over:

(a) any and all claims against RRDI which could give rise to any judgments, executions, assignments, attachments, garnishments, and receiving orders; and

(b) all mortgages/charges including, but not limited to, the WestLB Charges, the Fortress Charge, the Travelers Charge, the Unit Owners’ Charges, the Primary Marriott Charge and the Secondary Marriott Charge, but excluding the Receiver’s Charge and the Receiver’s Borrowing Charge,

affecting RRDI’s interest in its Premises (as defined in the CLA) including those lands legally described in Schedule “B” attached hereto, the improvements thereto and all material supplied to the improvements.

6. **THIS COURT ORDERS AND DECLARES** that, pursuant to paragraph 18 of the Construction Lien Claims Process Order, the provisions of paragraphs 11 and 12 of the

Construction Lien Claims Process Order be and are hereby dispensed with in respect of the Determined Lien Claims, and notwithstanding any provision of the Construction Lien Claims Process Order, the Notices of Determination issued by the Construction Lien Trustee with respect to the Determined Lien Claims as approved herein are final and binding for all purposes upon the granting of this Order, and fully and finally determine all Claims other than the Undetermined Lien Claims (defined below), and that all claims of the Lien Claimants other than (a) the Determined Lien Claims assigned or to be assigned to WestLB, (b) the Undetermined Lien Claims, and (c) claims permitted pursuant to paragraphs 14(i) and 14(ii) of the Construction Lien Claims Process Order, are forever barred and extinguished.

7. **THIS COURT ORDERS** that this Order is a final determination of the amount, as provided in paragraph 4, and priority, as provided in paragraph 5, of the Determined Lien Claims. Without prejudicing such final determinations of the Determined Lien Claims, this Court orders as follows:

- (a) the actions of the Lien Claimants commenced in respect of the Determined Lien Claims listed on the attached **Schedule "C"** (the "**Determined Lien Claim Actions**") are hereby dismissed as against Travelers without costs; and
- (b) any and all claims of the Lien Claimants with Determined Lien Claims listed on Schedule "A" are released as against Travelers.

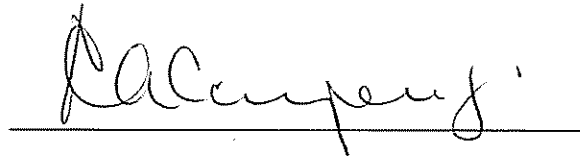
8. **THIS COURT ORDERS** that upon receipt of Confirmation, a copy of this Order is to be filed by the Trustee with the Superior Court of Justice in each of the Determined Lien Claim Actions listed on Schedule "C", and the local registrars of the Court offices in which such Determined Lien Claim Actions have been commenced shall accept this Order for filing as a final judgment in the Determined Lien Claim Actions.

9. **THIS COURT ORDERS** that solely for the purpose of complying with section 37 of the CLA, the trial of all Claims not otherwise barred by the Construction Lien Claims Process Order that are not Determined Lien Claims (the "**Undetermined Lien Claims**"), including all actions to enforce the perfected liens of the Lien Claimants in respect of the Undetermined Lien Claims, shall take place by way of appeal of any Notice of Determination that may be issued by the Construction Lien Trustee in respect of any Undetermined Lien Claims pursuant to paragraphs 11 and 12 of the Construction Lien Claims Process Order. Any such trial shall be heard in Toronto by this Honourable Court at 10:00 a.m. on July 29, 2011, by way of a motion

brought by the Construction Lien Trustee for an Order referring the said appeal to a claims officer, Construction Lien Master, or Case Management Master pursuant to paragraph 12 of the Construction Lien Claims Process Order, subject to further Order of this Court.

10. **THIS COURT ORDERS** that that solely for the purpose of complying with section 37 of the CLA, the trial date for all Determined Lien Claims shall be the return date of this motion, being Tuesday December 7, 2010 at 10:00 a.m., at Toronto.

11. **THIS COURT ORDERS** that the Thirteenth Report and the conduct and activities of the Receiver described therein be and are hereby approved.
