UPON THE APPLICATION of Impact 2000 Inc. ("Impact") to further extend the time for Impact to file a Proposal (the "Impact Application"); AND UPON READING the Applications of Canadian Western Bank to terminate these proposal proceedings and appoint a Receiver (the "CWB Applications"); AND UPON READING the proceedings had and taken herein to date; AND UPON HEARING counsel for Impact, counsel for Alvarez & Marsal Canada Inc. (the "Proposal Trustee"), counsel for Canadian Western Bank and counsel for Canada Revenue Agency; AND UPON BEING ADVISED that each of counsel for Impact, the Proposal Trustee and Canada Revenue Agency have undertaken to this Court and agree that no further applications or actions will be taken, commenced or renewed during the further extension period (herein defined as the "Stay Extension"), including without limitation any further applications or actions, whether in the Court of Queen's Bench or the Court of Appeal, to vary the Order granted herein by Madam Justice Horner on April 2nd, 2013, to seek a lifting of a stay of that Order, or to seek to enforce an earlier Order granted herein by Justice Macleod on February 28th, 2013, the intention being to maintain the status quo during the Stay Extension period; AND UPON READING the consents of counsel hereon endorsed; IT IS HEREBY ORDERED AND DECLARED THAT:

- 1. The time for service of notice of the Impact Application is abridged as required, the Impact Application is properly returnable on this date, service is deemed to be good and sufficient, and service on any other persons of notice of the Impact Application is dispensed with.
- 2. The time for service of notice of the CWB Applications is abridged as required, these applications are properly returnable on this date, service is deemed to be good and sufficient, and service on any other persons of notice of the CWB Applications is dispensed with.
- 3. Impact is granted an extension, pursuant to s. 50.4(9) of the Bankruptcy and Insolvency Act (Canada), of the time for Impact to file a proposal to on or before April **18th**, **2013** (the "Stay Extension").
- 4. The CWB Applications are adjourned to April 18th, 2013, at 10:30 a.m.
