Document and Data Analysis



Background: A&M produced expert evidence following complex analysis of specific metadata internal across relevant contract and transactional documents. This provided irrefutable evidence that the examined documents could not have been signed on the dates claimed by the opposing party.

Outcome: Our evidence proved revisions and modifications to the documents were made several months after the alleged deal date.

Internal Investigation



Background: Through extensive forensic analysis carried out by A&M across several devices used by former executives, it was confirmed that our Client's proprietary information and specialized formulae was indeed copied to an external USB device, and evidence of data destruction was found post the beginning of the case.

Outcome: During the legal proceedings, the opposing lawyers were replaced for authorizing the deletion of data relevant to the litigation and the court ordered an adverse inference instruction to be given.

Source Code Corruption



Background: A&M instructed as a single joint expert in a dispute over source code copyright infringement. Members of the A&M team performed a detailed analysis of two sets of source code to determine the similarities and differences.

Outcome: Although on first impressions the code looked completely different, a closer examination revealed that a detailed process had been undertaken to disguise the fact that one set of source code originated from the other and we were able to set out a detailed explanation of how this occurred.

Bad Leaver



Background: Following the departure of the lead coder from our client's employment, A&M was instructed to analyse the computers used by the coder due to suspicions being raised about his new venture.

Outcome: A very detailed analysis of his primary computer uncovered that not only had the coder connected devices from his home to the client's systems, but data transfers to his home had continued long after he had left, allowing him to continue to monitor our client's ongoing development activities.
