#### AFFIDAVIT OF CHRIS LEWIS Sworn December 11, 2024

## I, CHRIS LEWIS, of the City of Calgary, in the Province of Alberta, MAKE OATH AND SAY THAT:

- 1. I am the sole Director, Executive Chairman, and Chief Executive Officer of Cleo Energy Corp. ("Cleo"). As such I have personal knowledge of the matters herein deposed to, except where stated to be based upon information and belief, in which case I verily believe same to be true.
- 2. I am authorized to swear this Affidavit as corporate representative of Cleo.

- 3. In preparing this Affidavit, I consulted with Cleo's management and their legal, financial and other advisors. I also reviewed Cleo's business records relevant to these proceedings and have satisfied myself that I am possessed of sufficient information and knowledge to swear this Affidavit.
- 4. All references to dollar amounts contained herein are to Canadian Dollars unless otherwise stated.

#### **RELIEF REQUESTED**

- 5. This Affidavit is sworn in support of an Application by Cleo for Orders under the *Bankruptcy and Insolvency Act*, RSC 1985, c B-3, as amended (the "*BIA*") among other things:
  - (a) abridging the time for service of notice of this Application, deeming service of notice of this Application to be good and sufficient, and declaring that there is no other person who ought to have been served with notice of this Application;
  - (b) authorizing and directing the Royal Bank of Canada ("RBC") to cancel any cheques it issued as a result of the Garnishee Summons (as defined herein) and to make available the Garnished Funds (as defined herein) into Cleo's bank account with RBC ending in 041 (the "Account"); and
  - (c) such further and other relief as Cleo may request and this Honourable Court may grant.

#### DESCRIPTION OF THE CLEO'S BUSINESS AND BACKGROUND

- 6. Cleo was originally incorporated in the Province of Alberta on May 31, 2016. Cleo is a wholly owned subsidiary of Chimera Management Group Ltd., a holding corporation.
- 7. Cleo is a privately owned oil and gas operator of medium gravity oil based in Calgary, Alberta with operations throughout East Central Alberta. Cleo has been operating since its inception in 2016.

- 8. Cleo has a number oil wells and gas wells located primarily in the following fields throughout the Western Canada Sedimentary Basin in East Central Alberta (the "Fields"), including at the following locations:
  - (a) Silver Heights;
  - (b) Shorncliffe;
  - (c) Neutral Hills;
  - (d) Neutral Hills North;
  - (e) Fabyan;
  - (f) Sedgewick.
- 9. Cleo transports the oil and gas product (the "**Products**") from the Fields to a local sales point either by pipeline or transported by trucks. The Products are then sold to a marketer and the revenue is paid out to Cleo on the 25<sup>th</sup> of every month.

#### **EVENTS LEADING TO CLEO'S CURRENT CIRCUMSTANCES**

- 10. Cleo's revenue is linked to the productivity of its oil and gas wells, as well as the market price of oil and gas. Cleo has recently experienced low production, partly due to mechanical failures and subsequently a major theft in its main producing oil and gas fields.
- 11. Cleo's financial difficulties further stem from a variety of factors, including the lack of capital investment to undertake necessary mechanical repairs which has led to the shutdown of the Cleo's main producing fields contributing to a decline in production and revenue rates. Additionally, there has been a significant reduction in oil and gas prices during the month of September 2024, which has exacerbated Cleo's current financial difficulties. These challenges have placed considerable strain on Cleo, causing monthly revenues to decrease to unsustainable levels.
- 12. Despite Cleo's efforts to reach profitability, Cleo continues to face financial difficulties.

  Cleo is unable to meet its obligations as they become due and is insolvent.

- 13. On December 8, 2024, Cleo filed a Notice of Intention to Make a Proposal ("NOI") pursuant to subsection 50.4(1) of the *BIA*. Alvarez & Marsal Inc. has been appointed as proposal trustee (the "**Proposal Trustee**"). A copy of the NOI is attached as **Exhibit "A"**. Cleo filed the NOI in order to protect Cleo's assets, maintain the value of its business and assets, protect itself and its stakeholders interests, and provide itself an opportunity and breathing space to restructure.
- 14. Cleo has approximately \$23,000,000 in debt, of which approximately \$5,000,000 is secured. Further details relating to Cleo's insolvency will be set out in a substantive affidavit being prepared for a stay extension hearing before the Honourable Justice Lema on January 6, 2024.

#### **GARNISHEE SUMMONS**

- 15. I am advised by Cleo's legal counsel Sam Gabor of Gowling WLG (Canada) LLP ("Gowling"), that as a result of the filing of the NOI, all enforcement proceedings against Cleo and its assets are automatically stayed for an initial period of thirty (30) days from December 8, 2024 (the "Stay"). Further, no new enforcement proceedings may be commenced or continued as against Cleo during the Stay, including the continued enforcement of garnishee summons.
- 16. Garnishee proceedings were initiated against Cleo by Morganick Blending Services Corp. ("Morganick") under Court File No. 2401-10333 prior to the Stay. Morganick's collection agency T&S Collections Ltd. issued an initial garnishee summons (the "Initial Garnishment") upon RBC on or around August 6, 2024 in the amount of \$16,410.99, which amount was paid into Court by RBC. Attached as Exhibit "B" is an email from RBC confirming its reception of the Initial Garnishment. Attached as Exhibit "C" is the Certificate of Default Judgment obtained by Morganick.
- 17. Morganick was not paid in full from the Initial Garnishment as a result of the Court's allocation of funds between writ holders registered in the personal property registry ("PPR"). Accordingly, on or around November 11, 2024 Morganick's collection agency caused a second garnishee summons (the "Garnishee Summons") to be issued upon RBC

in the amount of \$152,436.18 in order to trigger payout of all writs registered in the PPR against Cleo and in order to cause Morganick to be paid in full by the Garnishee Summons. Attached as **Exhibit "D"** is an email from RBC confirming its receipt of the Garnishee Summons.

- 18. Attached hereto and marked as **Exhibit "E"** is a recent PPR name search of Cleo evidencing the writ filed by Morganick as against Cleo.
- 19. The Garnishee Summons caused the Account to be frozen by RBC and RBC to issue a cheque to the Court in the amount of \$152,436.18 (the "Garnished Funds").
- 20. On December 9, 2024, a letter was sent by Gowling on behalf of Cleo to the Alberta Court of King's Bench Accounting requesting that any garnished funds paid into court with respect to Cleo, including the Garnished Funds, need to be provided to Gowling as a result of the Stay. A copy of the letter is attached as **Exhibit "F"**.
- 21. On December 9, 2024, a letter was sent by Gowling on behalf of Cleo to Morganick advising it of the NOI and Stay, and that the Garnished Funds would need to be repaid to Cleo. A copy of this letter is attached as **Exhibit "G"**. Gowling has also provided same letters to two other writ holders who have issued recent garnishments against Cleo advising them of the Stay.
- 22. As a result of the recent Canada Post strike, the cheque sent by RBC for the Garnished Funds has not yet reached the Court. On December 11, 2024, I contacted the Court Registry which confirmed same to me.
- 23. Gowling by letters requested of RBC on December 9, 2024 and December 11, 2024 that it unlock the Account, cancel the cheque for the Garnished Funds and make available the Garnished Funds into the Account as a result of the Stay. Copies of these letters are attached as Exhibit "H" and Exhibit "I".
- 24. RBC has unlocked the Account and Cleo now has access to it. However, the Garnishment Funds have not been returned into the Account by RBC presumably as a result of the Garnishee Summons. The Garnished Funds are needed by Cleo to meet its payroll

obligations due this Friday, December 13, 2024 and to maintain business operations during the Stay. Cleo has twelve employees and nine consultants which fall under its payroll calculations. Cleo's payroll obligations are approximately \$132,000.

- 25. Jason Enns of RBC, Cleo's Private Banker, has requested a court order be provided to RBC for RBC to cancel the cheque for the Garnished Funds andmake the Garnished Funds available in the Account. Mr. Enns has advised me that RBC will follow a court order in this regard.
- 26. If Cleo is unable to meet its payroll obligations and continue its operations during the Stay, its oil and gas assets will be placed into jeopardy creating potential environmental issues and risk of significant loss to Cleo and its creditors which are owed in excess of \$23,000,000. As of the signing of this Affidavit, Cleo in good faith, is currently seeking interim financing from various sources and a prepayment of its oil revenues from its oil and gas marketer, however, none have yet confirmed that they will provide the respective financing or the prepayment by the end of the week. Accordingly, Cleo currently has no other confirmed adequate sources of available funds this week to meet its payroll obligations and Cleo is reliant on the Garnished Funds to do so.
- 27. Cleo needs to make payroll to be in a position to maintain its oil and gas assets, and needs to continue carrying on business during the Stay to be able to proceed forward with the NOI proceeding for the benefit of its stakeholders.
- 28. The Proposal Trustee is supportive of this application.

#### **CONCLUSION**

29. I swear this Affidavit in support of an Application for the relief set out in paragraph 5 of this Affidavit and for no other or improper purpose.

Alvarez & Marsal Canada Inc. has been appointed as the Proposal Trustee of Cleo for its NOI proceeding.

As a result of the filing of the NOI, a 30-day stay of proceedings has immediately taken effect (the "**Stay**") and all enforcement proceedings as against Cleo are stayed. Further, no new enforcement proceedings may be commenced or continued as against Cleo during the Stay, including the enforcement of any garnishee summons.

As a result of the Stay, it is necessary that Royal Bank of Canada ("**RBC**") immediately unlock Cleo's bank account no. 1222041, and any of Cleo's other accounts with RBC (the "**Accounts**"), which were previously frozen due to any garnishee summons served upon RBC, including the following:

We are legal counsel to Cleo. We are writing further to our letter dated December 9, 2024 (the "December 9 Letter"). All capitalized terms herein have the meaning set out in the December 9 Letter.

We have been advised by Cleo that it has been granted access to its accounts with RBC and we thank RBC for taking those proactive steps.

Concurrently, Cleo advises us that as of the time of this letter, the most recent garnishee cheque sent by RBC to the Court has not been cancelled and the applicable funds have not yet been returned into Cleo's Accounts with RBC. Our client has contacted the Court this afternoon which has advised it has not received the cheque from RBC. The Stay requires that the garnished funds be available to Cleo as no creditor is entitled to continue enforcement against the funds.

Cleo is required to make payroll this Friday. Cleo has determined that the aforementioned funds will be required to do so and for Cleo to maintain its operations. As you can appreciate, it is now critical that the cheque be cancelled and funds made available in the Accounts as soon as possible and no later than end of day Thursday, December 12, 2024, so Cleo can make payroll Friday. If Cleo is unable to make payroll, its oil and gas assets will be placed into significant jeopardy creating potential environmental issues and risk of significant loss to Cleo and its creditors which are owed in excess of \$23,000,000. Cleo must make payroll to be in a position to maintain its oil and gas assets, continue carrying on business and proceed forward with the NOI proceeding for the benefit of its stakeholders.

Based on the foregoing, we would respectfully ask that you please confirm today that the previously issued cheque sent to the Court is being cancelled by RBC and the applicable funds will be available in Cleo's Accounts by end of day Thursday.
