(the "**Receiver**"), Court-appointed Receiver of Morris Sales & Service Ltd., and upon hearing from counsel on behalf of other parties participating, and upon reading the Notice of Application dated June 15, 2021, the First Report of the Receiver dated June 15, 2021 (the "**First Report**"), and a form of Draft Order, all filed with proof of service; and upon reading the pleadings and proceedings herein;

**THE COURT ORDERS:**

1. The allocation of the costs of the realization upon the PMSI Assets (as that term is defined in the First Report) recommended the First Report, and in particular paragraphs 21-22 thereof (namely, the allocation based upon a fixed allocation methodology), shall be and is hereby approved.
2. The Receiver is authorized and directed to make the following distributions, namely:
  - (a) to De Lage Landen Financial Services Canada Ltd., \$120,266.00; and
  - (b) to Kubota Canada Ltd., \$105,924.00.
