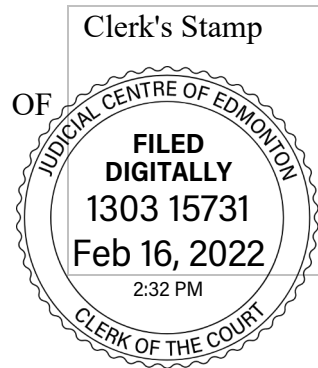

RECITALS

- A. Pursuant to an Order of the Honourable Justice Thomas of the Court of Queen's Bench of Alberta, Judicial District of Calgary (the "Court") granted November 13, 2013, Alvarez & Marsal Canada Inc. was appointed as the receiver (the "Receiver") of the undertakings, property and assets of 1324206 Alberta Ltd. (the "Debtor").
- B. Pursuant to an Order of the Honourable Justice Thomas granted June 30, 2015 (the "Discharge Order") Alvarez & Marsal Canada Inc. was discharged as Receiver of the

Debtor to be effective upon the filing by the Receiver with the Court of a certificate confirming that the Receiver has completed the matters in paragraphs 5 and 6 of the Discharge Order, provided, however, notwithstanding its discharge: (a) the Receiver shall remain Receiver for the performance of such incidental duties as may be required to complete the administration of the receivership herein, and (b) the Receiver shall continue to have the benefit of all provisions of all Orders made in this proceeding, including all approvals, protections and stays of proceedings in favour of Alvarez and Marsal Canada Inc. in its capacity as Receiver.

THE RECEIVER CERTIFIES the following:

1. All activities described in paragraphs 5 and 6 of the Discharge Order have been completed.
2. This Certificate was delivered by the Receiver on February 16, 2022.
