AFFIDAVIT

- 1. I am a lawyer at Rush Ihas Hardwick LLP ("Rush") and have acted as counsel to Alvarez and Marsal Canada Inc., the Receiver of Vinco Holdings Ltd. and Waterway Houseboats Ltd. (the "Receiver"). Rush was previously counsel to Vinco Holdings Ltd. and Waterway Houseboats Ltd. in respect of litigation that was active at the date of the Receiver's appointment. I have personal knowledge of the facts and matters hereinafter deposed to save and except where the same are stated to be made upon information and belief and where so stated I verily believe them to be true.
- 2. The accounts of Rush issued to the Receiver for service from May 1, 2020 to January 31, 2022, can be summarized as follows:
