**AFFIDAVIT**

I, **Anthony Tillman**, Managing Director, of 902 Cathedral Place Building, 925 West Georgia Street, Vancouver, British Columbia, MAKE OATH AND SAY AS FOLLOWS:

1. I am a CPA and LIT employed by Alvarez & Marsal Canada Inc., which on June 11, 2019 pursuant to an order of the Supreme Court of British Columbia (the "**Court**") was appointed receiver (the "**Receiver**") of the assets, undertakings, and property of Vinco Holdings Ltd. ("**VHL**") and Waterway Houseboats Ltd. ("**WHL**" collectively with VHL, "**Vinco**" or the "**Company**") in this proceeding. As such, I have personal knowledge of the facts contained herein and where those facts are based upon information and belief I verily believe them to be true.
2. This affidavit is intended to be read in conjunction with the Receiver's Fifth Report to Court (the "**Discharge Report**"), filed with this Affidavit, and is intended to specifically address the Receiver's accounts in respect of this matter.
3. In particular, by virtue of paragraph 21 of the Receivership Order, the Receiver and its legal counsel shall pass their accounts and, for this purpose, the accounts of the Receiver and its legal counsel are referred to a judge of the Supreme Court of British Columbia, which passing may be heard on a summary basis.

4. The purpose of this Affidavit, when read with the Discharge Report, is to advise the Court as to the factors commonly considered by the Court for the purpose of considering the accounts and passing them summarily in that respect.
5. Based upon my review of the time recordings, I confirm that the work as described therein was undertaken and was, in my opinion, necessary in order for the Receiver to fulfil its duties and obligations under the Receivership Order.
6. The work undertaken by the Receiver's personnel was done under my direct supervision and where appropriate, the work was delegated. Further, each of the disbursements paid by the Receiver was necessarily incurred in order for the Receiver to fulfil its obligations and incurred in accordance with my instructions.
7. For the period of May 1, 2020 to discharge, the total of these accounts is as follows:

10. In the Receiver's opinion, the time and disbursements incurred in the course of its duties are:

- (a) fair and reasonable in a receivership of the nature described herein; and
  - (b) comparable to receivership assignments of similar scale and complexity.
11. The hourly rates charged by the Receiver are:
- (a) consistent with the hourly rates billed by the Receiver on other engagements; and
  - (b) consistent with other insolvency firms of comparable size engaged on similar receivership matters to the Receiver's knowledge.
12. The Receiver requests that the Court summarily approve the Receiver's fees incurred to date and approve additional fees and costs to a maximum of \$20,000 to complete the administration of the receivership and the handling of closing matters. The additional fees include approximately \$3,500 of unbilled work in process, not including taxes and disbursements, for the period of March 1 to March 31, 2022. The estimated fees relate to work required to prepare for the discharge of the Receiver.
13. The Receiver retained the services of DLA Piper (Canada) LLP ("**DLA**") as its legal counsel.
14. The amounts billed by DLA as to fees and disbursements will be subject of a separate affidavit to be sworn by DLA.
15. However, I can confirm that DLA regularly invoiced the Receiver for the activities undertaken by them as requested by the Receiver for both their fees and disbursements.
16. In summary, the amounts billed to the Receiver by DLA is as follows:

21. In summary, the amounts billed to the Receiver by Rush is as follows:



  - the Receiver has approved the fees and disbursements in respect of the legal services provided by Rush.
23. The Receiver requests that the Court summarily approve the legal fees incurred to date and approve additional fees, and costs to a maximum of \$40,000 for DLA and Rush to complete the administration of the receivership. The estimated fees relate to work required to complete the discharge of the Receiver and to carry out the October Settlement Offer should the this Honourable Court grant the Orders sought on this application.
