## Affidavit of Doraine Awid sworn October 25, 2022.

- I, Doraine Awid, of Edmonton, Alberta, make oath and say that:
- 1. I am employed by the Canada Revenue Agency ("CRA") at its Edmonton office, have conduct of the CRA's files relating to 1679775 Alberta Ltd. (sometime carrying on business as Reid-Built Homes) ("1679775"), Reid-Built Homes Ltd., Builders Direct Supply Ltd., and Reid Worldwide Corporation and have personal knowledge of the matters outlined below except where stated to be based on information and belief and, where so stated, I believe them to be true.
- 2. I have informed myself from books or records maintained by the CRA in respect of each of the named corporations, and where I have done so, I affirm that, to the best of my knowledge:
  - these books or records were part of CRA's ordinary books or records; a.

- b. any entries in these books or records were made in the usual and ordinary course of CRA's business;
- c. these books and records were and are in the custody and control of CRA;
- d. any copies of these books or records appended to this Affidavit are true copies thereof; and
- e. I believe the information set out in CRA's records concerning the four named corporations to be true.
- 3. I am authorized to make this affidavit on behalf of the Minister of National Revenue (the "Minister") who acts on behalf of His Majesty the King in Right of Canada.
- 4. I am advised by counsel that on November 2, 2017 the Honourable Justice S.D. Hillier issued Consent Receivership Order in this proceeding, appointing Alvarez & Marsal Canada Inc. ("A&M") as receiver of Reid-Built Homes Ltd., 1679775 Alberta Ltd., Reid Worldwide Corporation, Builder's Direct Supply Ltd., Reid Built Homes Calgary Ltd., Reid Investments Ltd., Reid Capital Corp. Mr. Justice Hillier's Order is attached as Exhibit "A" to this my affidavit.

## 1679775 Alberta Ltd. - \$193,343.42

- 5. On November 29, 2017, I sent A&M a letter setting out CRA's claim in respect of the liability of 1679775 Alberta Ltd. (sometimes carrying on business as Reid Built Homes) pursuant to the *Excise Tax Act*. On March 27, 2018, I sent a letter setting out CRA's amended claim in respect of the liability of 1679775 Alberta Ltd. (sometimes carrying on business as Reid Built Homes) pursuant to the *Excise Tax Act*. 1679775 Alberta Ltd. was and remains liable for \$590,066.17 pursuant to the *Excise Tax Act* for unremitted Goods and Services Tax (GST), of which \$193,343.42 is subject to the deemed trust provisions of subsections 222(1) and (3) of the *Excise Tax Act*.
- 6. On August 27, 2018, I sent a follow-up letter, attaching my March 27, 2018 letter.
- 7. On January 17, 2019, I sent a third request, attaching both my March 27, 2018 letter and my August 27, 2018 letter.

- 8. Attached as **Exhibit "B"** is a copy of my fax cover sheet to Marianna Lee at A&M dated January 17, 2019, my follow up letter of August 27, 2018, and my claim letter of March 27, 2018.
- 9. To date, the Receiver has not paid this claim.

### **Reid-Built Homes Ltd. - \$555,105.69**

- 10. On November 28, 2017, I sent A&M a letter setting out CRA's claim in respect of Reid-Built Homes Ltd. pursuant to the *Excise Tax Act*. On March 27, 2018, I sent a letter setting out CRA's amended claim in respect of Reid-Built Homes Ltd. pursuant to the *Excise Tax Act*. Reid-Built Homes Ltd. was and remains liable for \$986,143.61 pursuant to the *Excise Tax Act* for unremitted GST, of which \$555,105.69 is subject to the deemed trust provisions of subsections 222(1) and (3) of the *Excise Tax Act*.
- 11. On August 22, 2018, I sent a follow-up letter, attaching my March 27, 2018 letter.
- 12. On January 17 2019, I sent a third request, attaching both my March 27, 2018 letter and my August 22, 2018 letter.
- 13. Attached as **Exhibit "C"** is a copy of my fax cover sheet to Marianna Lee at A&M dated January 17, 2019, my follow up letter of August 22, 2018, and my claim letter of March 27, 2018.
- 14. To date, the Receiver has not paid this claim.

### **Builders Direct Supply Ltd - \$4,495.27**

- 15. On April 11, 2018, I sent a letter setting out CRA's claim in respect of Builders Direct Supply Ltd.'s liability pursuant to the *Excise Tax Act*. Builders Direct Supply Ltd. was and remains liable for \$11,416.81 pursuant to the *Excise Tax Act* for unremitted GST, of which \$4,495.27 is subject to the deemed trust provisions of subsections 222(1) and (3) of the *Excise Tax Act*.
- 16. On August 22, 2018, I sent a follow-up letter, attaching my April 11, 2018 letter.

- 17. On January 17, 2019, I sent a third request, attaching both my April 11, 2018 letter and my August 22, 2018 letter.
- 18. Attached as **Exhibit "D"** is a copy of my fax cover sheet to Marianna Lee at A&M dated January 17, 2019, my follow up letter of August 22, 2018, and my letter of April 11, 2018.
- 19. To date, the Receiver has not paid this claim.

## Reid Worldwide Corporation - \$19,422.90

- 20. On June 11, 2018, I a letter setting out CRA's claim in respect of Reid Worldwide Corporation's liability pursuant to the *Excise Tax Act* for unremitted GST. Reid Worldwide Corporation was and remains liable for \$56,403.22 pursuant to the *Excise Tax Act*, of which \$19,422.90 is subject to the deemed trust provisions of subsections 222(1) and (3) of the *Excise Tax Act*.
- 21. On August 22, 2018, I sent a follow-up letter, attaching my June 11, 2018 letter.
- 22. On January 17, 2019, I sent a third request, attaching both my March 27, 2018 letter and my August 22, 2018 letter.
- 23. Attached as **Exhibit "E"** is a copy of my fax cover sheet to Marianna Lee at A&M dated January 17, 2019, my follow up letter of August 22, 2018, and my claim letter of June 11, 2018.
- 24. To date, the Receiver has not paid this claim.

## Telephone calls

- 25. I have reviewed the diary notes I made on this file, which notes were made in the ordinary course of business. The notes indicate
  - (a) On 6 February 2019, I called Marianna Lee at A&M and left a message to call on her voicemail;

- (b) On 28 November 2019, I left another voicemail message for Marianna Lee;
- (c) On 27 September 2022, I called A&M's Vancouver office, left message to call re who now has conduct of the Reid companies files. Monica Cheung from A&M returned my call to advise Vicki Chan now has conduct of the Reid company files.
- (d) On 11 October 2022, I received a voice-mail message from Vicki Chan advising they are in the process of filing the T2 (Income Tax) returns. I returned her call but reached her voicemail. I left a message to call.

## **Potential Bankruptcy of Companies**

- I contacted CRA's counsel and instructed him to contact the Receiver's counsel to inquire about the status of payment of CRA's GST claims, described above. By email dated September, 20, 2022, CRA's counsel contacted A&M's counsel to inquire about the status of the payment of CRA's \$193,343.42 GST claim against 1679775 Alberta Ltd. By reply dated October 5, 2022, A&M's counsel replied that the debtor (1679775) and other related Reid entities will be filing Bankruptcy assignments shortly and the CRA claims will be reviewed in that proceeding. A copy of that email exchange is attached as **Exhibit "F"** to this my affidavit.
- 27. I am advised by counsel and believe that the Crown's claims:
  - (a) of \$193,343.42 with respect to 1679775 Alberta Ltd.,
  - (b) of \$555,105.69 with respect to Reid-Built Homes Ltd.,
  - (c) of \$4,495.27 with respect to Builders Direct Supply Ltd., and
  - (d) of 19,422.90 with respect to Reid Worldwide Corporation

remain property claims protected by subsection 222(3) of the *Excise Tax Act*, RSC 1985 c. E-15, but that if the Receiver assigns any of those corporations into bankruptcy, each property claim will be reduced to an unsecured claim.

## No activity by Receiver since October 2021

- 28. According to the Receiver's website set up for this receivership

  (<a href="https://www.alvarezandmarsal.com/reidbuilt#intro">https://www.alvarezandmarsal.com/reidbuilt#intro</a>), the most recent Court Order pronounced in this receivership was pronounced on October 1, 2021. The most recent report filed with the Court was the <a href="https://www.alvarezandmarsal.com/reidbuilt#intro">Nineteenth Report of Receiver</a> dated September 20, 2021.
- 29. According to paragraph 4.1 of the Nineteenth Report, for the period from November 2, 2017 (date of Receivership Order) to September 10, 2021, the Combined Interim Statement of Cash Receipts and Disbursements prepared by the Receiver showed \$131,885,000 in total receipts and \$131,041,000 in total disbursements, with a closing cash balance of \$843,000. (per paragraph 4.1, all figures were expressed in thousands (\$000s)).

## Bankruptcy Searches – No bankruptcy as of 21 October 2022

30. Now shown to me and attached as **Exhibits "G"**, "H", "I", and "J" are true copies of the search results of the online database maintained by the Office of the Superintendent of Bankruptcy ("OSB") of 1679775 Alberta Ltd. (**Exhibit "G"**), Reid-Built Homes Ltd, (**Exhibit "H"**), Builders Direct Supply Ltd. (**Exhibit "I"**) and Reid Worldwide Corporation (**Exhibit "J"**) conducted on Friday October 21, 2022. Per each exhibit, the OSB's database shows each corporation was in receivership but the Superintendent's office had no record any of the corporations had made an assignment in bankruptcy.

### Conclusion

- 31. I make this affidavit in support of the Minister's application for an order directing A&M, as the court-appointed receiver of the corporations to remit \$772,367.28 to the Receiver General forthwith, allocated as follows:
  - (a) \$193,343,42 with respect to 1679775 Alberta Ltd.,
  - (b) \$555,105.69 with respect to Reid-Built Homes Ltd.,

- (c) \$4,495.27 with respect to Builders Direct Supply Ltd., and
- (d) \$19,422.90 with respect to Reid Worldwide Corporation

to be applied to each corporations' liability to the Minister on their respective GST accounts.

UPON the application of the Plaintiff, Royal Bank of Canada ("RBC") in respect of Reid-Built Homes Ltd., 1679775 Alberta Ltd., Reid Worldwide Corporation, Builder's Direct Supply Ltd., Reid Built Homes Calgary Ltd., Reid Investments Ltd., and Reid Capital Corp., (individually and collectively referred to as the "Debtor") and in respect of Emilie Reid; AND UPON reading the consent of Alvarez & Marsal Canada Inc. ("A&M") to act as Receiver and Manager (the "Receiver") of the property of the Debtor, filed; AND UPON hearing counsel for RBC, counsel for the Defendants and counsel for the Receiver; IT IS HEREBY ORDERED AND DECLARED THAT:

#### SERVICE

 The time for service of the notice of application for this order is hereby abridged and service thereof is deemed good and sufficient.

#### APPOINTMENT

 Pursuant to section 243 of the Bankruptcy and Insolvency Act, R.S.C. 1985, c. B-3 as amended (the "BIA"), and sections 13(2) of the Judicature Act, R.S.A. 2000 c.J-2 and 65(7) of the Personal Property Security Act, R.S.A. 2000, c.P-7 (the "PPSA") A&M is hereby appointed Receiver, without security, of all of the Debtor's current and future assets, undertakings and properties of every nature and kind whatsoever, and wherever situate, including all proceeds thereof (the "Property").

#### RECEIVER'S POWERS

- 3. The Receiver is hereby empowered and authorized, but not obligated, to act at once in respect of the Property and, without in any way limiting the generality of the foregoing, the Receiver is hereby expressly empowered and authorized to do any of the following where the Receiver considers it necessary or desirable:
  - (a) to take possession and control of the Property and any and all proceeds, receipts and disbursements arising out of or from the Property;
  - (b) to receive, preserve, protect and maintain control of the Property, or any part or parts thereof, including, but not limited to, the changing of tocks and security codes, the relocating of Property to safeguard it, the engaging of independent security personnel, the taking of physical inventories and the placement of such insurance coverage as may be necessary or desirable;
  - (c) to manage, operate and carry on the business of the Debtor, including the powers to enter into any agreements, incur any obligations in the ordinary course of business, cease to carry on all or any part other business, or cease to perform any contracts of the Debtor;
  - (d) to engage consultants, appraisers, agents, experts, auditors, accountants, managers, counsel and such other persons from time to time and on whatever basis, including on a temporary basis, to assist with the exercise of the powers and duties, including without limitation those conferred by this Order;
  - (e) to purchase or lease machinery, equipment, inventories, supplies, premises or other assets to continue the business of the Debtor or any part or parts thereof;
  - (f) to receive and collect all monies and accounts now owed or hereafter owing to the Debtor and to exercise all remedies of the Debtor in collecting such monies, including, without limitation, to enforce any security held by the Debtor;
  - (g) to settle, extend or compromise any indebtedness owing to or by the Debtor,
  - (h) to execute, assign, issue and endorse documents of whatever nature in respect of any of the Property, whether in the Receiver's name or in the name and on behalf of the Debtor, for any purpose pursuant to this Order;
  - (i) to initiate, prosecute and continue the prosecution of any and all proceedings and to defend all proceedings now pending or hereafter instituted with respect to the Debtor, the Property or the Receiver, and to settle or compromise any such proceedings. The authority hereby conveyed shall extend to such appeals or applications for judicial review in respect of any order or judgment pronounced in any such proceeding, and provided further that nothing in this Order shall authorize the Receiver to defend or settle the action in which this Order is made unless otherwise directed by this Court;
  - (j) to market any or all the Property, including advertising and soliciting offers in respect of the Property or any part or parts thereof and negotiating such terms and conditions of sale as the Receiver in its discretion may deem appropriate;

- (k) to sell, convey, transfer, lease or assign the Property or any part or parts thereof in the ordinary course of business without the approval of this Honourable Court and to sell, convey, transfer, lease or assign the Property or any part or parts thereof out of the ordinary course of business:
  - (i) without the approval of the Court in respect of any transaction out of the ordinary course of business not exceeding \$150,000.00, provided that the aggregate consideration for all such transactions out of the ordinary course of business does not exceed \$1,000,000.00; and
  - (ii) with the approval of this Court in respect of any transaction out of the ordinary course of business in which the purchase price or the aggregate purchase price exceeds the applicable amount set out in the preceding clause,

and in each such case notice under subsection 60(8) of the PPSA shall not be required.

- (I) to apply for any vesting order or other orders necessary to convey the Property or any part or parts thereof to a purchaser or purchasers thereof, free and clear of any liens or encumbrances affecting such Property;
- (m) to report to, meet with and discuss with such affected Persons (as defined below) as the Receiver deems appropriate all malters relating to the Property and the receivership, and to share information, subject to such terms as to confidentiality as the Receiver deems advisable:
- (n) to register a copy of this Order and any other Orders in respect of the Property against title to any of the Property;
- (o) to apply for any permits, licences, approvals or permissions as may be required by any governmental authority and any renewals thereof for and on behalf of and, if thought desirable by the Receiver, in the name of the Debtor;
- (p) to enter into agreements with any trustee in bankruptcy appointed in respect of the Debtor, including, without limiting the generality of the foregoing, the ability to enter into occupation agreements for any property owned or leased by the Debtor;
- (q) to exercise any shareholder, partnership, joint venture or other rights which the Debtor may have;
- (r) to assign the Debtor Into bankruptcy; and
- (s) to take any steps reasonably incidental to the exercise of these powers or the performance of any statutory obligations;

and in each case where the Receiver takes any such actions or steps, it shall be exclusively authorized and empowered to do so, to the exclusion of all other Persons (as defined below), including the Debtor, and without interference from any other Person.

The-Receiver-is-hereby-further-empowered-and-authorized, but-not-obligated, to-sign-in-the-name of-and-on-behalf-of-the-Debtor-any-documentation-necessary-to-effect-the-transfer-of-any-aircraft or-helicopter-or-any-component-of-any-aircraft-or-helicopter-and-all-relevant-registries-are-directed to-accept-any-documents-signed-by-the-Receiver-in-the-name-of-and-on-behalf-of-the-Debtor-for this-purpose.

## DUTY TO PROVIDE ACCESS AND CO-OPERATION OF THE RECEIVER

- (i) The Debtor, (ii) all of its respective current and former directors, officers, employees, agents, accountants, legal counsel and shareholders, and all other persons acting on their instructions or behalf, and (iii) all other individuals, firms, corporations, governmental bodies or agencies, or other entities having notice of this Order (all of the foregoing, collectively, being "Persons" and each being a "Person") shall forthwith advise the Receiver of the existence of any Property in such Person's possession or control, shall grant immediate and continued access to the Property to the Receiver, and shall deliver all such Property (excluding Property subject to liens the validity of which is dependent on maintaining possession) to the Receiver upon the Receiver's request.
- All Persons shall forthwith advise the Receiver of the existence of any books, documents, securities, contracts, orders, corporate and accounting records, and any other papers, records and information of any kind related to the business or affairs of the Debtors, and any computer programs, computer tapes, computer disks, or other data storage media containing any such information (the foregoing, collectively, the "Records") in that Person's possession or control, and shall provide to the Receiver or permit the Receiver to make, retain and take away copies thereof and grant to the Receiver unfettered access to and use of accounting, computer, software and physical facilities relating thereto, provided however that nothing in this paragraph 6 or in paragraph 7 of this Order shall require the delivery of Records, or the granting of access to Records, which may not be disclosed or provided to the Receiver due to the privilege attaching to solicitor-client communication or documents prepared in contemplation of litigation or due to statutory provisions prohibiting such disclosure.
- 7. If any Records are stored or otherwise contained on a computer or other electronic system of information storage, whether by independent service provider or otherwise, all Persons in possession or control of such Records shall forthwith give unfettered access to the Receiver for the purpose of allowing the Receiver to recover and fully copy all of the information contained therein whether by way of printing the information onto paper or making copies of computer disks or such other manner of retrieving and copying the information as the Receiver in its discretion deems expedient, and shall not alter, erase or destroy any Records without the prior written consent of the Receiver. Further, for the purposes of this paragraph, all Persons shall provide the Receiver with all such assistance in gaining immediate access to the information in the Records as the Receiver may in its discretion require including providing the Receiver with instructions on the use of any computer or other system and providing the Receiver with any and all access codes, account names and account numbers that may be required to gain access to the information.

## NO PROCEEDINGS AGAINST THE RECEIVER

 No proceeding or enforcement process in any court or tribunal (each, a "Proceeding"), shall be commenced or continued against the Receiver except with the written consent of the Receiver or with leave of this Court.

## NO PROCEEDINGS AGAINST THE DEBTORS OR THE PROPERTY

No Proceeding against or in respect of the Debtor or the Property shall be commenced or continued except with the written consent of the Receiver or with leave of this Court and any and all Proceedings currently under way against or in respect of the Debtor or the Property are hereby stayed and suspended pending further Order of this Court, provided, however, that nothing in this Order shall; (i) prevent any Person from commencing a proceeding regarding a claim that might otherwise become barred by statute or an existing agreement if such proceeding is not commenced before the expiration of the stay provided by this paragraph 8; and (ii) affect a Regulatory Body's investigation in respect of the debtor or an action, suit or proceeding that is taken in respect of the debtor by or before the Regulatory Body, other than the enforcement of a

payment order by the Regulatory Body or the Court. "Regulatory Body" means a person or body that has powers, duties or functions relating to the enforcement or administration of an Act of Parliament or of the legislature of a province.

## NO EXERCISE OF RIGHTS OF REMEDIES

10. All rights and remedies (including, without limitation, set-off rights) against the Debtor, the Receiver, or affecting the Property, are hereby stayed and suspended except with the written consent of the Receiver or leave of this Court, provided however that nothing in this paragraph shall (i) empower the Receiver or the Debtor to carry on any business which the Debtor is not lawfully entitled to carry on, (ii) exempt the Receiver or the Debtor from compliance with statutory or regulatory provisions relating to health, safety or the environment, (iii) prevent the filing of any registration to preserve or perfect a security interest, or (iv) prevent the registration of a claim for lien.

## NO INTERFERENCE WITH THE RECEIVER

11. No Person shall discontinue, fail to honour, alter, interfere with, repudiate, terminate or cease to perform any right, renewal right, contract, agreement, licence or permit in favour of or held by the Debtor, without written consent of the Receiver or leave of this Court. Nothing in this Order shall prohibit any party to an "eligible financial contract" (as defined by the Companies' Creditors Arrangement Act) with the Debtor from terminating such contract or exercising any rights of set-off, in accordance with its terms.

## CONTINUATION OF SERVICES

12. All Persons having oral or written agreements with the Debtor or statutory or regulatory mandates for the supply of goods and/or services, including without limitation, all computer software, communication and other data services, centralized banking services, payroll services, insurance, transportation services, utility or other services to the Debtor are hereby restrained until further Order of this Court from discontinuing, altering, interfering with or terminating the supply of such goods or services as may be required by the Receiver, and this Court directs that the Receiver shall be entitled to the continued use of the Debtor's current telephone numbers, facsimile numbers, internet addresses and domain names, provided in each case that the normal prices or charges for all such goods or services received after the date of this Order are paid by the Receiver in accordance with normal payment practices of the Debtor or such other practices as may be agreed upon by the supplier or service provider and the Receiver, or as may be ordered by this Court.

#### RECEIVER TO HOLD FUNDS

13. All funds, monies, cheques, instruments, and other forms of payments received or collected by the Receiver from and after the making of this Order from any source whatsoever, including without limitation the sale of all or any of the Property and the collection of any accounts receivable in whole or in part, whether in existence on the date of this Order or hereafter coming into existence, shall be deposited into one or more new accounts to be opened by the Receiver (the "Post Receivership Accounts") and the monies standing to the credit of such Post Receivership Accounts from time to time, net of any disbursements provided for herein, shall be held by the Receiver to be paid in accordance with the terms of this Order or any further order of this Court.

#### **EMPLOYEES**

Subject to employees' rights to terminate their employment, all employees of the Debtor shall remain the employees of the Debtor until such time as the Receiver, on the Debtor's behalf, may

terminate the employment of such employees. The Receiver shall not be liable for any employee-related liabilities, including wages, severance pay, termination pay, vacation pay, and pension or benefit amounts, other than such amounts as the Receiver may specifically agree in writing to pay, or such amounts as may be determined in a Proceeding before a court or tribunal of competent jurisdiction.

Pursuant to clause 7(3)(c) of the Personal Information Protection and Electronic Documents Act, S.C. 2000, c. 5, the Receiver shall disclose personal information of identifiable individuals to prospective purchasers or bidders for the Property and to their advisors, but only to the extent desirable or required to negotiate and attempt to complete one or more sales of the Property (each, a "Sale"). Each prospective purchaser or bidder to whom such personal information is disclosed shall maintain and protect the privacy of such information and limit the use of such information to its evaluation of the Sale, and if it does not complete a Sale, shall return all such information to the Receiver, or in the alternative destroy all such information. The purchaser of any Property shall be entitled to continue to use the personal information provided to it, and related to the Property purchased, in a manner which is in all material respects identical to the prior use of such information by the Debtor, and shall return all other personal information to the Receiver, or ensure that all other personal information is destroyed.

#### LIMITATION ON ENVIRONMENTAL LIABILITIES

- (a) Notwithstanding anything in any federal or provincial law, the Receiver is not personally liable in that position for any environmental condition that arose or environmental damage that occurred:
  - (i) before the Receiver's appointment; or
  - (ii) after the Receiver's appointment unless it is established that the condition arose or the damage occurred as a result of the Receiver's gross negligence or wilful misconduct.
  - (b) Nothing in sub-paragraph exempts a Receiver from any duty to report or make disclosure imposed by a law referred to in that sub-paragraph.
  - (c) Notwithstanding anything in any federal or provincial law, but subject to sub-paragraph hereof, where an order is made which has the effect of requiring the Receiver to remedy any environmental condition or environmental damage affecting the Property, the Receiver is not personally liable for failure to comply with the order, and is not personally liable for any costs that are or would be incurred by any person in carrying out the terms of the order,
    - (i) if, within such time as is specified in the order, within 10 days after the order is made if no time is so specified, within 10 days after the appointment of the Receiver, if the order is in effect when the Receiver is appointed, or during the period of the stay referred to in clause below, the Receiver:
      - (A) complies with the order, or
      - (B) on notice to the person who issued the order, abandons, disposes of or otherwise releases any interest in any real property affected by the condition or damage;
    - (ii) during the period of a stay of the order granted, on application made within the time specified in the order referred to in clause (i) above, within 10 days after the

order is made or within 10 days after the appointment of the Receiver, if the order is in effect when the Receiver is appointed, by,

- (A) the court or body having jurisdiction under the law pursuant to which the order was made to enable the Receiver to contest the order; or
- (B) the court having jurisdiction in bankruptcy for the purposes of assessing the economic viability of complying with the order; or
- (iii) if the Receiver had, before the order was made, abandoned or renounced or been divested of any interest in any real property affected by the condition or damage.

Mothing in this Order shall derogate from the protection afforded to the Receiver by Section 14.06 of the *BIA* or any other applicable legislation.

#### LIMITATION ON THE RECEIVER'S LIABILITY

17. Except for gross negligence or wilful misconduct, as a result of its appointment or carrying out the provisions of this Order the Receiver shall incur no liability or obligation that exceeds an amount for which it may obtain full indemnity from the Property. Nothing in this Order shall derogate from any limitation on liability or other protection afforded to the Receiver under any applicable law, including, without limitation, Section 14.06, 81.4(5) or 81.6(3) of the BIA.

## RECEIVER'S ACCOUNTS

- Any expenditure or liability which shall properly be made or incurred by the Receiver, including the fees of the Receiver and the fees and disbursements of its legal counsel, incurred at the standard rates and charges of the Receiver and its counsel, shall be allowed to it in passing its accounts and shall form a first charge on the Property in priority to all security interests, trusts, liens, charges and encumbrances, statutory or otherwise, in favour of any Person (the "Receiver's Charge").
- 19. The Receiver and its legal counsel shall pass their accounts from time to time.
- 20. Prior to the passing of its accounts, the Receiver shall be at liberty from time to time to apply reasonable amounts, out of the monies in its hands, against its fees and disbursements, including the legal fees and disbursements, incurred at the normal rates and charges of the Receiver or its counsel, and such amounts shall constitute advances against its remuneration and disbursements when and as approved by this Court.

#### FUNDING OF THE RECEIVERSHIP

The Receiver be at liberty and it is hereby empowered to borrow by way of a revolving credit or otherwise, such monies from time to time as it may consider necessary or desirable, provided that the outstanding principal amount does not exceed \$1,500,000.00 (or such greater amount as this Court may by further Order authorize) at any time, at such rate or rates of interest as it deems advisable for such period or periods of time as it may arrange, for the purpose of funding the exercise of the powers and duties conferred upon the Receiver by this Order, including interim expenditures. The whole of the Property shall be and is hereby charged by way of a fixed and specific charge (the "Receiver's Borrowings Charge") as security for the payment of the monies borrowed, together with interest and charges thereon, in priority to all security interests, trusts, liens, charges and encumbrances, statutory or otherwise, in favour of any Person, but subordinate in priority to the Receiver's Charge.

- 22. Neither the Receiver's Borrowings Charge nor any other security granted by the Receiver in connection with its borrowings under this Order shall be enforced without leave of this Court.
- 23. The Receiver is at liberty and authorized to issue certificates substantially in the form annexed as Schedule "A" hereto (the "Receiver's Certificates") for any amount borrowed by it pursuant to this Order.
- The monies from time to time borrowed by the Receiver pursuant to this Order or any further order of this Court and any and all Receiver's Certificates evidencing the same or any part thereof shall rank on a *pari passu* basis, unless otherwise agreed to by the holders of any prior issued Receiver's Certificates.

#### ALLOCATION

Any interested party may apply to this Court on notice to any other party likely to be affected, for an order allocating the Receiver's Charge and Receiver's Borrowings Charge amongst the various assets comprising the Property.
