ENDORSEMENT OF JUSTICE OSBORNE:

1. RBC, in its capacity as Bilateral Lender, ("RBC Bilat") moves for an order (the "Amended Syndicate Collateral Management Order") that amends my earlier Syndicate Collateral Management Order dated October 17, 2024 to expand the definition of "Management Assets" to include the RBC Bilat Assets and all proceeds thereof.
2. Defined terms in this Endorsement have the meaning given to them in my earlier Order and/or the motion materials.
3. The Syndicate Collateral Management Order dated October 17, 2024 appointed Alvarez & Marsal as Manager of the Management Property of the Syndicate Lenders. The order sought today would expand the scope of that Management Property to include the Remaining Assets to be turned over to RBC Bilat in its capacity as Recourse Lender, subject to the consent of the Manager and RBC as administrative agent for itself and the other Syndicate Lenders. Essentially, RBC Bilat has now elected to have the Manager administer these additional assets as well.
4. RBC relies on the affidavits of Brad D. Newton sworn August 2, 2024 and October 16, 2024, both with exhibits thereto.
5. The Service List has been served. The motion is unopposed, including by the Applicants and the Court-appointed Monitor.
6. I am satisfied that the relief should be granted. Order to go in the form signed by me today which is effective immediately and without the necessity of issuing and entering.
