AFFIDAVIT #1 OF SCOTT ROWLAND

I, Scott Rowland, of the Town of Oakville, in the Province of Ontario, HEREBY SWEAR THAT:

- I am the Chief Investment Officer at Timbercreek Mortgage Servicing Inc. ("Timbercreek"), a secured creditor of SCREO I Metrotown Inc. (the "Metrotown Legal Owner") and SCREO I Metrotown L.P. (the "Metrotown Beneficial Owner" and, collectively, "Metrotown").
- 2. By virtue of my direct knowledge regarding the Assignments of Proceeds (as defined below), granted by Metrotown to Timbercreek, as well as the Timbercreek Loans (as defined below), I have personal knowledge of the matters hereinafter deposed to, except where stated to be based on information and belief, and where so stated I verily believe the same to be true.
- 3. As more fully outlined below, I make this Affidavit in support of Timbercreek's response to (i) the Notice of Application for Advice and Direction filed on March 5, 2025 (the "Application") of Alvarez & Marsal Canada Inc. ("A&M"), in its capacity as the court-appointed receiver over the property of Metrotown (the "Receiver"), and (ii) the Application Response filed on April 17, 2025 (the "GVWD Response") of Greater Vancouver Water District ("GVWD"), an apparent unsecured creditor of Metrotown.

- 4. I have reviewed, among other things, the Application, the GVWD Response, as well as the First Report of the Receiver dated October 30, 2024 (the "First Report") and the Second Report of the Receiver dated March 5, 2025 (the "Second Report").
- 5. I am authorized to make this Affidavit on behalf of Timbercreek.

Metrotown, Slate CREO Fund and Slate Affiliates

- Based on my review of the First Report, and my personal knowledge, Metrotown are special purpose vehicles that are affiliated with Slate Canadian Real Estate Opportunity Fund I LP ("Slate CREO Fund"). More specifically, Slate CREO Fund is the indirect shareholder of Metrotown. Slate CREO Fund is an investment fund that holds interests in various real estate projects across Canada, through special purpose vehicles, such as Metrotown. Timbercreek frequently deals with Slate CREO Fund with respect to various real estate assets across Canada.
- 7. As set out in the First Report, Metrotown was formed to acquire and develop two office towers located in Burnaby, British Columbia known as the "Capital Point Towers".
- 8. The legal address for the Capital Point Towers is PID: 031-357-881, Lot 1 District Lot 153 Group 1 New Westminster District Plan EPP107270 and the municipal addresses for the Capital Point Towers are:
 - (a) Capital Tower 1: 4300-4330 Kingsway, Burnaby, B.C.; and
 - (b) Capital Tower 3: 5945 Kathleen Avenue, Burnaby, B.C.
- 9. Slate CREO Fund is also an indirect shareholder of:
 - (a) SCREO I 700 2ND Inc. ("SCREO 700") and 58508 Alberta Ltd. ("585" and, collectively, "SCREO 700/585"); and
 - (b) SCREO I Gill Inc. ("SCREO Gill").
- 10. Based on my review of Alberta corporate search reports, I understand that (i) SCREO 700 and SCREO Gill are both corporations incorporated pursuant to the laws of the Province of Ontario and are extra-provincially registered to carry on business in Alberta, and (ii) 585 is a corporation incorporated pursuant to the laws of the Province of Alberta. Attached and marked as **Exhibit "A"** to this Affidavit are true copies of the corporate searches for SCREO 700, SCREO Gill and 585.
- 11. SCREO 700/585 and SCREO Gill own office towers in Calgary, Alberta.

12. Slate CREO Fund, Metrotown, SCREO 700/585 and SCREO Gill are all affiliates by virtue of their common relationship to Slate CREO Fund.

The Timbercreek Loan Agreements and the Assignments of Proceeds

- 13. Pursuant to a Loan Agreement dated November 27, 2018, as amended by certain loan amending agreements (collectively, the "SCREO 700/585 Loan Agreement"), Timbercreek, as lender, advanced to SCREO 700/585, as borrowers, certain loans (the "SCREO 700/585 Loans"). A true copy of the SCREO 700/585 Loan Agreement (without amendments) is attached as Appendix B to the Second Report.
- Additionally, pursuant to a Loan Agreement dated November 9, 2018, as amended by certain loan amending agreements (collectively, the "SCREO Gill Loan Agreement"), Timbercreek, as lender, advanced to SCREO Gill, as borrower, certain loans (the "SCREO Gill Loans"). A true copy of the SCREO Gill Loan Agreement (without amendments) is attached as Appendix A to the Second Report.
- 15. The SCREO 700/585 Loan Agreement and the SCREO Gill Loan Agreement are collectively referred to as the "Timbercreek Loan Agreements". The SCREO 700/585 Loans and the SCREO Gill Loans are collectively referred to as the "Timbercreek Loans".
- 16. Slate CREO Fund is also a limited guaranter and party to each of the Timbercreek Loan Agreements. The Timbercreek Loans are secured by real estate owned by SCREO 700/585 and SCREO Gill in Calgary, Alberta.
- 17. On or about December 1, 2022, Timbercreek, SCREO 700/585 and Slate CREO Fund agreed to a Loan Amending Agreement (the "SCREO 700/585 December Renewal"). A copy of the SCREO 700/585 December Renewal is attached as Appendix D to the Second Report.
- 18. Further, on or about December 1, 2022, Timbercreek, SCREO Gill and Slate CREO Fund agreed to a Loan Amending Agreement (the "SCREO Gill December Renewal"). A copy of the SCREO Gill December Renewal is attached as Appendix C to the Second Report.
- 19. The SCREO 700/585 December Renewal and the SCREO Gill December Renewal are collectively referred to as the "December Renewals".
- 20. As consideration to Timbercreek for the extensions under the December Renewals, SCREO 700/585 and SCREO Gill each agreed to make certain partial principal repayments of the Timbercreek Loans. Those payments would be due when Metrotown sold the Capital Point Towers, or when other

affiliates, named SCREO I Dixie Outlet Mall Inc. and SCREO I Dixie Outlet Mall L.P. sold a property in Ontario known as "Dixie Outlet Mall".

- 21. A yet further condition of each of the December Renewals was for Metrotown to provide Timbercreek a security interest in, and promise to transfer and set over, net sale proceeds from the Capital Point Towers, pursuant to Assignments of Proceeds (collectively, the "Assignments of Proceeds" or each an "Assignment of Proceeds"). True copies of the Assignments of Proceeds are attached as Appendix E of the Second Report.
- 22. Among other things, each of the Assignments of Proceeds state that:
 - (a) Metrotown absolutely pledges, mortgages, charges, assigns, transfers, and sets over to Computershare Trust Company of Canada ("Computershare"), as agent, nominee and bare trustee for and on behalf of Timbercreek, all right, title and interest Metrotown has or may hereafter have in any "net sale proceeds" from the sale of the Capital Point Towers, as partial principal repayment of the SCREO 700/585 Loans and the SCREO Gill Loans, as applicable; and
 - (b) they "shall be continuing security to [the benefit of Computershare on behalf of Timbercreek] for repayment of the facilities" owing under the Timbercreek Loan Agreements.
- 23. The Assignments of Proceeds incorporate the definition for "net sale proceeds" in the December Renewals, which defines "net sale proceeds" as the proceeds from a sale of the Capital Point Towers after paying financing related to the Capital Point Towers (e.g. registered mortgages), reasonable legal fees, real estate commissions and normal closing costs.
- 24. Similarly, the quantum of Timbercreek's security interest in the "net sale proceeds", under the Assignments of Proceeds, is determined by reference to the December Renewals. The December Renewals define Timbercreek's entitlement as equalling:
 - the "greater of \$15,000,000 ... or 25% of the net sales proceeds" under the SCREO 700/585
 Assignment of Proceeds; and
 - (b) the "greater of \$2,000,000 ... or 10% of the net sales proceeds" under the SCREO Gill Assignment of Proceeds.

- 25. By virtue of the Assignments of Proceeds, Timbercreek has an aggregate secured claim in any "net sale proceeds" from the Capital Point Towers of \$17,000,000.
- 26. The only contracts executed by Metrotown in favour of Timbercreek (via Computershare) were the Assignments of Proceeds. There were no other guarantees or other loan agreements signed by Metrotown.
- 27. Nevertheless, the commercial and main purpose of the Assignments of Proceeds was to encourage Timbercreek to extend the maturity dates for the Timbercreek Loans, from December 1, 2022 to September 1, 2024, by providing Timbercreek additional recourse, albeit up to certain limits. Effectively, Metrotown agreed to backstop the obligations of its affiliates, SCREO 700/585 and SCREO Gill.

Amounts Owed to Timbercreek

- 28. The sale of the Capital Point Towers triggered the obligations of SCREO 700/585 and SCREO Gill to make the partial principal repayments contemplated by the December Renewals. However, SCREO 700/585 and SCREO Gill have not made these payments, and based on my personal dealings with those entities, I understand they lack the liquidity to do so. There has been no sale completed for the Dixie Outlet Mall.
- As such, Timbercreek is entitled to receive up to \$17,000,000 from the Net Sale Proceeds realized by the Receiver from the sale of the Capital Point Towers.
- 30. Finally, and for completeness, there remains due and owing to Timbercreek under the Timbercreek Loans substantial amounts, namely:
 - (a) in respect of the SCREO 700/585 Loan: \$140,105,163.68; and
 - (b) in respect of the SCREO Gill Loan: \$26,161,615.93 plus an exit fee of \$142,600.
- Likewise, Timbercreek has received no principal repayment on the Timbercreek Loans since prior to the December Renewals, except on or about November 15, 2024. That payment was made to Timbercreek by SCREO Gill, as SCREO Gill sold one of its properties mortgaged to Timbercreek. This sale does not reduce SCREO Gill's obligations under the Assignments of Proceeds.

Remote Attestation

32. I was not physically present before the lawyer commissioning this Affidavit, but was in the lawyer's virtual electronic presence with the lawyer using video technology and the process described in the Law

Society of British Columbia Code of Professional Conduct for remote commissioning of affidavits was used.

33. I acknowledge the solemnity of making this Affidavit and acknowledge that I am aware of the consequences of making an untrue statement in this Affidavit.
