1. I am a lawyer at DLA Piper (Canada) LLP ("**DLA**"), counsel to Alvarez & Marsal Canada Inc., in its capacity as information officer (the "**Information Officer**") in these proceedings, and as such have personal knowledge of the facts and matters hereinafter deposed to save and except where the same are stated to be made upon information and belief and where so stated I verily believe them to be true.
