TAKE NOTICE that an application will be made by the applicant to Justice Blake at the courthouse at 800 Smithe Street, Vancouver, B.C. on Friday, November 1, 2024 at 9:30 a.m. for the order set out in Part 1 below.

The applicant estimates that the application will take 5 minutes.

This matter is not within the jurisdiction of an associate judge.

Part 1 ORDER SOUGHT

1. An order, substantially in the form attached hereto as <u>Schedule "A"</u>, adding Alix Abela, Thanh Tran, Hikari Yasuhara, Mereani Vaileba, Paolo Bianchin, Gelareh Hashemishayan, Charlie Goodchild, Jenny Goodchild and Nicolas Binon (collectively, the "**Tenants**") as respondents to these proceedings.

Part 2 FACTUAL BASIS

Background

- On October 27, 2022, on the application of the Petitioner, the Honourable Mr. Justice Giaschi granted an order (the "Receivership Order"), among other things, appointing Alvarez & Marsal Canada Inc. (the "Receiver") as receiver and manager of certain lands and other assets, undertakings and property (collectively, the "Property") of the Respondents 1025332 B.C. Ltd., 1025334 B.C. Ltd., 1025336 B.C. Ltd., Chongye Developments Ltd., Washington Properties (Point Grey) Inc., Washington Properties (QEP) Inc., Lucky Five Investments Ltd., 1094321 B.C. Ltd., Prarda Developments Corporation, 1256306 B.C. Ltd., 1256319 B.C. Ltd., Amy Barsha Washington (a.k.a. Fengyun Shao), Edison Washington (a.k.a. Qiang Wang) and Linda Washington (collectively, the "Debtors").
- 2. On December 18, 2023, on the application of the Petitioner, the Honourable Madam Justice Blake granted an order, among other things, adding Washington Properties (West 27th) Inc. and Washington Properties (West 29th) Inc. as respondents in these proceedings.
- 3. Subsequently, the Petitioner filed its amended petition to the court on February 1, 2024, reflecting the addition of the new respondents as parties to these proceedings.

- 4. Through the Receiver, the Petitioner has been made aware of the identities of several tenants living at two of the properties comprising the Property, being those properties bearing the civic addresses of:
 - (a) 4491 Cambie Street, Vancouver, B.C. ("4491"); and
 - (b) 4215 Cambie Street, Vancouver, B.C. ("4215").
- 5. The Petitioner is aware of the following tenants currently occupying 4491:
 - (a) Alix Abela; and
 - (b) Thanh Tran.
- 6. The Petitioner is aware of the following tenants currently occupying 4215:
 - (a) Hikari Yasuhara;
 - (b) Mereani Vaileba;
 - (c) Paolo Bianchin;
 - (d) Gelareh Hashemishayan;
 - (e) Charlie Goodchild;
 - (f) Jenny Goodchild; and
 - (g) Nicolas Binon.

Part 3 LEGAL BASIS

- 1. The Petitioner relies on:
 - (a) the Supreme Court Civil Rules, B.C. Reg. 241/2010, as amended (the "SCCR");
 - (b) the inherent and equitable jurisdiction of this Honourable Court; and
 - (c) such further and other legal bases and authorities as counsel may advise and this Honourable Court may permit.

Adding Parties

2. The Petitioner seeks to add the Tenants as Respondents in these proceedings pursuant to Rule 6-2(7) of the SCCR, which reads, in part, as follows:

Adding, removing or substituting parties by order

- (7) At any stage of a proceeding, the court, on application by any person, may, subject to subrules (9) and (10),
 - (b) order that a person be added or substituted as a party if
 - (i) that person ought to have been joined as a party, or
 - (ii) that person's participation in the proceeding is necessary to ensure that all matters in the proceeding may be effectually adjudicated on, and
 - (c) order that a person be added as a party if there may exist, between the person and any party to the proceeding, a question or issue relating to or connected with
 - (i) any relief claimed in the proceeding, or
 - (ii) the subject matter of the proceeding

that, in the opinion of the court, it would be just and convenient to determine as between the person and that party.

3. The Petitioner seeks to add the Tenants as Respondents in these proceedings, as they ought to have been joined as parties as occupants of properties comprising the Property.
