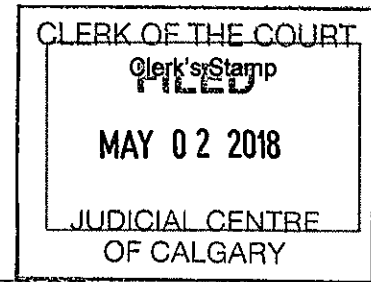

UPON the application of Alvarez & Marsal Canada Inc. in its capacity as the Court-appointed receiver (the "Receiver") of the undertaking, property and assets of the Defendant Advantage Products Inc. ("Advantage"); AND UPON reading the Application, the Receiver's first report dated April 24, 2018 (the "First Report"); the Affidavit of Service and other materials filed in the proceedings; AND UPON hearing counsel for the Receiver and any other interested parties appearing at the within application, **IT IS ORDERED THAT:**

1. Unless otherwise defined herein, all capitalized terms shall have the meaning given to them in the First Report.

2. Service of notice of this application and supporting materials is hereby declared to be good and sufficient, and no other person is required to have been served with notice of this application, and time for service of this application is abridged to that actually given.
