### PROPOSAL TRUSTEE'S CERTIFICATE

#### **RECITALS**

- A. Pursuant to a Notice of Intention to Make a Proposal pursuant to section 50.4(1) of the Bankruptcy and Insolvency Act ("BIA") dated April 18, 2022 by Just Solutions Inc. (the "Debtor"), Alvarez & Marsal Canada Inc. (the "Proposal Trustee") was appointed as Proposal Trustee.
- B. On May 31, 2022, the Debtor filed a proposal to its creditors pursuant to Division I of Part III of the BIA (the "**Proposal**").
- C. Pursuant to the Order (Approval and Implementation of Proposal; Cancellation of Existing Shares) granted on July 14, 2022 by the Honourable Mr. Justice R.W. Elson (the "Approval Order"), the Court of Queen's Bench for Saskatchewan (the "Court") approved the Proposal and, inter alia, provided that the Proposal Trustee may, following the implementation of the Proposal, file a certificate with the Court stating that all of its duties in respect of the Debtor pursuant to the BIA and the Orders of the Court pronounced in these proceedings have been completed, file a certificate evidencing the same and thereby be discharged from its duties as Proposal Trustee.
- D. Section 65.3 of the BIA requires that a proposal trustee certify in a prescribed form (Form 46) that a proposal has been fully performed, which Certificate of Full Performance of Proposal in Form 46 is attached to this Proposal Trustee's Certificate as Schedule A.

#### THE PROPOSAL TRUSTEE CERTIFIES the following:

- Proposal Implementation has occurred, and the Stalking Horse Proposal and the Approval Order (as those terms are defined in the Proposal) are effective in accordance with their respective terms..
- 2. All of the Proposal Trustee's duties in respect of the Debtor pursuant to the BIA and the Orders pronounced in these proceedings have been completed.
