I, Paul Farley Joslyn of the Calgary, Alberta, Make Oath and SWEAR THAT:

- 1. I am the Chief Financial Officer of Petrolama Energy Canada Inc. (the "Company" or "Petrolama"). The facts stated in this Affidavit are based on my personal knowledge of the Company and its business and affairs, my review of its books and records. In each case where I have relied upon information from others, I have stated the source of such information.
- 2. I swore an Affidavit on August 2, 2022 (the "First Affidavit") and in paragraph 12 of that Affidavit I stated that Petrolama had no bank debt and no secured creditors. That was true when I swore the First Affidavit and it continues to be true today.

- 3. That said, I wish to advise the Court that, after conducting debtor searches in the jurisdictions within which Petrolama has conducted business, it has come to my attention that there are security registrations against Petrolama in Alberta, Saskatchewan and Oklahoma. Attached hereto and collectively marked as **Exhibit "A"** are:
 - (a) An Alberta Personal Property Registry search dated August 8, 2022;
 - (b) A Saskatchewan Personal Property Registry search dated August 5, 2022; and
 - (c) An Oklahoma Uniform Commercial Code search for Petrolama dated August 8, 2022;

(collectively, the "Searches").

- 4. The Searches show the following security registrations:
 - (a) In Alberta:
 - (i) HSBC Bank Canada ("**HSBC**") has registered a security agreement against Petrolama;
 - (ii) ING Capital LLC ("**ING**") has registered a security agreement against Petrolama; and
 - (iii) ING has registered a land charge against Petrolama;
 - (b) In Saskatchewan, ING has registered an interest in all present and after acquired personal property of Petrolama; and
 - (c) In Oklahoma, ABN Amro Capital USA LLC ("ABN") has registered a security interest against all the assets of Petrolama.
- 5. Petrolama does not own or hold any interest in any land; it does not owe any monies to any of HSBC, ING or ABN (collectively, the "Registrants"); and Petrolama has no knowledge that any of the Registrants have extant security interests in any of the property of Petrolama.
- 6. Petrolama maintains its operating bank account with HSBC. On August 4, 2022, I wrote to HSBC regarding its registration. Thereafter, I spoke with Petrolama's account manager at HSBC and I was advised that it was taking steps to discharge its registration. In the meanwhile, HSBC has provided Petrolama with a "No Interest Letter" dated August 5, 2022. A copy of part of the correspondence between HSBC and me, as well as the No Interest Letter, are attached hereto and collectively marked as **Exhibit "B"**.

- 7. As indicated in the First Affidavit at paragraphs 11 and 12, Petrolama had entered into a credit agreement with ING in March of 2018, however, the Company's financing agreements with ING came to an end in November 2020.
- 8. Petrolama no longer does business with ING and there is no debt outstanding. On August 4, 2022 I sent an email to ING requesting that it discharge its security registration against Petrolama. In response, ING asked Petrolama to prepare and send it Uniform Commercial Code and Personal Property Security Act discharge forms. A copy of part of the correspondence between ING and me is attached hereto and collectively marked as **Exhibit "C"**. Since that time, I have sent ING discharge forms for Alberta and I will continue to work with ING to accomplish the discharges of security in all jurisdictions.
- 9. With respect to ABN, just today, I managed to make contact with John Sullivan ("Mr. Sullivan") from ABN regarding its registration against Petrolama. Mr. Sullivan informed me that he had contacted ABN's general counsel to discharge the registration. Subsequently, I received an email from Mr. Sullivan stating that ABN's counsel had submitted a Uniform Commercial Code termination notice. Attached hereto and marked as Exhibit "D" is a copy of that email and the termination notice attached to it.

The deponent was not physically present before the commissioner, but was linked with the commissioner utilizing video technology and the process described in the *Notice to the Profession and Public: Remote Commissioning of Affidavits for Use in Civil and Family Proceedings During the Covid-19 Pandemic* was utilized.

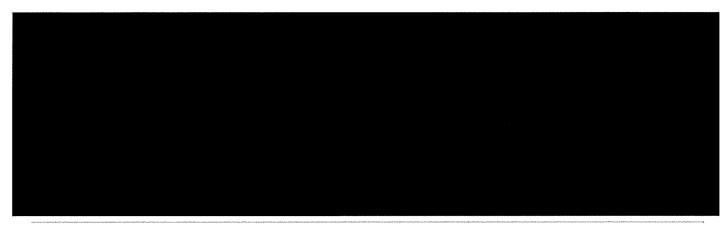

I, Paul Farley Joslyn of the Calgary, Alberta, Make Oath and SWEAR THAT:

- I am the Chief Financial Officer of Petrolama Energy Canada Inc. (the "Company" or "Petrolama"). The facts stated in this Affidavit are based on my personal knowledge of the Company and its business and affairs, my review of its books and records. In each case where I have relied upon information from others, I have stated the source of such information.
- 2. I swore an Affidavit on August 2, 2022 (the "First Affidavit") and in paragraph 12 of that Affidavit I stated that Petrolama had no bank debt and no secured creditors. That was true when I swore the First Affidavit and it continues to be true today.



- 3. That said, I wish to advise the Court that, after conducting debtor searches in the jurisdictions within which Petrolama has conducted business, it has come to my attention that there are security registrations against Petrolama in Alberta, Saskatchewan and Oklahoma. Attached hereto and collectively marked as **Exhibit "A"** are:
 - (a) An Alberta Personal Property Registry search dated August 8, 2022;
 - (b) A Saskatchewan Personal Property Registry search dated August 5, 2022; and
 - (c) An Oklahoma Uniform Commercial Code search for Petrolama dated August 8, 2022;

(collectively, the "Searches").

- 4. The Searches show the following security registrations:
 - (a) In Alberta:
 - (i) HSBC Bank Canada ("**HSBC**") has registered a security agreement against Petrolama;
 - (ii) ING Capital LLC ("**ING**") has registered a security agreement against Petrolama; and
 - (iii) ING has registered a land charge against Petrolama;
 - (b) In Saskatchewan, ING has registered an interest in all present and after acquired personal property of Petrolama; and
 - (c) In Oklahoma, ABN Amro Capital USA LLC ("ABN") has registered a security interest against all the assets of Petrolama.
- 5. Petrolama does not own or hold any interest in any land; it does not owe any monies to any of HSBC, ING or ABN (collectively, the "Registrants"); and Petrolama has no knowledge that any of the Registrants have extant security interests in any of the property of Petrolama.
- 6. Petrolama maintains its operating bank account with HSBC. On August 4, 2022, I wrote to HSBC regarding its registration. Thereafter, I spoke with Petrolama's account manager at HSBC and I was advised that it was taking steps to discharge its registration. In the meanwhile, HSBC has provided Petrolama with a "No Interest Letter" dated August 5, 2022. A copy of part of the correspondence between HSBC and me, as well as the No Interest Letter, are attached hereto and collectively marked as **Exhibit "B"**.

- 7. As indicated in the First Affidavit at paragraphs 11 and 12, Petrolama had entered into a credit agreement with ING in March of 2018, however, the Company's financing agreements with ING came to an end in November 2020.
- 8. Petrolama no longer does business with ING and there is no debt outstanding. On August 4, 2022 I sent an email to ING requesting that it discharge its security registration against Petrolama. In response, ING asked Petrolama to prepare and send it Uniform Commercial Code and Personal Property Security Act discharge forms. A copy of part of the correspondence between ING and me is attached hereto and collectively marked as **Exhibit "C"**. Since that time, I have sent ING discharge forms for Alberta and I will continue to work with ING to accomplish the discharges of security in all jurisdictions.
- 9. With respect to ABN, just today, I managed to make contact with John Sullivan ("Mr. Sullivan") from ABN regarding its registration against Petrolama. Mr. Sullivan informed me that he had contacted ABN's general counsel to discharge the registration. Subsequently, I received an email from Mr. Sullivan stating that ABN's counsel had submitted a Uniform Commercial Code termination notice. Attached hereto and marked as Exhibit "D" is a copy of that email and the termination notice attached to it.

The deponent was not physically present before the commissioner, but was linked with the commissioner utilizing video technology and the process described in the Notice to the Profession and Public: Remote Commissioning of Affidavits for Use in Civil and Family Proceedings During the Covid-19 Pandemic was utilized.

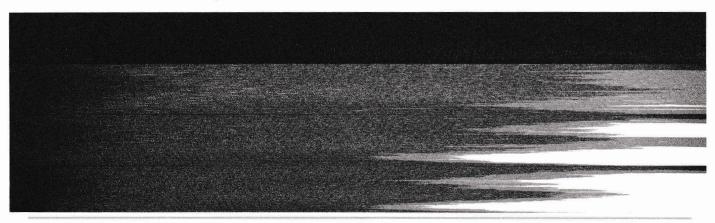
