I. Introduction¹

1. Allied World Specialty Insurance Company (“**Allied World**”) files this aide memoire on a narrow issue: whether the distribution sought by the Applicant to 1001485743 Ontario Inc. (the “**IP Creditor**”) should be deferred pending a final determination of transfer at undervalue and/or preference litigation (“**TUV Litigation**”) against corporations that are related to the Applicant, including the IP Creditor, and the directing mind of all such corporations, Douglas Putman (“**Mr. Putman**”).
2. Allied World does not seek to determine the IP Creditor’s secured claim, reorder priorities or decide liability at this case conference. Instead, Allied World asks that the Court exercise its broad discretion under the CCAA to defer the distribution to the IP Creditor and direct the Monitor to hold the sale proceeds from the AP Transaction² (the “**Proceeds**”) in an interest-bearing account pending a case-managed, expedited determination of the TUV Litigation.³
3. The balance of prejudice favours granting Allied World’s request. If the Proceeds are distributed now, Allied World may be deprived of the ability to recover on any judgment if the Proceeds are dissipated or placed beyond Allied World’s reach. By contrast, the prejudice to the IP Creditor is limited and temporary. If the TUV Litigation is unsuccessful, the IP Creditor receives the Proceeds with interest. A deferral of the distribution is therefore the less prejudicial interim course.

II. The Related Party Transactions Report Discloses Serious Reviewable Transaction Claims

4. At this interim stage, the Court need not decide the merits. The record discloses a serious foundation for the TUV Litigation and a fair basis for the preservation of the Proceeds. Section 36.1 of the CCAA incorporates the BIA preference and transfer at undervalue regime into CCAA

proceedings.⁴ Sections 95 and 96 of the BIA address non-arm's length preferences and transfers at undervalue, including recovery from parties and "privies".⁵

5. The RPT Report identifies three categories of transactions that warrant deferring a distribution of the Proceeds while the TUV Litigation is prosecuted:

- (a) **Preferential Payments to Related Party Suppliers:** In the month before the CCAA filing, the Applicant paid approximately \$2.3 million to related party suppliers as compared to approximately \$300,000 to third party suppliers. The Monitor also concludes that the \$800,000 payment made to Rose Textiles may be preferential because the Applicant did not receive goods or services for that payment;⁶
- (b) **Above Market Rent to Related Parties:** As part of the RPT Report, the Monitor engaged CBRE to conduct an analysis of the 18 Related Party Leases.⁷ In that analysis, CBRE concludes that 4 Related Party Leases are above market,⁸ and the Monitor concludes that, when compared to comparable properties, the Applicant may have overpaid rent between \$300,000 to \$1.8 million annually.⁹ In addition, in an effort to adjust for differences across locations and other market factors, CBRE added an arbitrary and additional \$10/sq ft to the comparable market range to conclude that 9 additional Related Party Leases are "plausible". In one case, this additional \$10/sq ft to the high end of CBRE's comparable range for these 13 locations increases the rent range by an additional 32% to 57%. If Related Party Leases that fall within the \$10/sq ft buffer are factored into the analysis, the Applicant may have overpaid rent between \$3.9 million and \$7.5 million annually in respect of 13 Related Party Leases. A summary of the Related Party Leases that may be considered above market is attached as Appendix "A"; and

- (c) **Real Property Transactions:** The Applicant sold the St. Catharines property to a related party for a purchase price of \$8.24 million, and the Gatineau property to another related party for a purchase price of \$6.21 million.¹⁰ 12 months later, the Gatineau property was sold to a third party for a purchase price of \$12.75 million (\$6.54 million profit) and a further 3 months later, the St. Catharines property was sold to a third party for a purchase price of \$16.25 million (\$8.01 million profit).¹¹ Those facts support scrutiny of the sufficiency of consideration and demonstrate badges of fraud such as non-arm's length dealings and potentially inadequate consideration.

III. There is a Serious Issue that the IP Creditor and Related Parties are Privies

6. Through Putman Investments, Mr. Putman directly or indirectly controls the related parties likely to be named defendants in the TUV Litigation, including the IP Creditor. Corporate searches show that Mr. Putman is the sole director and officer of the related party entities involved in the real property transactions and above-market Related Party Leases.¹² Sections 96(1) and (3) of the BIA permit recovery from a party to a transfer and from a non-arm's length person privy to it. The Supreme Court of Canada confirms the creditor-protection purpose of this remedy.¹³ This language is important because the issue is not limited to who owns a particular asset. The privy analysis extends to entities that directly or indirectly received value, or caused value to be received, through the related-party structure. In this case, there is reason to believe the IP Creditor indirectly received value and benefited from the reviewable transactions.
7. The current evidentiary record does not disclose the flow of assets among the Putman-related entities. Allied World has not received an entity organizational chart or financial information showing shareholdings, dividend paths, intercompany balances, or the ultimate economic beneficiaries of the impugned transactions. This information is uniquely within the knowledge of

the Applicant, Putman Investments, the IP Creditor, and Mr. Putman. At this interim stage, the asymmetrical information supports the preservation rather than the distribution of the Proceeds.

8. There is reason to believe the IP Creditor indirectly received a benefit from the impugned transactions. On February 2, 2026, the IP Creditor purchased the remaining payment obligations (estimated to be approximately \$142 million) owing to Fairfax, and Fairfax assigned all of its right, title and interest in the IP Security to the IP Creditor.¹⁴ Corporate records show that the IP Creditor was incorporated on January 27, 2026, approximately one week before acquiring the IP Security and before the Applicant commenced the CCAA proceeding. Although Allied World has no knowledge regarding the cash amount paid by the IP Creditor, as a newly incorporated corporation, the IP Creditor needed cash to complete the transaction, which presumably came from Putman Investments or another related party. In other words, the IP Creditor would not have received the benefit of the secured position it is in without cash from the same corporate group that benefited from the impugned transactions at issue. For these reasons, it is reasonable to conclude that, if the TUV Litigation is successful, a Court may conclude that the IP Creditor indirectly benefited from the impugned transactions and is a “privity” under the BIA.
9. If it is ultimately determined that the IP Creditor, Mr. Putman and/or other related parties in the Applicant’s corporate group directed related party transactions contrary to the BIA, this could justify the piercing of the corporate veil as between those parties and further justify recovery against the IP Creditor.¹⁵
10. Based on the current record, there is at least a serious issue to be determined as to whether Mr. Putman, Putman Investments, the IP Creditor, and other related parties were parties or privies to the subject matter of the TUV Litigation. The Court need not determine this issue now. Allied

World simply requests that the Court defer the distribution of the Proceeds so that the TUV Litigation is not rendered practically ineffective.

IV. Preservation of the Proceeds is Appropriate, Proportionate and Fair

11. Preservation of the Proceeds is appropriate, and, in these circumstances, principles of fairness and equity should be applied. Allied World has acted in good faith in fulfilling its obligations under the trade credit insurance policies issued for the benefit of many of the Applicant's key merchandise suppliers. Allied World has paid over \$53 million in claims under insurance policies, including a \$4.23 million payment to Out There First Inc., and a \$280,000 payment to Rose Textiles, both related party suppliers to the Applicant.
12. The Proceeds are known and subject to the jurisdiction of the Court. Allied World is prepared to proceed on an expedited litigation timetable. The accrual of interest limits prejudice to the IP Creditor, and it may seek direction of the Court if the deferral becomes unnecessary or disproportionate. By contrast, a distribution now creates potentially irreversible prejudice. If the TUV Litigation succeeds and the Proceeds have been transferred out of Allied World's reach, it may be left with an unsecured judgment against one or more entities with no assets, and no practical recovery source. This risk outweighs the temporary delay to the IP Creditor, particularly when the Proceeds are proposed to be held in a segregated, interest-bearing account, and be subject to further order of the Court.
13. For these reasons, Allied World submits that it is in the interests of justice and consistent with the principles of fairness and equity for the Court to direct the Monitor to hold the Proceeds in an interest-bearing account pending final determination of the TUV Litigation or further order.

SCHEDULE “A” RELEVANT STATUTES

Companies’ Creditors Arrangement Act, R.S.C. 1985, c. C-36

General power of court

11. Despite anything in the *Bankruptcy and Insolvency Act* or the *Winding-up and Restructuring Act*, if an application is made under this Act in respect of a debtor company, the court, on the application of any person interested in the matter, may, subject to the restrictions set out in this Act, on notice to any other person or without notice as it may see fit, make any order that it considers appropriate in the circumstances.

Duty of Good Faith

18.6(1) Any interested person in any proceedings under this Act shall act in good faith with respect to those proceedings.

Preferences and Transfers at Undervalue

36.1(1) Sections 38 and 95 to 101 of the *Bankruptcy and Insolvency Act* apply, with any modifications that the circumstances require, in respect of a compromise or arrangement unless the compromise or arrangement provides otherwise.

36.1(2) For the purposes of subsection (1), references in sections 38 and 95 to 101 of the *Bankruptcy and Insolvency Act* to “date of the bankruptcy”, “trustee”, “bankrupt”, “insolvent person” or “debtor” are read as references to the day CCAA proceedings commence, the monitor, or the debtor company, as applicable.

Bankruptcy and Insolvency Act, R.S.C. 1985, c. B-3

Definition of *person*

(2) *person* includes a partnership, an unincorporated association, a corporation, a cooperative society or a cooperative organization, the successors of a partnership, of an association, of a corporation, of a society or of an organization and the heirs, executors, liquidators of the succession, administrators or other legal representatives of a person

Definition of *related persons*

4(2) For the purposes of this Act, persons are related to each other and are ***related persons*** if they are

(c) two entities

(i) both controlled by the same person or group of persons, [...]

Presumptions

(5) Persons who are related to each other are deemed not to deal with each other at arm's length while so related. For the purpose of paragraph 95(1)(b) or 96(1)(b), the persons are, in the absence of evidence to the contrary, deemed not to deal with each other at arm's length.

Preferences

95(1) A transfer of property made, a provision of services made, a charge on property made, a payment made, an obligation incurred or a judicial proceeding taken or suffered by an insolvent person in favour of a creditor who is not dealing at arm's length with the insolvent person, or a person in trust for that creditor, that has the effect of giving that creditor a preference over another creditor is void as against the trustee if made during the period beginning on the day that is 12 months before the date of the initial bankruptcy event and ending on the date of the bankruptcy.

Transfer at undervalue

96 (1) On application by the trustee, a court may declare that a transfer at undervalue is void as against, or, in Quebec, may not be set up against, the trustee — or order that a party to the transfer or any other person who is privy to the transfer, or all of those persons, pay to the estate the difference between the value of the consideration received by the debtor and the value of the consideration given by the debtor — if

(a) the party was dealing at arm's length with the debtor and

(i) the transfer occurred during the period that begins on the day that is one year before the date of the initial bankruptcy event and that ends on the date of the bankruptcy,

(ii) the debtor was insolvent at the time of the transfer or was rendered insolvent by it, and

(iii) the debtor intended to defraud, defeat or delay a creditor; or

(b) the party was not dealing at arm's length with the debtor and

(i) the transfer occurred during the period that begins on the day that is one year before the date of the initial bankruptcy event and ends on the date of the bankruptcy, or

(ii) the transfer occurred during the period that begins on the day that is five years before the date of the initial bankruptcy event and ends on the day before the day on which the period referred to in subparagraph (i) begins and

(A) the debtor was insolvent at the time of the transfer or was rendered insolvent by it, or

(B) the debtor intended to defraud, defeat or delay a creditor.

Meaning of *person who is privy*

(3) In this section, a ***person who is privy*** means a person who is not dealing at arm's length with a party to a transfer and, by reason of the transfer, directly or indirectly, receives a benefit or causes a benefit to be received by another person.
