**Remedy claimed or sought:**

1. Capitalized terms used but not otherwise defined herein have the meanings ascribed to them in the Amended and Restated Initial Order, granted November 25, 2024 (the “ARIO”).
2. Canadian Rep Counsel on behalf of Canadian Investors, seeks:
  - (a) an order appointing three Canadian Investors to act as Canadian Representatives in the within proceedings substantially in the form attached hereto as **Schedule “B”** (the “**Appointment Order**”);
  - (b) a restricted court access order in respect of Confidential Exhibits “A”, “B”, and “C” to Secretarial Affidavit No. 2 of Kim Picard, sworn December 13, 2024 (the “**Second Picard Affidavit**”) substantially in the form attached hereto as **Schedule “C”** (the “**Sealing Order**”); and
  - (c) granting such further and other relief as may be sought by the Applicants and this Honourable Court may deem appropriate.

**Grounds for making this application:**

**Appointment of the Representative Committee**

3. Pursuant to paragraph 27 of the ARIO, Canadian Rep Counsel was permitted to commence a process to identify no more than five Canadian Investors to be appointed, pursuant to a further order of this Court, as the Canadian Representatives in the within proceedings.

4. Canadian Rep Counsel, in consultation with the Monitor, is recommending, at this time, that three individuals be appointed as Canadian Representatives. Canadian Rep Counsel has commenced a process to solicit interest amongst Canadian Investors to act as Canadian Representatives and to vet investors who put their names forward. The Canadian Investors whose names are being put forward to the Court are investors in one or more of Angus Manor, Fossil Creek, or Windridge with varying degrees of investment experience and knowledge.
5. Appointment of the proposed three Canadian Investors as Canadian Representatives is necessary for the orderly and efficient representation of Canadian Investors and to work together with Offshore Representatives on behalf of all investors in A2A projects given the large number of investors spread across Canada and the world.

#### **Sealing Order**

6. Canadian Rep Counsel seeks a Sealing Order over Confidential Exhibits “A”, “B”, and “C” to the Second Picard Affidavit, on the basis that these Exhibits contain: i) copies of the lists of Canadian Investors in Angus Manor, Fossil Creek, and Windridge provided by the Debtor Companies to the Monitor, ii) an unredacted copy of Canadian Rep Counsel’s internal tracking sheet which lists the names of the Canadian Investors who provided information to Canadian Rep Counsel, and iii) copies of the emails received from the proposed Canadian Representatives containing their personal profiles.
7. Confidential Exhibits “A”, “B”, and “C” contain personal information about Canadian Investors, including contact information, and Canadian Rep Counsel does not have the permission of the Investors to share such information publicly. Publicizing the names and contact information of Canadian Investors may deter Investors from continuing to participate in these proceedings.
8. Sealing Confidential Exhibits “A”, “B”, and “C” is the least restrictive method available to prevent the dissemination of sensitive personal information. The salutary effects of the Sealing Order, which are to protect the general commercial interest of maintaining

confidentiality, far outweigh the deleterious effects of restricting the accessibility of court proceedings.

9. Such further and other grounds as counsel may advise and this Honourable Court may permit.

**UPON** the Application of Canadian Rep Counsel on behalf of Canadian Investors seeking an order for the appointment of three Canadian Investors as Canadian Representatives in the within proceedings; **AND UPON** having read the Application of Canadian Rep Counsel, Secretarial Affidavit No. 2 of Kim Picard, sworn December 13, 2024, and the other pleadings and materials previously filed in the within proceedings; **AND UPON** hearing Canadian Rep Counsel, counsel for the Monitor, counsel for the Debtor Companies, Offshore Rep Counsel, and other counsel in attendance at the hearing;

**IT IS HEREBY ORDERED AND DECLARED THAT:**

1. All defined terms used herein have the meanings ascribed to them in the Amended and Restated Initial Order, granted November 25, 2024 (the “**ARIO**”).

4. The Canadian Representatives are hereby authorized to represent the Canadian Investors in these CCAA proceedings, including without limitation, for the purposes of settling or compromising claims by the Canadian Investors in the within proceedings and to seek the approval of this Honourable Court in relation to the same.
5. Canadian Rep Counsel is hereby authorized to reapply to this Honourable Court to appoint additional Canadian Representatives where there are fewer than five Canadian Representatives appointed at any given time due to the resignation of any one of the Canadian Representatives, a decision by the Canadian Representatives to remove any one Canadian Representative in accordance with their powers under paragraph 3 of this Order, fewer than five Canadian Representatives being appointed pursuant to this Order, or for any

other reason as Canadian Rep Counsel may advise and this Honourable Court deems just and appropriate.

6. The Canadian Representatives shall have no personal liability or obligations as a result of the performance of their duties in carrying out the provisions of this Order or any further order granted by this Court in respect of being Canadian Representatives, save and except for liability arising out of gross negligence or wilful misconduct. No action or other proceedings may be commenced against the Canadian Representatives, or any one of them, in respect of the performance of their duties under this Order without leave of the Court obtained on 7 days' notice to the Investor Representatives, Canadian Rep Counsel, Offshore Rep Counsel, the Monitor, and the Debtor Companies.
