AFFIDAVIT OF CHRIS LEWIS Sworn December 24th, 2024

I, CHRIS LEWIS, of the City of Calgary, in the Province of Alberta, MAKE OATH AND SAY THAT:

- I am the sole Director, Executive Chairman, and Chief Executive Officer of Cleo Energy Corp. ("Cleo"). As such I have personal knowledge of the matters herein deposed to, except where stated to be based upon information and belief, in which case I verily believe same to be true.
- I am authorized to swear this Affidavit as corporate representative of Cleo.

- All references to dollar amounts contained herein are to Canadian Dollars unless otherwise stated.
- 4. All defined terms herein are as defined in my prior Affidavit in this proceeding sworn December 22, 2024 (the "December 22 Affidavit").
- 5. At paragraph 52 in the December 22 Affidavit I made the statement that Trafigura would be entitled to post filing setoff rights under the Prepayment Agreement allowing it to deduct \$83,000 a month from Cleo's post filing revenues for each of Cleo's post filing production months.
- 6. The above statement was made by me in error and I retract it as I am advised by Cleo's legal counsel Gowling that the stay of proceedings issued by the filing of the NOI would legally apply to prevent contractual setoffs by Trafigura of these future scheduled monthly payments as against the amounts that will become owing by Trafigura to Cleo under the Commercial Agreement for Cleo's future monthly oil production.
- 7. I make this affidavit bona fide.
