**FIFTH AFFIDAVIT OF DANIEL T. WILSON  
Sworn on April 20, 2023**

I, Daniel T. Wilson, of the City of Calgary, in the Province of Alberta, **MAKE OATH AND SAY THAT:**

1. I am the President and Chief Executive Officer, interim Vice President of Finance and Chief Financial Officer, and a Director and Chairman of the Board of Sugarbud Craft Grower Corp. ("**SCGC**"), President and Chief Executive Officer, Vice President and Chief Financial Officer and Director of Trichome Holdings Corp. ("**THC**") and 1800905 Alberta Ltd. ("**OpCo**" together with SCGC and THC, the "**Applicants**" or "**Sugarbud**") and I am authorized to swear this affidavit (the "**Affidavit**") on behalf of the Applicants.
2. I have personal knowledge of the matters and facts herein deposed, except where based on information and belief, in which case I believe the same to be true.

3. All capitalized terms not otherwise defined herein shall have the same meaning as within my Affidavit sworn on October 7, 2022 (the "**October 7 Affidavit**"), Second Affidavit sworn on November 28, 2022 (the "**Second Wilson Affidavit**"), my Third Affidavit sworn on January 12, 2023 (the "**Third Wilson Affidavit**"), and my Fourth Affidavit sworn on March 15, 2023 (the "**Fourth Wilson Affidavit**").

### **Background**

4. Sugarbud operates a federally licensed cannabis production facility located in Stavely, Alberta (the "**Facility**") where it produces, distributes and sells cannabis products across Canada.
5. Since receiving its cultivation licence and commencing its cannabis operation in August of 2019, Sugarbud has been cash flow negative for the entire history of its operations. Despite attempts to access additional financing or complete a transaction, Sugarbud is facing a significant working capital deficit which makes it unable to pay its ongoing obligations as they become due.
6. On September 26, 2022, the Applicants each filed a Notice of Intention to Make a Proposal pursuant to subsection 50.4(1) of the BIA and A&M was appointed as Proposal Trustee.
7. As a result of the filing of the NOI, all proceedings against the Applicants and the Property were automatically stayed for an initial period of thirty (30) days (i.e. until October 26, 2022) (the "**NOI Stay Period**"). The NOI Stay Period was subsequently extended to December 10, 2022 by an order (the "**NOI Order**") granted by Justice D.B. Nixon of this Honourable Court on September 29, 2022.
8. The Applicants continued the NOI Proceedings under the CCAA pursuant to section 11.6 of the CCAA on October 18, 2022 and obtained an initial order (the "**Initial Order**") and an amended and restated initial order (the "**ARIO**") on that date.

### **Current Status of the Applicants Business and Restructuring Efforts**

9. During the CCAA proceedings, the Applicants and its management team have been working diligently and in good faith with the Monitor and Connect First Credit Union Ltd. ("**CFCU**" or the "**Interim Lender**") towards a restructuring. Sugarbud requires an

extension of the Stay Period to continue to work toward and complete a transaction within the CCAA proceedings with CFCU.

10. The Applicants have been working with the Monitor and CFCU to finalize a credit bid to purchase the Facility in which the Applicants operations are currently conducted.
11. The Applicants are also aware that a separate party who previously participated in the SISP had approached the Monitor with a proposed transaction that would be complimentary to the one proposed by CFCU.
12. The Applicants further understand that the terms of the proposed transaction from the third party were not acceptable to CFCU and the additional transaction was unable to be consummated. The Applicants understand that, on April 12, 2023, the third party advised CFCU that it was withdrawing its offer to pursue other opportunities. As a result, there will not be a going concern sale of the operating assets of the Applicants.
13. Since the Third Stay Extension, the Applicants have continued to wind-down their operations. The Applicants have wound down cannabis cultivation activities and have focused on the sale of certain excess inventory to generate additional receivables during this period. The Applicants expect that all of the remaining inventory will either be sold or destroyed prior to the end of the CCAA proceedings.
14. Opco has also provided notice to Health Canada that it will be ceasing operations effective as of May 12, 2023. Attached hereto and marked as **Exhibit "A"** is a copy of the notice sent to Health Canada.
15. The Applicants are requesting an approximately one month extension of the Stay Period to May 31, 2023 (the "**Fourth Stay Extension**"), because it is not clear how much time will be required to complete a transaction for the sale of the Facility to CFCU.
16. With the support of the Monitor and CFCU, Sugarbud is of the view that this extension is appropriate to avoid the unnecessary expenditure of the incremental professional fees that would be incurred in further extending the Stay Period, if a shorter extension was sought at this time.
