**AFFIDAVIT**

I, Anthony Tillman, of the City of Vancouver, in the Province of British Columbia, SWEAR  
THAT:

1. I am a Senior Vice President at Alvarez & Marsal Canada Inc. (“**A&M**”), monitor of the  
Petitioners (in such capacity, “**Monitor**”) pursuant to, among other orders, an initial order granted  
by the Honourable Madam Justice Gropper in these proceedings on August 13, 2024 (as may be  
further amended and restated, the “**Initial Order**”), and receiver of the assets, undertakings and  
property of the Petitioners (in such capacity, “**Receiver**”) pursuant to a receivership order granted  
by Justice Gropper in these proceedings on August 27, 2025 (the “**Receivership Order**”), and as  
such have personal knowledge of the matters deposed to in this affidavit, except where stated to  
be on information and belief, in which case I verily believe them to be true.

2. I am the Senior Vice President at A&M that has had primary carriage of this matter, and I  
am authorized to make this affidavit on behalf of the Monitor and the Receiver in support of the  
Receiver’s application for an order, among other things, approving the fees and disbursements of

the Monitor and Receiver, and their legal counsel, Fasken Martineau DuMoulin LLP (“**Fasken**”) in these proceedings, and approving the activities of the Receiver to date.

3. Capitalized terms not otherwise defined herein have the meanings ascribed to them in the Second Report of the Receiver to the Court dated April 1, 2026 (the “**Second Report**”).

**A. The Monitor’s Invoices and Fees**

4. Attached hereto collectively as Exhibit “A” and marked as indicated are copies of the covering pages of the following invoices issued by A&M showing fees for services rendered and disbursements incurred in this matter in A&M’s capacity as Monitor (the “**Monitor’s Invoices**”):

5. As detailed in the Monitor’s Invoices, from August 13, 2024 to August 31, 2025, A&M invoiced fees totalling \$1,904,673.00, and incurred and invoiced for disbursements in the amount of \$23,673.30 and taxes in the amount of \$96,417.34, for a total of \$2,024,763.64 (the “**Monitor’s Fees**”).

6. The Monitor’s Fees as set out in the Monitor’s Invoices are calculated on the basis of the hours spent by the Monitor’s personnel, multiplied by the applicable standard hourly rates charged by A&M.

7. Several professionals at A&M expended time on this matter in connection with A&M’s services as Monitor. The following is a summary of the time expended by each professional on the Monitor’s Invoice from August 13, 2024 to August 31, 2025, and each professional’s hourly rate:

- (c) the identity of the individuals who performed work; and
- (d) the rates charged for the work performed.

9. I have reviewed the Monitor's Invoices and verily believe that:

- (a) the Monitor's professional fees and disbursements have been properly incurred and are fair and reasonable in the circumstances;
- (b) the work completed by the Monitor was delegated to the appropriate professionals at A&M with the appropriate seniority and hourly rates;
- (c) the Monitor's fees in this matter are consistent with fees charged by other insolvency firms of a similar size for work of a similar nature and complexity in British Columbia; and
- (d) the services were provided by the Monitor in a prudent and economical manner.

**B. The Monitor's Reports**

10. The details of the work carried out by the Monitor in these proceedings, as set out in the fourteen (14) Reports previously filed by the Monitor, have been approved by this Court pursuant to paragraph 4 of the Receivership Order.

**D. Receiver's Reports**

17. The details of the work carried out by the Receiver in these proceedings, and for which the Court's approval is sought at this time, are set forth in the First Report of the Receiver dated September 29, 2025 and in the Second Report prepared and filed by the Receiver in these proceedings (the "**Reports**").


18. I have reviewed the Reports and confirm that, to the best of my knowledge, information and belief, the work detailed therein was carried out by the Receiver, and that such work was necessary to the Receiver in carrying out its duties and obligations in relation to this matter pursuant to the Receivership Order and the provisions of the *Bankruptcy and Insolvency Act* (Canada) (the "**BIA**").

**E. Fasken's Invoices**

19. The Monitor and Receiver engaged Fasken Martineau DuMoulin LLP ("**Fasken**") to assist it in carrying out its duties and obligations in these proceedings pursuant to, respectively, the Initial Order and the *Companies' Creditors Arrangement Act* (Canada) ("**CCAA**"), and the Receivership Order and the BIA. I have reviewed the invoices of Fasken that were issued for services rendered between the period August 6, 2024 and February 28, 2026 ("**Fasken's Invoices**"), which are further detailed in the First Affidavit of Kibben Jackson to be filed concurrently herewith. I am satisfied that the work detailed therein was completed by Fasken at the request of the Monitor and Receiver, as applicable, and was necessary.

20. I verily believe that the fees and rates charged by Fasken and reflected in Fasken's Invoices are consistent with those charged by other law firms for work of a similar nature and complexity in British Columbia.


