- On the 10th day of April, 2026, Alvarez & Marsal Canada Inc. (“A&M”) was appointed receiver (the “Receiver”), without security of the assets, undertakings and property of Manney Transport Ltd. and NCG National Container Group Inc. (collectively the “Debtors”) pursuant to section 243(1) of the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3, as amended and section 39 of the *Law and Equity Act*, R.S.B.C. 1996 c. 253, as amended (collectively the “Assets”).
