**IN THE MATTER OF THE NOTICE OF INTENTION TO MAKE A PROPOSAL OF  
JORIKI INC.**

**TO THE CREDITORS OF JORIKI INC.:**

On December 31, 2024, Joriki Inc. (the “**Company**” or “**Joriki**”) filed a Notice of Intention to Make a Proposal (“**NOI**”) pursuant to Section 50.4(1) of the *Bankruptcy and Insolvency Act* (Canada), *R.S.C. 1985, c. B-3* (the “**BIA**”) and Alvarez & Marsal Canada Inc. (“**A&M**”) was appointed as Proposal Trustee of the Company (the “**Proposal Trustee**”). A copy of the NOI, together with the list of creditors, are enclosed herewith.

Please be advised that the Company is not bankrupt and has availed itself of a procedure whereby a company, with creditor and Court approval, restructures its financial affairs. Joriki Inc. commenced the NOI proceedings to create a stabilized environment and to allow the Company breathing room while it evaluates its strategic alternatives.

During these NOI proceedings:

- Pursuant to section 69.1 (1) of the BIA, upon the filing of the NOI (December 31, 2024), no creditor shall have any remedy against the Company or its property or shall commence or continue any action, execution or other proceedings for the recovery of a claim provable in bankruptcy until the bankruptcy of the Company;
- Pursuant to section 65.1 (1) of the BIA, no person may terminate or amend any agreement with the Company, or claim an accelerated payment, or a forfeiture of the term, under any agreement with the Company, by reason only that the Company is insolvent or by reason of the filing of the NOI; and
- Pursuant to section 69.31 (2) of the BIA, no person may commence or continue any action against a director of the corporation on any claim against directors that arose before the commencement of these NOI proceedings and that relates to obligations of the corporation where directors are under any law liable in their capacity as directors for the payment of such obligations.
