

**ENDORSEMENT OF JUSTICE FL MYERS:**

1. Unopposed order to go as sought.
2. The post-LRO holdback funds paid to the Monitor in respect of continuing projects are properly due to New QM under the terms of the RVO. The Monitor will continue to hold holdback funds received prior to the implementation of the sale agreement.
3. The Monitor is proceeding with the lien resolution process appropriately. I am satisfied that the proceeding is being carried in good faith and with due diligence. The extension sought is fair and reasonable.
4. The Monitor's activities are fully explained in its reports. Absent complaint, I see no reasons to refrain from approval.
5. I have reviewed the fees and disbursements sought by the Monitor and its counsel. The rates and hours claimed appear to be reasonable given the length of time and the number of moving parts in these proceedings.
