RECITALS

A. Pursuant to an Order of the Honourable Justice D.R. Mah of the Court of King's Bench of Alberta, Judicial District of Calgary (the "Court") dated November 3, 2023, Alvarez & Marsal Canada Inc. was appointed as the receiver and manager (the "Receiver") of the remaining assets, undertaking, and properties (collectively, the "Purchased Assets") of OGEN Ltd. and OGEN Holdings Ltd. (collectively, the "Debtors").

B. Pursuant to an Order of the Court dated May 2, 2025, the Court approved the agreement of purchase and sale dated April 22, 2025 (the "262 APA") between the Receiver and 2627411 Alberta Ltd. (the "Purchaser") and provided for the vesting in the Purchaser of the Debtors' right, title and interest in and to the Purchased Assets (the "Transaction"), which vWhatesting is to be effective with respect to the Purchased Assets upon the delivery by the Receiver to the Purchaser of a certificate confirming (i) the payment by the Purchaser of the Purchase Price for the Purchased Assets; (ii) that the conditions to Closing as set out in Article 6 of the 262 APA have been satisfied or waived by the Receiver and the Purchaser; and (iii) the Transaction has been completed to the satisfaction of the Receiver.

C. Unless otherwise indicated herein, capitalized terms have the meanings set out in the 262 APA.
