## **1.0 INTRODUCTION**

- 1.1 On November 2, 2017, upon application of the Royal Bank of Canada, Alvarez & Marsal Canada Inc. was appointed as Receiver and Manager (the "Receiver") pursuant to a consent receivership order ("Receivership Order") granted by the Honourable Justice Hillier in respect of the current and future assets, undertakings and properties (the "Receivership Proceedings") of 1679775 Alberta Ltd. ("167"), Reid-Built Homes Ltd. ("RBH"), Reid Worldwide Corporation ("RWC"), Builder's Direct Supply Ltd. ("BDS"), Reid Built Homes Calgary Ltd., Reid Investments Ltd., and Reid Capital Corp. and as subsequently amended to include 1852512 Alberta Ltd. and Anchorview Capital Corp. (collectively, the "Reid Group").
- 1.2 The Receivership Order authorized the Receiver to, among other things, solicit offers in respect of the Reid Group's property and sell any such property or parts thereof with the approval of this Honourable Court for any transactions for which the purchase price exceeds \$150,000.
- 1.3 On January 22, 2018, the Receiver commenced a sales process to solicit offers to purchase the Receiver's right, title and interest in certain of Reid Group's assets (the "Sales Process"). Certain details of the Sales Process are set out in the Second Report of the Receiver dated February 28, 2018 and Fourth Report of the Receiver dated April 5, 2018 and are not repeated herein.
- 1.4 To date, the Receiver has completed 68 transactions involving accepted and approved offers for 506 residential completed and work-in-progress homes and lots, 34 commercial, development and other real properties, and sale and/or settlement of 6 other assets and interests of the Reid Group for total cash consideration of \$130.2 million which are detailed in previous reports of the Receiver.
- 1.5 On October 25, 2022, an application was filed by the Canada Revenue Agency (the "CRA") on behalf of the Minister of National Revenue representing his Majesty the King in right of Canada as a creditor of certain entities of the Reid Group to be heard on November 3, 2022 (the "CRA Application") seeking an order from this Honourable Court to:
  - a) direct the Receiver to remit payment to the Receiver General of Canada in respect of outstanding pre-filing goods and services tax ("GST") claims of the CRA against 167, RBH, RWC, and BDS; and
  - b) annul any bankruptcy assignments of 167, RBH, RWC, and BDS, if necessary.
- 1.6 The Receivership Order and other motion materials are posted on the Receiver's website at www.alvarezandmarsal.com/reidbuilt.
- 1.7 Capitalized terms not defined in this Twentieth Report are as defined in the Receivership Order.

1.8 All references to dollars in this Twentieth Report are in Canadian currency.

## 2.0 PURPOSE

2.1 This Twentieth Report is intended to provide this Honourable Court with information with respect to the Receiver's response to the CRA Application.

## 3.0 PRE-FILING GOODS AND SERVICES TAX CLAIMS

## The CRA Application

- 3.1 The CRA is seeking an order directing the Receiver to remit payment to the Receiver General of Canada in respect of outstanding GST claims relating to the pre-filing period in the following amounts:
  - a) \$193,343,42 with respect to 167;
  - b) \$555,105.69 with respect to RBH;
  - c) \$4,495.27 with respect to BDS; and
  - d) \$19,422.90 with respect to RWC.
- 3.2 Further, the CRA indicated that in the event that the Receiver had assigned these companies into bankruptcy in response to the CRA's application for payment, the CRA is requesting the Court to annul such assignments pursuant to subsection 181(1) of the *Bankruptcy and Insolvency Act*.

## Receiver's Comments on the Notice of Application by the CRA

- 3.3 Since the Receiver's appointment on November 2, 2017, the primary focus and obligation of these Receivership Proceedings were to maximize the value of the estate and realize on the numerous properties and interests of the Reid Group.
- 3.4 Under paragraph 3(r) of the Receivership Order, the Receiver is authorized and empowered to assign the Reid Group entities into bankruptcy if the Receiver considered it necessary or desirable.
- 3.5 As part of the winding down of the administration of the receivership, the Receiver had considered and prepared draft bankruptcy documents supporting an assignment into bankruptcy of certain entities of the Reid Group dating back to October 2018. A chronology of the Receiver's considerations and preparation in respect of pending bankruptcy assignments of Reid Group entities, along with the relevant supporting excerpts and extracts, is summarized below:

- 3.6 Given the passage of time since the commencement of these Receivership Proceedings, the delayed timing of the bankruptcy assignments were primarily as a result of:
  - a) the complexity of the asset and creditor profile of the Reid Group, which included over 500 residential completed and work-in-progress homes and lots and 40 commercial, development, and other assets and interests, as well as approximately 700 stakeholders and creditors involved in these proceedings, including employees, developers, mortgagors, lienholders, and deposit holders;
  - b) the volume of properties and interests held by the Reid Group to be realized in these proceedings, as detailed in section 1.4 of this report and in previous reports of the Receiver, which involved protracted negotiations and extended time to complete and close transactions. The final transaction in the Sales Process closed in October 2021 for the sale of the commercial property that served as the former head office of the Reid Group and the final settlement relating to the Build to Home Ownership Partnership, which is detailed in the Receiver's Supplement to Sixteenth Report dated June 25, 2019, was finalized in January

2022, which together resulted in aggregate gross proceeds of \$3.4 million to secured creditors and the estate;

- c) the impact of COVID which resulted in the temporary shut-down of the Receiver's office; and
- d) turnover of staff at the Receiver's office during the Receivership Proceedings.
- 3.7 Based on the foregoing, assigning the entities under the Reid Group into bankruptcy was to be addressed as part of the wind-down of the administration following the resolution of the significant matters outstanding in the Receivership Proceedings. Accordingly, 167, RBH and RWC were assigned into bankruptcy on October 28, 2022.
