UPON THE WITHOUT NOTICE APPLICATION (the "**Application**") of Canadian Western Bank (the "**CWB**") for an Order sealing the Notice of Application to appoint an Interim Receiver over Big Bear Energy Rentals Ltd., 1509571 Alberta Ltd., 5556300 Manitoba Ltd., Barricade Environmental Ltd., and Direct Environmental Technologies Inc. (the "**Corporate Defendants**") and all pleadings in support thereof, except the Undertaking of Damage endorsed by CWB, and an Order dispensing with service of the Application on the Defendants and providing the Media with notice of an order sealing certain documents on the Court record; and UPON hearing counsel for CWB;

IT IS HEREBY ORDERED THAT:

SERVICE

1. Service of notice of the Application and all evidence filed in support thereof on the Defendants and any other party, including the media, is hereby dispensed with.

SEALING ORDER

2. Division 4 of Part 6 of the Rules does not apply to this Application, and the Clerk of the Court be and is hereby directed to seal the Application and all material or evidence relied upon with respect to the Application, as listed in the Application (collectively, the “**Sealed Documents**”), except for the Undertaking of Damages executed by Canadian Western Bank until the earlier of:
 - (a) 35 days from granting of this Order;
 - (b) such further Order of this Court directing the unsealing of the Sealed Documents.
3. The Clerk of this Honourable Court is hereby directed not to file the Sealed Documents, but instead seal the Sealed Documents in one or more envelopes setting out the style of cause in the within proceedings and labelled.

THIS ENVELOPE CONTAINS THE WITHOUT NOTICE APPLICATION TO APPOINT AN INTERIM RECEIVER AND AN RESTRICTED ACCESS AND SEALING ORDER AND THE MATERIAL FILED IN SUPPORT THEREOF. THESE CONFIDENTIAL DOCUMENTS ARE SEALED ON THE COURT FILE PURSUANT TO THE ORDER ISSUED BY THE HONOURABLE MADAM JUSTICE K.M HORNER ON FRIDAY, JANUARY 21, 2022.
