

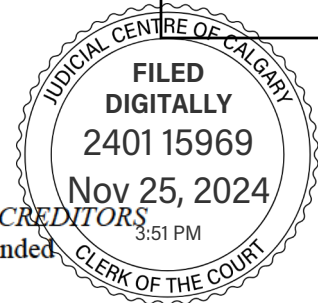

INTRODUCTION

1. On November 14, 2024, on the application of an ad hoc group of Canadian investors in various real estate and land investment projects (the "**Applicant Investors**"), the Court of King's Bench of Alberta (the "**Court**") issued an initial order (the "**Initial Order**") which, among other things, commenced proceedings (the "**CCAA Proceedings**") under the *Companies' Creditors Arrangement Act*, RSC 1985, c C-36, as amended (the "**CCAA**") and appointed Alvarez & Marsal Canada Inc. ("**A&M**") as the CCAA monitor with enhanced powers (the "**Monitor**").
2. On November 18, 2024, the Monitor filed an application returnable on November 21, 2024 (the "**Comeback Application**") seeking an amended and restated initial order (the "**ARIO**").
3. The entities which are subject to relief under the CCAA are A2A Capital Services Canada Inc. ("**A2A CSC**"), Serene Country Homes (Canada) Inc. ("**Serene**"), A2A Developments Inc. ("**Developments**"), Angus A2A GP Inc. ("**Angus GP**"), Angus Manor Park A2A Developments Inc. ("**Angus Manor Developments**"), Angus Manor Park Capital Corp. ("**Angus Manor Capital**"), Angus Manor Park A2A GP Inc. ("**Angus Manor GP**") Fossil Creek A2A GP Inc. ("**Fossil GP**"), Hills of Windridge A2A GP Inc. ("**Windridge GP**") and US entities Fossil Creek A2A Developments, LLC ("**Fossil USA**") and Windridge A2A Developments, LLC ("**Windridge USA**" and collectively, the "**Debtor Companies**").
4. The Initial Order also extended the stay of proceeding to certain non-Debtors: Canadian entities Angus A2A Limited Partnership ("**Angus LP**"), Angus Manor Park A2A Limited Partnership ("**Angus Manor LP**"), Fossil Creek A2A Trust, Hills of Windridge A2A Trust, Fossil Creek A2A Limited Partnership ("**Fossil LP**") and Hills of Windridge A2A Limited Partnership ("**Windridge LP**" and collectively, the "**Additional Debtor Stay Entities**"). The Debtor Companies and the Additional Debtor Stay Entities are collectively referred to as the "**A2A Group**".

5. In support of the Initial Order, various Affidavits¹ of the Applicant Investors have been sworn (the "**Original Investor Affidavits**").
6. Capitalized terms not otherwise defined in this Second Supplement (this "**Second Supplement**") to the Monitor's First Report dated November 20, 2024 (the "**First Report**") are as defined in the Initial Order, the Pre-Filing Report of the Monitor dated November 13, 2024 (the "**Pre-Filing Report**"), the Original Investor Affidavits or such other materials filed by the Applicant Investors in support of the Initial Order.
7. On November 21, 2024, the Monitor was served with, among other things, the Affidavit of Allan Whiteford Lind sworn November 21, 2024 (the "**Lind Affidavit**") and the Affidavit of Grayson James Ambrose sworn November 21, 2024 (the "**First Ambrose Affidavit**"). The Lind Affidavit states, among other things, that to permit the CCAA Initial Order to proceed will cause financial harm and damages to the global investor class solely because a handful of Canadian investors, representing a "tiny fraction" of the investor class, misunderstand the investment product they bought. Likewise, the First Ambrose Affidavit suggests that the Offshore Investors in Angus Manor (as defined in the First Report) voted almost unanimously in favour of the sale.
8. On November 21, 2024, the Monitor filed the First Supplement to the First Report, describing the communication received from multiple A2A Investors.
9. The Monitor was subsequently served with the Second Affidavit of Grayson James Ambrose sworn November 21, 2024 (the "**Second Ambrose Affidavit**"). The Second Ambrose Affidavit contains a number of proxies that appear in support of the vote described in the First Ambrose Affidavit.

PURPOSE

10. The purpose of this Second Supplement is to provide information to this Honourable Court with:
 - a) a summary of some irregularities in the proxies included in the Second Ambrose Affidavit;
 - b) additional support received by the Monitor from Offshore Investors; and
 - c) an update on the Monitor's communication with the A2A Group.
11. This Report should be read in conjunction with the Applicant Investors' materials filed in support of the CCAA Application.

PROXY REVIEW

12. The Monitor reviewed the Second Ambrose Affidavit and noted some apparent irregularities, including, among others:
 - a) ANGUS MANOR PARK A2A DEVELOPMENTS INC. voted in favor, representing 990.4 units (pages 509 and 511 of the Second Ambrose Affidavit). The title documents show ANGUS MANOR PARK A2A DEVELOPMENTS INC. owning 893 units;
 - b) ANGUS A2A LIMITED PARTNERSHIP voted in favor, representing 176.6 units (pages 507 and 508 of the Second Ambrose Affidavit). The title documents show ANGUS A2A LIMITED PARTNERSHIP owning 212 units;
 - c) at least seven proxies did not vote in favor or against (*e.g.*, 30 units at page 265 of the Second Ambrose Affidavit). In addition, several proxies were unsigned or undated. Exhibit B of the First Ambrose Affidavit show no spoiled proxies; and

- d) various investors who signed proxies are not on title (*e.g.*, investor on pages 4, 7, 10, 13 and 16 of the Second Ambrose Affidavit does not exist on title).

OFFSHORE INVESTOR COMMUNICATION

13. Since November 15, 2024 (over the course of 9 days), the Monitor and their advisors have received over 65² in-bound emails representing over 126 individual investors. Most emails allege a significant lack of communication and transparency experienced by the investors from the A2A Group for several years. Attached hereto as Appendix "B" are the emails received in relation to their A2A Group investments.
14. Within these emails, there are several investors in Fossil Creek who advise they haven't received any communication from the A2A Group in many years. The Monitor notes that the Lind Affidavit states the Fossil Creek lands were sold to Bloomfield Homes L.P. on September 27, 2024.

COMPANY COMMUNICATION

15. On November 22, 2024 at 2:18pm MST, Mr. Ambrose emailed the Monitor and requested to set up a call on Tuesday, November 26, 2024 at 3:30pm MST.
16. At 4:00pm MST on November 22, 2024, the Monitor responded to Mr. Ambrose, advising that they were available to meet at the suggested time and offered to host the meeting at the Monitor's office. The Monitor re-iterated that the outstanding information requests were to be provided once available (and not to wait until all the information was collected). In particular, the Monitor stressed the importance of obtaining all banking records of A2A Group immediately and confirmation as to whether the Company is holding onto cash, as those funds are to delivered to the

Monitor pursuant to the Initial Order. The Monitor set up a virtual data room, invited Mr. Ambrose and counsel to join, and advised Mr. Ambrose of same.


17. As at the time of filing of this Second Supplement, the Monitor has not received any information nor further communication from Mr. Ambrose. The A2A Group's counsel wrote to the Monitor on the morning of November 25, 2024 and advised that they would be providing the requested documents. As at the time of filing of this Second Supplement, the Monitor has not received any documents.
18. Also on November 22, 2024, the Monitor's Counsel emailed A2A Group's counsel advising that the Lind Affidavit and the First Ambrose Affidavit appeared to suggest that negotiations for the sale of Angus Manor Park and Hills of Windridge may be ongoing, including after the issuance of the Initial Order. Monitor's Counsel reminded the A2A Group that: (a) the Monitor, with enhanced powers, was in control of the entities; and (b) no deals or negotiations from the A2A Group or anyone behalf of A2A Group's behalf are permitted to continue without the express knowledge and consent of the Monitor until further Order of this Court.

I am an investor for the following 4 land banking projects all of which are located in Ontario Canada. Legal documents were signed between 2010 and 2012.

- 1) Clearview Park (A2A/TSI/TGP)- 1 unit at Cad\$10,000 - Sales ID 8523.
- 2) Bridle Park 11 (BP 11) (A2A/TSI/TGP)- 2 units at Cad\$20,000 - Sales ID 1770.
- 3) Meaford Highlands Resort (A2A)- 1 unit at Cad\$10,000 - Sales ID 110681
- 4) Wingham Creek (A2A)- 1 unit at Cad\$10,000 - Sales ID 121782

I have invested a total of Cad\$50,000 in the 4 projects mentioned.

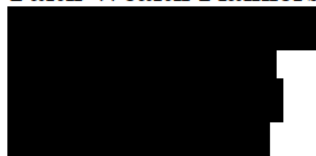
