- I am a Senior Vice-President of A&M in Toronto. I have more than 20 years of turnaround and restructuring experience. I am a Chartered Professional Accountant, Chartered Insolvency and Restructuring Professional, and a Licensed Insolvency Trustee. I am a member of the Insolvency Institute of Canada, Canadian Association of Insolvency and Restructuring Professionals, and the Turnaround Management Association. I am duly authorized on behalf of A&M, in its capacity as the court-appointed Monitor, as defined below, of Lydian International Limited (Lydian International), to swear this affidavit in support of Lydian International's application to be wound up pursuant to the Royal Court's just and equitable jurisdiction in Jersey.
- 2. The contents of this affidavit are true to the best of my knowledge, information and belief and are, unless otherwise stated, within my personal knowledge. There is now produced and shown to me and marked "AJH1" a paginated bundle of true copy documents (or extracts from true copy documents) to which I refer.
- A&M was appointed by the Ontario Superior Court of Justice (Commercial List) (the Ontario Court) to monitor the business and financial affairs of Lydian International (and the other applicants) pursuant to the *Companies' Creditors Arrangement Act*, R.S.C. 1985, c. C-36 (Canada) (the CCAA), and the order of the Ontario Court dated 23 December 2019.¹

4. By an Act of Court dated 25 February 2020, the Royal Court of Jersey made orders recognising the CCAA proceedings, which is the foreign main proceeding, including that the appointment of the Monitor be recognised in Jersey.²
