# Remedy claimed or sought:

An Order abridging the time required for service of notice of this Application to that actually
given, and declaring such notice as was given to be good and sufficient notice of this Application;

- 2. Advice and directions generally with respect to the hearing of the claims made by certain parties defined in these proceedings as the "Unfunded Merchants" presently scheduled for July 11 and July 12, 2018, and specifically with respect to the following issues:
  - a. Should the claims of certain Unfunded Merchants who failed to strictly comply with the requirements of this Honourable Court's Process Order granted and filed herein on April 13, 2018 be dismissed, or should any such deficiencies be excused?
  - b. Should the Unfunded Merchants be permitted to participate in the hearings scheduled for July 11 and July 12, 2018 by telephone?
  - c. Can the Unfunded Merchants be self-represented at the hearings scheduled for July 11 and July 12, 2018?
- Such further and other relief as this Honourable Court may grant as may be necessary to give effect to the foregoing.

### Grounds for making this application:

- With respect to the technical breaches of this Honourable Court's Process Order, the Receiver notes that several of the Unfunded Merchant claims submitted in response to the Process Order were not filed, or were not filed by the deadline set out in paragraph 4 of the Process Order. Paragraph 5 of the Process Order provides that in the event that merchant did not comply with paragraph 4 of the Process Order, the unfunded loan agreements to which that Unfunded Merchant is a party and any funds collected by the Receiver pursuant to such unfunded loan agreement will be declared to be the property of Crelogix and subject to the first ranking security interest of the Plaintiff herein and the Unfunded Merchant in question shall be considered an unsecured creditor with respect to any claims it may have pursuant to the unfunded loan agreements.
- With respect to the ability of any Unfunded Merchant to participate in the hearings scheduled for July 11 and July 12, 2018 by telephone, the Receiver notes that Rule 6.10 of the Alberta Rules of Court (the "Rules") permits an electronic hearing if the parties agree and the Court so permits, or, on application, the Court orders an electronic hearing.
- 6. With respect to the ability of an Unfunded Merchant to be self-represented in these proceedings, the Receiver notes that Rule 2.23(3)(a) of the Rules provides that the Court may permit a person to assist a party before the Court but that no assistance may be permitted that would contravene s.106(1) of the Legal Profession Act. Alberta case law from our Court of Appeal stands for the

proposition that no corporation may be represented by anyone other than a lawyer before the Courts of this province.

7. Such further and other grounds as Counsel may advise.
