TERMINATION AGREEMENT

THIS TERMINATION AGREEMENT is entered into this 16th day of November, 2015 by and between Global Tungsten & Powders Corp. ("GTP"), a Delaware Corporation having an address at 1 Hawes Street, Towanda PA 18848, USA and North American Tungsten Corporation Ltd. ("NTC"), a public company listed on TSXV, having its registered office at #1640-1188 West Georgia Street, Vancouver, BC V6E 4A2, Canada.

WHEREAS NTC and GTP entered into and have been operating under a Supply Agreement dated December 19, 2013 (the "Supply Agreement") that provides for the purchase and sale of tungsten concentrate ("Concentrate") produced at NTC's Cantung Mine (the "Mine");

WHEREAS NTC has sought creditor protection under the provisions of the Companies' Creditors Arrangement Act in the Supreme Court of British Columbia, Action No. S154746, Vancouver Registry (the "CCAA Proceeding"), and is subject to an Order of the Court pronounced June 9, 2015 and various subsequent orders;

WHEREAS the Mine is entering into care and maintenance for the foreseeable future and will not be producing Concentrate;

WHEREAS the Parties now wish to terminate the Supply Agreement on the terms set out herein;

NOW, THEREFORE, intending to be legally bound, and in consideration of the mutual covenants and agreements set forth herein, the receipt and legal sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. GTP will make payments to NTC for the invoices listed in Schedule "A" hereto (the "Remaining Invoices") in the amounts and by the due dates set out in Schedule "A" according to the terms of the Supply Agreement without set-off or deduction.
- 2. Upon payment by GTP of the Remaining Invoices, the Supply Agreement shall be terminated.
- 3. Except as provided for herein, upon termination of the Supply Agreement, the parties remise, release and forever discharge each other, and their respective successors and assigns, from any and all manner of actions, causes of action, suits, claims, contracts, debts, demands and damages of any nature or kind whatsoever, at law or in equity, known as well as unknown, that either party, or its respective successors and assigns, hereafter can, shall or may have by reason of any matter, cause or thing whatsoever arising out of or connected with the Supply Agreement.
- 4. Notwithstanding the foregoing, nothing in this agreement shall release or discharge GTP from the costs orders made in the following orders:
 - (a) Order of Mr. Justice Butler dated July 30, 2015 in Vancouver Supreme Court Registry No. S154746;
 - (b) Order of Mr. Justice Savage dated August 12, 2015 in Court of Appeal Registry Nos. CA42990 and CA42991; and

- · (c) Order of a panel of the Court of Appeal dated September 30, 2015 in Court of Appeal Registry Nos. CA42990 and CA42991.
- 5. This Agreement is subject to the approval by the Supreme Court of British Columbia in the CCAA Proceeding.
- 6. This Agreement may be executed in counterparts and delivered by electronic file transfer. Each such executed counterpart will be considered an original. All executed counterparts taken together will constitute one agreement.

This Agreement is made by and between the parties hereto as of the date set forth above.
