Remedy claimed or sought:

- An Order in substantially the form of the enclosed draft Distribution and Discharge Order:
 - (a) approving and directing a final distribution of sale proceeds to certain creditors of 101098672 Saskatchewan Ltd. ("8672 Sask"), Morris Industries Ltd. ("MIL"), Morris Sales and Service Ltd. ("MSS"), and/or Morris Industries (USA) Inc. ("MUSA"; together with 8672 Sask, MIL, MSS, and MUSA, the "Receivership Entities");
 - vacating the Directors' Charge established by paragraph 22 of the Amended and Restated Initial Order granted by the Honourable Mr. Justice R.S. Smith on January 16, 2020 (the "ARI Order") in the proceedings pursuant to the *Companies' Creditors Arrangement Act*, RSC 1985, c C-36, Q.B. No. 1884 of 2019, Judicial Centre of Saskatoon (the "CCAA Proceedings"), and affirmed by the Receivership Order granted within the receivership proceedings within Q.B. No. 1884 of 2019, Judicial Centre of Saskatoon (the "Receivership Proceedings") of the Honourable Mr. Justice R.W. Elson dated March 26, 2021 (the "Receivership Order");
 - (c) discharging Alvarez & Marsal Canada Inc. ("A&M") as Receiver of the Receivership Entities;
 - (d) authorizing A&M to dispose of any records of the Receivership Entities which are in its possession but no longer required (the "Records") if the same are not claimed by the former directors of the Recievership Entities after 60 days' notice from A&M;
 - (e) approving the activities of the A&M as Receiver, Trustee in Bankruptcy, and (formerly) Monitor of the Receivership Entities, and the fees and disbursements of A&M and its legal counsel; and
 - (f) releasing A&M from liability for its actions in its capacity as Receiver and (formerly) Monitor of the Receivership Entities.
- 2. Such further and other relief as counsel may request and this Honourable Court may allow.

Grounds for making this application:

3. All or substantially all of the assets of the Receivership Entities were sold prior to the granting of the Receivership Order. The Receivership Entities remained in receivership in order that funds might be distributed and certain administrative matters completed. Those tasks have now been completed, and (assuming the distributions sought herein are approved) A&M's mandate as Receiver is complete, and there is no further role for A&M to play in that regard. 4. The Director and Officer Claims Process contemplated in the Order (Director and Officer Claims Process) granted by the Honourable Mr. Justice R.W. Elson on June 18, 2021 (the "D&O Claims Process Order") is complete, with only one (non-material) claim having been accepted and paid.

5. As more particularly detailed in the Second Report of the Receiver dated September 27, 2021, as well as all other reports filed in these proceedings:

a) A&M's mandate has at all times been carried out with efficiency and integrity and with due regard for the interests of all parties; and

b) the professional fees and disbursements of A&M and its legal counsel are fair and reasonable in the circumstances.

6. Such further or other grounds as counsel may advise and this Honourable Court may allow.

8. Second Report of the Receiver dated September 27, 2021;

9. A form of draft Order (Distribution and Discharge);
