ORDER

(Extension of Stay of Proceedings and Other Relief)

Before the Honourable Mr. Justice R.S. Smith in Chambers the 18th day of December, 2020.

Upon application by Jeffrey M. Lee, Q.C. and Paul Olfert, counsel on behalf of the Monitor, Alvarez & Marsal Canada Inc. (the "**Monitor**"), and upon hearing from counsel on behalf of other parties participating, and upon reading the Notice of Application dated the 11th day of December, 2020, the Twelfth Report of the Monitor dated December 11, 2020 (the "**Twelfth Report**"), the Confidential Appendix to the Twelfth Report of the Monitor dated November 23, 2020 (the "**Confidential Appendix**"), and the Draft Order (collectively, the "**Application Materials**"), all filed with proof of service; and upon reading the pleadings and proceedings herein;

**THE COURT ORDERS:**

1. The term of the Amended and Restated Initial Order granted by the Honourable Mr. Justice R.S. Smith in these proceedings on January 16, 2020 (the "**ARI Order**"), and the stay of proceedings provided for therein, shall be and are hereby extended from 11:59 p.m. on December 18, 2020 to 11:59 p.m. on January 31, 2021.
2. All activities, actions and proposed courses of action of the Monitor (collectively, the "**Actions of the Monitor**") from November 23, 2020 to December 11, 2020 in relation to the discharge of its duties and mandate as Monitor pursuant to the various Orders of the Court of Queen's Bench for Saskatchewan in these proceedings (collectively, the "**Monitor's Mandate**"), as such Actions of the Monitor are more particularly described in the Twelfth Report and the Confidential Appendix, shall be and are hereby approved and confirmed.
3. All of the professional fees and disbursements of the Monitor and its legal counsel, MLT Aikins LLP, from November 1, 2020 to November 30, 2020, as more particularly described in the Eleventh Report, shall be and are hereby approved and confirmed.
