Before the Honourable Mr. Justice R.W. Elson in Chambers the 29th day of July, 2020.

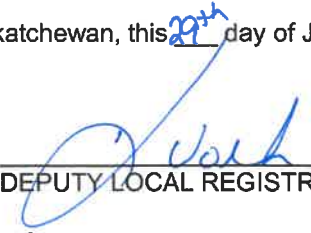
Upon application by Jeffrey M. Lee, Q.C. and Paul Olfert, counsel on behalf of the Monitor, Alvarez & Marsal Canada Inc. (the "**Monitor**"), and upon hearing from counsel on behalf of other parties participating, and upon reading the Notice of Application dated the 24th day of July, 2020, the Eighth Report of the Monitor dated July 24, 2020 (the "**Eighth Report**"), the Confidential Appendix to the Eighth Report of the Monitor dated July 24, 2020 (the "Confidential Supplement") and the Draft Order (collectively, the "**Application Materials**"), all filed with proof of service; and upon reading the pleadings and proceedings herein;

THE COURT ORDERS:

1. The term of the Amended and Restated Initial Order granted by the Honourable Mr. Justice R.S. Smith in these proceedings on January 16, 2020 (the "**ARI Order**"), and the stay of proceedings provided for therein, shall be and are hereby extended from 11:59 p.m. on July 31, 2020 to 11:59 p.m. on August 31, 2020.
2. All activities, actions, conduct and proposed courses of action of the Monitor (collectively, the "**Actions of the Monitor**") from July 1, 2020 to and including July 24, 2020 in relation to the discharge of its duties and mandate as Monitor pursuant to the various Orders of the Court of Queen's Bench for Saskatchewan in these proceedings, as such Actions of the Monitor are more particularly described in the Eighth Report and the Confidential Supplement, shall be and are hereby approved and confirmed.
3. All of the professional fees and disbursements of the Monitor and its legal counsel, MLT Aikins LLP, from June 1, 2020 to and including June 30, 2020, as more particularly described in the Eighth Report, shall be and are hereby approved and confirmed.

4. The Confidential Appendix to the Eighth Report shall be kept sealed and confidential and shall not form part of the public record, but rather shall be placed, kept separate and apart from all other contents of the Court file, in a sealed envelope which shall bear a notice which sets out the title of these proceedings and a statement that the contents are subject to a sealing order and shall only be opened upon further order of the Court.
