IT IS HEREBY ORDERED AND DECLARED THAT:

1. The Hillsboro Application and Depositor Application (together the "**Applications**") are scheduled to be heard on the Commercial List by the Honourable Madam Justice Eidsvik on December 8 and 10, 2020, as follows:

 - (e) Briefs of all parties shall be served on or before December 2, 2020; and
