UPON the application (the "**Application**") of National Bank of Canada ("**NBC**") in respect of Manito Energy Inc. ("**Manitok**") and Raimount Energy Corp. ("**Raimount**", Raimount and Manito are collectively referred to as, the "**Debtors**"); **AND UPON** having read the Affidavit of Audrey Ng, sworn on February 14, 2018 (the "**Second Ng Affidavit**"), filed; **AND UPON** having read Confidential Exhibit "B" to the Second Ng Affidavit (the "**Confidential Exhibit**"), unfiled; **AND UPON** having read the Affidavit of Massimo Geremia, sworn on February 7, 2018, filed;

AND UPON having read the Supplemental Affidavit of Massimo Geremia, sworn on February 13, 2018, filed; **AND UPON** having read the Second Report of FTI Consulting Canada Inc. (the "**Proposal Trustee**"), as proposal trustee of the Debtors, dated February 12, 2018; **AND UPON** hearing counsel for NBC, the Debtors, the Proposal Trustee, and any other persons present;

IT IS HEREBY ORDERED AND DECLARED THAT:

SERVICE
