Wellness, the “**Companies**”), Estate No 11-2733088, is hereby consolidated with and will


continue under the estate of Wellness, Estate No. 11-2733087 (together hereafter, the “**Consolidated Estate**”) for all administrative purposes, and, without limitation to the foregoing, the Companies and the proposal trustee may deliver notice of both of the Companies’ proposal proceedings and one consolidated cashflow forecast for both Companies to all creditors of the Companies. For greater certainty and clarity, by virtue of the consolidation of the estates of Centers and Wellness into the Consolidated Estate, the need to carry out any action, including those actions mandated by the *Bankruptcy and Insolvency Act*, R.S.C. 1985, c. B-3 (the “**BIA**”) in respect of the estates of Centers and Wellness on an individual estate basis be and is hereby dispensed with.

3. Supreme Court of British Columbia Actions Nos. VLC-S-B-210224 and VLC-S-B-210223, Vancouver Registry, are hereby consolidated and the Action Number for the Consolidated Estate shall be VLC-S-B-210223, having the following style of cause:


