INTRODUCTION

- 1. On December 21, 2016 (the "Filing Date"), Modular Space Holdings, Inc. ("MSH") and certain of its subsidiaries and affiliates (collectively, "ModSpace" or the "Chapter 11 Debtors"), each commenced voluntary reorganization proceedings (the "Chapter 11 Proceedings") in the United States Bankruptcy Court for the District of Delaware (the "US Court") by filing a voluntary petition for relief under Chapter 11 of Title 11 of the United States Code, 11 U.S.C. 101-1532. (the "Bankruptcy Code"). The seven Chapter 11 Debtors are as follows:
 - MSH;
 - Modular Space Intermediate Holdings, Inc.;
 - Modular Space Corporation ("MSC" or the "Foreign Representative");
 - Resun ModSpace, Inc.;
 - ModSpace Government Financial Services, Inc.;
 - ModSpace Financial Services Canada, Ltd. (the only Chapter 11 Debtor that is incorporated in Canada, "ModSpace Canada"); and
 - Resun Chippewa, LLC.
- 2. On December 22, 2016, the US Court made various orders in the Chapter 11 Proceedings (the "First Day Orders"), including an order authorizing MSC to act as foreign representative of the Chapter 11 Proceedings and an interim order authorizing the Chapter 11 Debtors to obtain debtor-in-possession financing.
- 3. On December 27, 2016, this Court made two orders that, among other things: (i) recognized MSC as the "foreign representative" of the Chapter 11 Debtors; (ii) declared the Chapter 11 Proceedings to be a "foreign main proceeding" under the *Companies*"

Creditors Arrangement Act ("CCAA"); (iii) stayed all proceedings against the Chapter 11 Debtors; (iv) appointed Alvarez & Marsal Canada Inc. ("A&M Canada" or the "Information Officer") as the information officer in respect of these proceedings under Part IV of the CCAA (the "CCAA Recognition Proceedings"); and (v) recognized and gave effect in Canada to the First Day Orders.

- 4. A&M Canada, in its capacity as proposed Information Officer, filed with this Court a report dated December 24, 2016 (the "**Preliminary Report**"), to provide this Court with, among other things, information relating to the Chapter 11 Debtors' business and operations and their debt and capital structure.
- 5. On December 29, 2016, ModSpace filed several motions (the "Second Day Motions") with the US Court. A formal hearing with respect to the Second Day Motions that was scheduled for January 19, 2017, was not held as there were no unresolved objections filed by any parties so as to necessitate the hearing. As such, the US Court made the Second Day Orders on January 17 and 18, 2017.
- 6. On January 25, 2017, this Court recognized several Second Day Orders and approved the Preliminary Report and the First Report of the Information Officer (the "First Report") and the activities described therein. A copy of the First Report (without appendices) is attached hereto as **Appendix A**.
- On February 15, 2017, the US Court made an order (the "Confirmation Order"): (i) confirming ModSpace's plan of reorganization, as originally distributed on or about December 20, 2016, and as filed in revised form with the US Court on February 3, 2017 (including all amendments, modifications and supplements, the "Plan") pursuant to the

- Bankruptcy Code; and (ii) approving ModSpace's disclosure statement in respect of the Plan.
- 8. MSC has brought a motion to this Court returnable on February 21, 2017, to, among other things, seek recognition of the Confirmation Order in Canada.

TERMS OF REFERENCE AND DISCLAIMER

- 9. In preparing this Second Report of the Information Officer (the "Second Report"), A&M

 Canada has relied solely on information and documents provided by the Foreign

 Representative, the other Chapter 11 Debtors and their Canadian legal counsel

 (collectively, the "Information").
- 10. The Information Officer has reviewed the Information for reasonableness, internal consistency and use in the context in which it was provided. However, the Information Officer has not audited or otherwise attempted to verify the accuracy or completeness of the Information in a manner that would wholly or partially comply with Canadian Auditing Standards ("CASs") pursuant to the Chartered Professional Accountants Canada Handbook, and accordingly, the Information Officer expresses no opinion or other form of assurance contemplated under CASs in respect of the Information.
- This Second Report should be read in conjunction with the Affidavit of David Orlofsky, Senior Managing Director of Zolfo Cooper LLP ("Zolfo"), financial advisor to the Chapter 11 Debtors, sworn on February 16, 2017 (the "Third Orlofsky Affidavit").
- 12. Unless otherwise stated, all monetary amounts contained herein are expressed in United States dollars.
- 13. Terms not otherwise defined in this Second Report have the meanings ascribed to them in the First Report and/or the Third Orlofsky Affidavit.

PURPOSE OF REPORT

- 14. The purpose of this Second Report is to provide the Court with information regarding the following:
 - (a) the motion brought by MSC for an order, among other things:
 - i. recognizing and giving full force and effect in Canada to the Confirmation Order;
 - ii. recognizing, implementing and giving full force and effect in Canada to the Plan;
 - iii. authorizing and permitting ModSpace to take all such steps and actions necessary or appropriate to implement the Plan, including the transactions contemplated by the Plan;
 - iv. amending the articles of ModSpace Canada in accordance with the Plan;
 - v. directing the Registrar of Corporations of the Alberta Corporate Registry to give effect to the Canadian Recognition of the Confirmation Order and to implement the Articles of Reorganization (as defined below) contemplated by the Plan, pursuant to Section 192 of the *Business Corporations Act* (Alberta);
 - vi. approving the Second Report of the Information Officer and the activities of the Information Officer as set out therein;
 - vii. approving the fees and disbursements of the Information Officer and its legal counsel, Torys LLP, including estimated fees and disbursements up to the Information Officer's date of discharge, as described in this Second Report;

- viii. terminating, discharging and releasing the Administration Charge upon filing of the Certificate of Discharge (the "Certificate") with the Court certifying that the Information Officer has attended to the Remaining Matters (as defined below);
 - ix. terminating the CCAA Recognition Proceedings, effective upon the filing of the Certificate; and
 - x. discharging A&M Canada in its capacity as Information Officer upon the filing of the Certificate;
- (b) the activities of the Information Officer since filing the First Report;
- (c) the fees and disbursements of the Information Officer and its counsel; and
- (d) the Information Officer's recommendations with respect to the aforementioned motion by MSC.

CONFIRMATION ORDER

- 15. On February 15, 2017, the US Court made the Confirmation Order confirming the Plan and approving ModSpace's disclosure statement in respect of the Plan.
- As indicated in the Third Orlofsky Affidavit, in making the Confirmation Order, the US Court was satisfied that, among other things, the Plan satisfied the requirements of the Bankruptcy Code, including that at least one impaired class (as defined in the Bankruptcy Code) for each Debtor accepted the Plan and there are adequate means in place for the Plan's implementation. A copy of the Confirmation Order is attached as Exhibit H to the Third Orlofsky Affidavit.

THE PLAN

17. A copy of the Plan filed with the US Court on February 3, 2017, is attached as Exhibit E to the Third Orlofsky Affidavit. The Plan involves, among other things, a consensual exchange of approximately \$400 million in secured notes (the "Notes") for equity in reorganized MSH and a rights offering through which holders of Notes may purchase additional equity in reorganized MSH (the "Rights Offering"). The Rights Offering includes an agreement (the "Backstop Agreement") whereby certain holders of Notes have agreed to back-stop the Rights Offering in exchange for a commitment premium to ensure liquidity for ModSpace. The proceeds of the Rights Offering will facilitate ModSpace's emergence from the Chapter 11 Proceedings and the CCAA Recognition Proceedings.

Unanimous Stakeholder Support

Declaration of David Orlofsky dated February 3, 2017 (the "Orlofsky February 3 Declaration", attached as Exhibit D to the Third Orlofsky Affidavit), provides greater detail regarding the contents of the Plan and the unanimous support that it received from the Chapter 11 Debtors' creditors. While some objections to confirmation of the Plan were filed in the Chapter 11 Proceedings, those objections were resolved and subsequently withdrawn by the objecting parties. There are no unresolved objections in respect of the Plan. The voting members of the classes of creditors and equityholders entitled to vote on the Plan, voted unanimously in favour of the Plan.

Canadian Unsecured Creditors

19. Canadian unsecured creditors having valid claims are unaffected by the Plan and will receive payment for their claims. To the extent that Canadian creditors are not repaid in full prior to or upon implementation of the Plan, their claims will remain due and owing following implementation of the Plan and paid in the ordinary course.

Canadian Disputed Claims

20. Disputed claims, including outstanding litigation claims as described in the First Orlofsky Affidavit, will not be paid as part of the Plan. These claims are not compromised, however, and ModSpace will continue to dispute such claims following implementation of the Plan.

Secured Lenders

21. The only creditors of ModSpace Canada that are impaired (as defined in the Bankruptcy Code) are the Secured Lenders under ModSpace's pre-Filing Date ABL Facility. The Secured Lenders have also provided the DIP Financing to ModSpace.

Releases

22. The Plan, among other things, includes releases in favour of the Secured Lenders, ModSpace, the signatories to the RSA and the Backstop Agreement and other parties. The releases are discussed in greater detail in the Third Orlofsky Affidavit. ModSpace believes that the releases are standard, appropriate, reasonable and necessary to implement the Plan, and they have been approved by the US Court. The Information

Officer understands that the releases under the Plan were negotiated among, and agreed upon by, the Chapter 11 Debtors' primary stakeholders.

Articles of Reorganization

- 23. Pursuant to supplements to the Plan filed with the US Court on or about January 18, 2017, and February 13, 2017, ModSpace will amend and restate the articles of incorporation of each of the Chapter 11 Debtors, including ModSpace Canada. This is being done so as to comply with the requirements of the Bankruptcy Code.
- 24. The amendments to the ModSpace Canada articles (the "Articles of Reorganization") restrict its ability to issue non-voting equity securities, except to the extent permitted by the Bankruptcy Code and done in compliance with the requirements of the Bankruptcy Code. A copy of ModSpace Canada's Articles of Reorganization is attached as Exhibit G to the Third Orlofsky Affidavit.
- 25. ModSpace Canada's registered head office is located in Alberta. ModSpace's Canadian legal counsel has advised the Information Officer that the Alberta Corporate Registry requires an Order of the Alberta Court of Queen's Bench in order to implement the Articles of Reorganization. ModSpace is seeking: (i) approval to amend the articles of ModSpace Canada in accordance with the Plan; and (ii) a direction to the Registrar of Corporations of the Alberta Corporate Registry to permit the filing of the Articles of Reorganization. It is anticipated by MSC that a further application to the Alberta Court of Queen's Bench will be required in order to meet the technical requirements of the Business Corporations Act (Alberta).

26. The Plan is currently expected to be implemented in early March 2017 (the "Effective Date"). At that time, ModSpace expects to file and serve notice of the Effective Date of the Plan in the Chapter 11 Proceedings, which will be posted on the KCC web-site at: http://www.kccllc.net/modspace

REQUEST FOR APPROVAL OF FEES AND DISBURSEMENTS

- 27. The Information Officer and its counsel, Torys LLP, have maintained detailed records of their professional time and costs since the Information Officer's appointment.
- 28. Pursuant to paragraph 17 of the Supplemental Recognition Order, the Information Officer and its counsel shall each be paid their reasonable fees and disbursements both before and after the making of the Supplemental Recognition Order by ModSpace.
- 29. Paragraph 18 of the Supplemental Recognition Order provides that the Information Officer and its legal counsel shall pass their accounts from time to time, and that the accounts of the Information Officer and its counsel are not subject to approval in the Foreign Proceeding.
- The total fees of the Information Officer during the period from December 12, 2016, to February 11, 2017 ("the Information Officer's Fee Period"), amount to \$103,219.50, together with expenses and disbursements in the amount of \$12,059.44, both excluding HST (collectively, the "Information Officer's Fees and Disbursements"). The time spent by the Information Officer's personnel during the Information Officer's Fee Period, including an estimate to completion, is provided in the Affidavit of Alan J. Hutchens (the "Hutchens Affidavit"), sworn in support hereof and attached hereto as Appendix B. Exhibit C to the Hutchens Affidavit is a summary of the personnel, hours and hourly rates

- charged by the Information Officer in respect of the CCAA Recognition Proceedings, for the Information Officer's Fee Period.
- The total fees for services provided by Torys during the period December 13, 2016 to February 14, 2017 (the "Torys Fee Period"), amount of \$63,289.00, together with expenses and disbursements in the amount of \$499.79, both excluding HST (collectively, the "Torys Fees and Disbursements"). The time spent by Torys personnel during the Torys Fee Period, including an estimate to completion, is provided in the Affidavit of Adam Slavens (the "Slavens Affidavit"), sworn in support hereof and attached hereto as Appendix C. Exhibit C to the Slavens Affidavit provides a summary of the personnel, hours, and hourly rates charged by Torys in respect of the CCAA Recognition Proceedings for the Torys Fee Period.
- 32. The Information Officer respectfully submits that the Information Officer's Fees and Disbursements and Torys Fees and Disbursements are reasonable in the circumstances and have been validly incurred in accordance with the provisions of the Supplemental Recognition Order.
- 33. The Information Officer also requests that the Court authorize and approve the estimated fees and disbursements of the Information Officer and Torys for services that have been or will be provided up to the Information Officer's date of discharge as set forth in the Hutchens Affidavit and the Slavens Affidavit (the "Fee Estimates to Completion").
- 34. The Fee Estimates to Completion were determined by the Information Officer in consultation with Torys on the assumption that the Effective Date of the Plan will be in early March 2017. The Information Officer will submit further accounts to the Foreign Representative for fees and disbursements actually incurred by it and Torys. In the event

the Fee Estimates to Completion are exceeded, no further court approval will be sought provided that ModSpace consents to payment of such fees and disbursements. In this manner, the costs and delays that would arise from a further hearing to approve the residual fees and disbursements prior to the Effective Date will be avoided. Given the consensual nature of the Plan and the fact that unsecured creditors are being paid in full or otherwise rendered unimpaired, the payment of fees and disbursements in this manner does not prejudice any stakeholder.

35. To the extent all or any portion of the approved fees and disbursements has not been paid, the Information Officer and Torys intend to apply their respective retainers to such amounts. The remainder of the retainers will be returned to the Foreign Representative following the discharge of the Information Officer.

ACTIVITIES OF THE INFORMATION OFFICER

- 36. The activities of the Information Officer since its First Report have included:
 - (a) updating the Information Officer's website;
 - (b) monitoring the KCC website for activity in the Chapter 11 Proceedings;
 - (c) reviewing key Plan documents;
 - (d) discussions with legal counsel and the Chapter 11 Debtors' Canadian legal counsel regarding matters relevant to the CCAA Recognition Proceedings and the Chapter 11 Proceedings, including the substance of the Plan, the treatment of Canadian creditors pursuant to the Plan, and implementation of the Plan; and
 - (e) preparing the Second Report, the Hutchens Affidavit and the Slavens Affidavit, and reviewing draft materials of the Foreign Representative in connection with the CCAA Recognition Proceedings.

37. The Foreign Representative is seeking approval of the Second Report, and the activities of the Information Officer set out therein.

DISCHARGE OF THE INFORMATION OFFICER AND TERMINATION OF THESE PROCEEDINGS

- 38. ModSpace has requested that the Information Officer be discharged once it files the Certificate indicating that the Remaining Matters (as defined below) have been completed and the Plan has been implemented. The Information Officer anticipates its remaining activities will primarily consist of monitoring the implementation of the Plan to its Effective Date, including ongoing review of the materials posted on the KCC website, ensuring that all obligations under the Administration Charge are satisfied, updating the Information Officer's website as necessary and responding to any enquiries regarding the Chapter 11 Proceedings and the CCAA Recognition Proceedings (the "Remaining Matters"). As noted above, the Monitor anticipates that the Remaining Matters will be completed on or about the Effective Date, and that the Certificate will be filed by the Monitor at that time or shortly thereafter.
- 39. ModSpace has also requested a termination of the CCAA Recognition Proceedings, the removal of the Administration Charge and the discharge of the Information Officer upon the Certificate being filed.
- 40. The Information Officer is of the view that the foregoing will enable the CCAA Recognition Proceedings to be efficiently concluded.

RECOMMENDATIONS

- 41. The Canadian recognition of the Confirmation Order is necessary in order for ModSpace to complete the reorganization process and implement the Plan. It will also allow for the efficient conclusion of the CCAA Recognition Proceedings.
- 42. Based on the foregoing, the Information Officer respectfully recommends that this Court grant the relief requested by MSC.

SECOND DAY ORDERS FOR WHICH RECOGNITION IS BEING SOUGHT IN CANADA

- 12. On January 17 and 18, 2017, the US Court made a number of orders with respect to the Second Day Motions (the "Second Day Orders"). The Second Day Orders, for which recognition is being sought in Canada, are as follows:
 - (a) a final order made on January 18, 2017: (i) approving post-Filing Date financing (the "DIP Financing"); (ii) granting liens and super-priority administrative status of the DIP Financing expenses; (iii) authorizing use of the DIP Financing proceeds to pay certain US pre-Filing Date obligations; and (iv) granting adequate protection to certain of the Chapter 11 Debtors' pre-Filing Date secured creditors (the "Final DIP Order);
 - (b) an order made on January 17, 2017, authorizing the Chapter 11 Debtors' assumption of the restructuring support agreement dated as of December 20, 2016 (the "RSA Order");
 - (c) an order made January 17, 2017, approving the Chapter 11 Debtors' entry into and performance of their obligations under a stock purchase and backstop agreement dated as of December 28, 2016 (the "SPBA") and authorizing them to pay certain fees and expenses in connection with the SPBA (the "SPBA Order");
 - (d) an order made January 17, 2017, authorizing the Chapter 11 Debtors to employ and pay certain professionals in the ordinary course of business, *nunc pro tunc*, to December 21, 2016 (the "OCP Order");
 - (e) a final order made January 17, 2017, authorizing ModSpace to pay pre-Filing Date wages, compensation and employee benefits (the "Final Wages Order");

- (f) a final order made January 18, 2017, authorizing, but not directing ModSpace to maintain their existing bank accounts and cash management system, and authorizing the continuation of (and administrative expense priority status of) intercompany transactions (the "Final Cash Management Order");
- (g) a final order made January 17, 2017, with respect to utility providers: (i) approving ModSpace's form of adequate assurance of payment; (ii) establishing procedures to resolve objections by utility companies; and (iii) restraining utility companies from discontinuing, alternating or refusing service (the "Final Utilities Order"); and
- (h) a final order made January 17, 2017, establishing notification procedures and approving restrictions on certain transfers or claims for worthlessness with respect to equity securities (the "Final NOL Order").

Final DIP Order

- On December 22, 2016, the US Court made an interim order authorizing the Chapter 11 Debtors to borrow pursuant to the DIP Financing with limits on amounts available to the Chapter 11 Debtors prior to entry of a final DIP Financing order. The interim order was recognized by this Court on December 27, 2016. A summary of the DIP Financing, including amounts available to the Chapter 11 Debtors, prior to entry of the Final DIP Order, was provided in the Preliminary Report.
- 14. The Final DIP Order grants on a final basis substantially the same relief that was granted on an interim basis by the US Court and authorizes the full amount available to the Chapter 11 Debtors under the various components of the DIP Financing. Specifically, the Final DIP Order provides as follows:

- the US Debtors are authorized to borrow up to \$568 million, subject to borrowing base and availability reserves, pursuant to a US revolving loan facility;
- (b) ModSpace Canada is authorized to borrow up to \$200 million, subject to borrowing base and availability reserves, pursuant to a Canadian revolving loan facility; and
- the US Debtors are authorized to borrow a US term loan in the amount of the unpaid principal balance of a US term loan owed under the pre-Filing Date ABL Facility up to \$25,000,000.
- 15. Pursuant to the DIP Financing Documents, and consistent with the pre-Filing Date financing terms, the US Debtors guarantee the obligations of ModSpace Canada but ModSpace Canada does not guarantee the obligations of the US Debtors.
- 16. The US Debtors are authorized to use advances under the DIP Financing to repay preFiling Date amounts owed by them under the pre-Filing Date ABL Facility. However,
 ModSpace Canada is not authorized to use advances under the DIP Financing to repay
 pre-Filing Date amounts owed by it. For ModSpace Canada, the DIP Financing employs
 a "creeping roll up" whereby the cash generated by ModSpace Canada's business will be
 used to reduce the balance of the outstanding pre-Filing Date debt owed by ModSpace
 Canada under the pre-Filing Date ABL Facility.

RSA Order

17. Key terms of the restructuring plan (the "Plan") were summarized in the Preliminary Report, together with the efforts that led to the restructuring support agreement dated December 20, 2016 between ModSpace, the ABL Lenders, the Ad Hoc Group of

- Notcholders and Calera (the "RSA") in support of a pre-packaged Chapter 11 plan of reorganization.
- 18. As described in the Second Orlofsky Affidavit, based on the RSA, ModSpace will likely have sufficient members of each class entitled to vote on the Plan to achieve positive vote results for the Plan.
- 19. The RSA Order authorizes the parties to the RSA to perform under the RSA, including taking all actions, executing all documents and making all payments that may be necessary to give effect to the RSA.

SPBA Order

- 20. The Plan includes a rights offering expected to raise approximately \$90 million (the "Rights Offering"). In the event the Rights Offering is under-subscribed and does not raise sufficient funds, the SPBA ensures that ModSpace will have the liquidity necessary to implement the Plan, as certain noteholders have agreed to purchase equity interests in the reorganized entity under the SPBA.
- 21. The SPBA Order authorizes the Chapter 11 Debtors to enter into the SPBA and to execute, deliver and implement the SPBA, including performing the obligations contemplated under the SPBA and pay the costs and expenses associated with the SPBA.

 OCP Order
- 22. As indicated in the Second Orlofsky Affidavit, the OCP Order authorizes the Chapter 11 Debtors to pay certain professionals (the "OCPs") in the ordinary course of their business, *nunc pro tunc*, to December 21, 2016 so that services can continue on an uninterrupted basis. Exhibit 1 to the OCP Order includes three parties located in Canada that have provided legal services to ModSpace.

- 23. Pursuant to the OCP Order, the Chapter 11 Debtors are authorized to retain, pay compensation to, and reimburse the expenses of the OCPs without requiring the OCPs to file applications with the US Court.
- 24. The OCP order also sets out two classifications of OCPs based on fee thresholds and sets out the method through which the Chapter 11 Debtors can retain additional OCPs.

 Final Wages Order, Final Cash Management Order, Final Utilities Order and Final NOL Order
- 25. The Final Wages Order, the Final Cash Management Order, the Final Utilities Order and the Final NOL Order are discussed in the Second Orlofsky Affidavit. These final orders grant on a final basis substantially the same relief that was granted on an interim basis by the US Court on December 22, 2016 and recognized by this Court on December 27, 2016.
- 26. Copies of the Second Day Orders discussed above are attached as Exhibits D to K of the Second Orlofsky Affidavit.

OTHER ORDERS IN THE CHAPTER 11 PROCEEDINGS

27. Certain other Second Day Orders were granted by the US Court on January 17 and 18, 2017 that authorized the Chapter 11 Debtors' retention and payment of professionals used in the ordinary course of business to December 21, 2016, including Cleary Gottlieb Steen & Hamilton LLP (US counsel), Young Conaway Stargatt & Taylor LLP (US co-counsel), Borden Ladner Gervais LLP (Canadian counsel), Zolfo (financial advisor), Lazard Middle Market LLC and Lazard Freres & Co LLC (investment bankers) and Kurtzman Carson Consultants LLC ("KCC") (administrative advisor). Further information regarding these orders is contained in the Second Orlofsky Affidavit.

ACTIVITIES OF THE INFORMATION OFFICER

- 28. The activities of the Information Officer to date have included:
 - (a) establishing a website at www.alvarezandmarsal.com/modspace to make available copies of the orders granted in the CCAA Recognition Proceedings and other relevant motion materials and reports. In addition, there is a link on the Information Officer's website to the Chapter 11 Debtors' restructuring website maintained by KCC that includes copies of the US Court materials and orders, petitions and notices and other materials relevant to the Chapter 11 Proceedings;
 - (b) coordinating the publication of a notice of the Chapter 11 Proceedings and CCAA Recognition Proceedings (the "Notice") in *The Globe and Mail* newspaper (National Edition) on Thursday, January 5, 2017 and on Thursday, January 12, 2017, as required of the Foreign Representative by s. 53(b) of the CCAA. The initial publication date of the Notice was scheduled for Saturday, December 31, 2016; however, due to a production error at *The Globe and Mail*, the Notice was published on January 5, 2017, the next available publishing date;
 - (c) responding to inquiries regarding the CCAA Recognition Proceedings and the Chapter 11 Proceedings;
 - (d) monitoring the KCC website for activity in the Chapter 11 Proceedings;
 - (e) corresponding with the Office of the Superintendent of Bankruptcy regarding information filing requirements;
 - (f) discussions with legal counsel and the Chapter 11 Debtors' Canadian legal counsel regarding matters relevant to the CCAA Recognition Proceedings and the Chapter 11 Proceedings; and

- (g) preparing the Preliminary Report and this First Report and reviewing draft materials of the Foreign Representative in connection with the CCAA Recognition Proceedings.
- 29. The Foreign Representative is seeking approval of the Preliminary Report and the First Report, and the activities of the Information Officer set out therein.

RECOMMENDATIONS

- 30. The Information Officer understands that the Second Day Orders for which recognition is being sought in Canada are necessary to the Chapter 11 Debtors' continued business operations and that absent these orders, the reorganization efforts would be impaired.
- 31. The Information Officer has reviewed the Second Day Orders and believes they are reasonable and appropriate in the circumstances. Without limitation, such orders do not, in the Information Officer's view, treat Canadian stakeholders of ModSpace in an unfair or prejudicial matter as compared to non-Canadian stakeholders of ModSpace.
- 32. Based on the foregoing, the Information Officer respectfully recommends that this Court grant the relief requested by MSC.
