ORDER

(Seventh Extension of Stay of Proceedings)

Before the Honourable Mr. Justice R.W. Elson in Chambers the 18th day of September, 2020.

Upon application by Jeffrey M. Lee, Q.C. and Paul Olfert, counsel on behalf of the Monitor, Alvarez & Marsal Canada Inc. (the "**Monitor**"), and upon hearing from counsel on behalf of other parties participating, and upon reading the Notice of Application dated the 14th day of September, 2020, the Tenth Report of the Monitor dated September 4, 2020 (the "**Tenth Report**"), the Confidential Appendix to the Tenth Report of the Monitor (the "Confidential Tenth Report"), Brief of Law, and a Draft Order, all filed with proof of service; and upon reading the pleadings and proceedings herein;

THE COURT ORDERS:

1. The term of the Amended and Restated Initial Order granted by the Honourable Mr. Justice R.S. Smith in these proceedings on January 16, 2020 (the "**ARI Order**"), and the stay of proceedings provided for therein, shall be and are hereby extended from 11:59 p.m. on September 18, 2020 to 11:59 p.m. on November 30, 2020.
2. All activities, actions, conduct and proposed courses of action of the Monitor (collectively, the "**Actions of the Monitor**") from August 14, 2020 to and including September 14, 2020 in relation to the discharge of its duties and mandate as Monitor pursuant to the various Orders of the Court of Queen's Bench for Saskatchewan in these proceedings, as such Actions of the Monitor are more particularly described in the Tenth Report, shall be and are hereby approved and confirmed.
3. All of the professional fees and disbursements of the Monitor and its legal counsel, MLT Aikins LLP, from August 1, 2020 to and including August 31, 2020, as more particularly described in the Tenth Report, shall be and are hereby approved and confirmed.

4. The Confidential Appendix to the Tenth Report shall be kept sealed and confidential and shall not form part of the public record, but rather shall be placed, kept separate and apart from all other contents of the Court file, in a sealed envelope which shall bear a notice which sets out the title of these proceedings and a statement that the contents are subject to a sealing order and shall only be opened upon further order of the Court.
