Re: Servus Credit Union v. Crelogix Acceptance Corporation et al Edmonton QB Action 1703 12765

Please find enclosed for service upon you the filed Order granted by Justice Gill on February 6, 2018 and filed February 7, 2018.

As indicated in paragraph 4 of Justice Gill's Order, the determination of the "Contract 1" issue has been adjourned *sine die*. The Receiver intends to appear before Justice Graesser at his Lordship's convenience to seek a Procedural Order that would establish deadlines by which Unfunded Merchants and/or their counsel are obliged to file any evidence that they wish to present to the Court in connection with a determination of this issue, and establish a date by which written argument is to be submitted. Should any evidence be put forward that, in the Receiver's opinion merits questioning on Affidavit, then a deadline would be established for that questioning to take place, followed by a further deadline for filing responsive evidence and argument by any other parties who wish to be heard on the matter. We would anticipate that the final hearing on the merits would take place sometime during the last half of April, 2018.

We wish to emphasize that it was made clear on the record before Justice Gill on February 6, 2018 that the Receiver's ability to convey residual assets to the Plaintiff in this action would not include any of the Unfunded Loan Agreements or the funds collected from customers pursuant to such agreements unless and until the Court ruled in favour of the Receiver or the Secured Creditor on that issue.

I trust that you will find this to be in order.
